

## SALARY REVIEW COMMISSION

### 2024 Final Report: Decision Establishing the Salaries of the Mayor, Council President and City Council Members of the City of Spokane

#### Commissioners

The Salary Review Commission (SRC) is comprised of five Spokane citizens who are nominated by the Mayor and appointed by the City Council to staggered terms. Commission members serve four-year terms with a two-term limit. Three Commission members shall have experience in the field of personnel management, or a demonstrated knowledge in the administration of compensation and benefits. Two Commission members shall have experience in finance, business management, or other related fields that demonstrate experience beneficial to the review of total compensation and establishment of salary.

#### Commission Charge

The Spokane City Council established the Salary Review Commission (SRC) for the purpose of determining the salaries of the Mayor, Council President and Council Members. It is the goal of the Commission to base the salaries of the Mayor, Council President and City Council Members *on realistic standards so that the elected officials may be paid according to the duties of their offices, and so that citizens of the highest quality may be attracted to public service* (SMC 2.05.040).

The SRC is required to meet to review the salaries of the elected City officials during even numbered years, to conduct at least one public hearing regarding the establishment of salaries, and to file its decision regarding an increase or decrease in the salary schedule with the City Clerk by May 31 of that year.

The SRC began its biennial review of the elected officials' salaries on March 5th of 2024. The SRC held six meetings, including three public hearings (May 16<sup>th</sup>, May 23<sup>rd</sup> & May 28<sup>th</sup>).

The SRC reviewed the existing salaries applicable to the City of Spokane elected officials, as well as salaries of other elected officials of municipalities statewide and nationally. Data reviewed and discussed included CPI data from the Bureau of Labor & Statistics, population data from the Census of Governments, and salary and compensation data on local, state-wide and nation-wide municipalities with similar forms of government and populations.

The SRC considered the current condition of the regional economy, inclusive of Cost-of-Living Adjustment data. All data documents, and other related Commission documents, are available on the Commission's webpage at <https://my.spokanecity.org/bcc/commissions/salary-review-commission/>.

Additionally, the SRC conducted public hearings on May 16, 2024, May 23, 2024, and May 28, 2024 to receive public comment on the salary schedule for the Mayor, the Council President and the Spokane City Council Members. The Commission's meetings and public hearing were conducted with a virtual option.

### **Data Collection Methodology and Analysis**

The Salary Review Commission reviewed a large volume of salary data sets associated with the roles of Mayor, Council President and City Council positions in Spokane. As with the City of Spokane labor contracts, "like-cities" were identified in pursuit of a stronger data correlation. Cities reviewed included those with a Mayor-Council form of government, versus a Council-Manager form of government. City populations were also considered, as was geographic location. Examples of the data reviewed include, but are not limited to, the following:

- Spokane City Elected Official and Spokane County Commissioner Salaries from 2000 to 2024 and City of Spokane Employee Salary Increases over the same period.
- 2020 Census population data to compare salaries of U.S. and Washington cities with similar population size, government type, and size of organization. Washington State City Elected Official Salaries, which included:
  - ✓ Top cities based on population and salaries
  - ✓ Salaries of mayor-council, council-city manager and combined forms of government.
- Total Compensation Package, including salaries and other City benefits
- Roles of each elected office outlined in the City Charter

### **Commission Salary Determination**




The salary for City Council Members in 2025 is set to reflect an approximate 3.5% increase. The salary for City Council Members in 2026 is set to reflect an approximate 3% increase. The City Council President's salary in 2025 is set to reflect an approximate 3.5% increase. The City Council President's salary in 2026 is set to reflect an approximate 3% increase. The salary for the Mayor in 2025 is set to reflect an approximate 2% increase. The salary for the Mayor in 2026 is set to reflect an approximate 2% increase.

- Council Members: \$53,150




## **CONSUMER DISCLOSURE**

From time to time, SHI International Corp OBO City of Spokane (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. ### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us.
