# Chair's Report-December 1, 2024

Dear Commissioners,

Below is a summary of activities I participated in as Chair of the <u>SHRC</u> over the past month, as well as additional points of interest:

## \* Commission Updates

- <u>City Councilmember Jonathan Bingle</u> called the SHRC Chair on the morning of 11/11/24, in order to wish the SHRC Chair a *happy 50<sup>th</sup> Birthday* and to also talk about *Human-Rights-Issues* in our community. This call is an annual phone call the SHRC Chair receives from <u>Councilmember Bingle</u> on their birthday, in which this year we discussed the candidate for the SHRC vacancy who was having their <u>City Council</u> <u>Interview</u> that day. It was during this discussion <u>Councilmember Bingle</u> said that after talking to the Chair, they now would be voting for that SHRC candidate, but 7 days later voted against them. <u>Councilmember Bingle</u> had to end the call early, due to an alarming email a citizen sent to the full <u>City Council</u>.
- On the afternoon of 11/11/24 SHRC Chair was at <u>City Hall</u> when a "Lock-Down" happened, which was due to an alarming email a citizen sent to the <u>full City Council</u>. The SHRC Chair was at <u>City Hall</u> to support the <u>SHRC candidate</u> who was interviewing with <u>City Council</u> that day, which that interview was moved to 11/18/24. While at <u>City Hall</u> a <u>Spokesman-Review Reporter</u> interviewed the SHRC Chair for the following news story, <u>"Threats from man accused of</u> <u>harassing 2 Spokane mayors causes lockdown and</u> <u>cancellation of City Council meetings"</u>.
- $\circ$  A citizen reached out to the SHRC Chair on the evening of 11/11/24, in which they were asking for help with finding out

if their long-time-friend had been the one that died in jail on 11/8/24. The jail released the name of the person who had died 2 days after that citizen had reached out to the Chair, and sadly the person who had died was in fact the long-time-friend of that citizen. At that point the Chair reached back out to that citizen, in order to offer them resources and to also connect them with other "Impacted-Families" who could help the citizen during their time of grief. It must also be noted that in 2015 the SHRC calls on Justice Department to investigate jail, in which the Commission sent a letter to the DOJ because the Human Rights Commission seeks investigation of Spokane jail deaths.

- A <u>KLXY-TV Reporter</u> reached out to the SHRC Chair, in order to do an interview about a story on <u>"Spokane's scattered</u> <u>shelter system receives mixed responses"</u>.
- The <u>Mayor's Office</u> reached out to the SHRC Chair, in order to let them know that the <u>City Council Interview</u> with the <u>SHRC candidate</u> will take place on 11/14/24 after the interview was delayed due to the <u>City Hall</u> "Lock-Down" on 11/11/24. Also, the <u>Mayor's Office</u> said that the <u>City Council</u> will vote on the <u>SHRC candidate</u> on 11/18/24.
- On 11/14/24 the SHRC Chair attended the <u>"City Council Briefing Session"</u>, in which the <u>SHRC candidate</u> was interviewing with City Council that day.
- The SHRC Chair reached out to the <u>Eastern Washington</u> <u>Long-Term Care Ombuds</u>, <u>Richard Danford</u>, in order to let them know about the Commission's vote on 11/7/24 to be a part of the <u>Ombuds</u> request to have someone from the Commission to work with the new "long-term care committee" that the <u>Ombuds</u> was creating. That Commissioner will be <u>Commissioner Hernandez-Peck</u>.
- The <u>City Council</u> voted to confirm the <u>SHRC candidate</u> on 11/18/24. The <u>SHRC Executive Committee</u> wishes to welcome <u>Commissioner Justice Forral</u> to the <u>SHRC</u>, which their 1<sup>st</sup> Commission meeting will be on 12/5/24.

- The SHRC Chair attended the <u>"City Council's Homeless</u> <u>Roundtable</u>" event on 11/19/24 held at the downtown Library, in which this was the 5<sup>th</sup> roundtable-meeting, and the last meeting will be on 12/10/24 in City Council Chambers.
- The SHRC Chair reached out to the <u>Police Chief's Office</u>, in order to confirm his <u>"Q&A" Presentation</u> to the full Commission on 12/5/24. The <u>Police Chief's Office</u> then did confirm this event.
- On 11/21/24 the SHRC Chair attended the 2024 Human **Rights Champions Awards Banguet & Celebration held at the** Spokane Convention Center. This event is hosted by the Spokane County Human Rights Task Force in partnership with the SHRC, which this year the Commission paid for 2 tables at the event. Other Commissioners & City-Staff that attended the event at the Commissions tables were as follows; the SHRC Executive Team, Commissioner Hernandez-Peck, Commissioner Harrison, City Councilmember Lili Navarrete, City Council Manager of Housing & Homelessness Initiatives, and <u>3 City Council</u> *Legislative Assistants*. And the **Keynote Speaker** was "Travis McAdams" of the Southern Poverty Law Center, which the Awards Banquet & Celebration was honoring the following people with the "Human-Rights Champions Awards": John & Cindy Bryant, Taylor Crisp, Robert Lloyd & The Black Lens, Tony Stewart, Norm Gissel, & Diana Gissel, Ping Ping Zhou, and the late Rev. Happy Watkins -Community Pillar Champion (sadly Rev. Watkins passed away on 10/25/24).
- Held an <u>SHRC Executive Committee</u> Meeting on 11/24/24.
- The SHRC Chair reached out to the <u>Mayor's Office</u> on 11/26/24, in order to remind them that 2 Commissioners need to be reappointed before 12/31/24. Those Commissioners are <u>Commissioner Knox</u> and <u>Commissioner</u> <u>Schreibman</u>, which this was the 2<sup>nd</sup> time the Chair has made this reminder, and the last time was on 10/14/24 with the

<u>Mayor's Office</u> responding on 11/13/24 that they were working on it.

- The <u>Deputy City Administrator</u> reached out to the SHRC Chair, in order to see if the Chair would be willing to serve on the "Selection Committee" for the <u>C.O.P.S. formal</u> <u>procurement process</u>. The City's current contract for related services with <u>C.O.P.S.</u> terminates at the end of the year, which now the City is going to solicit proposals for community policing services through a formal procurement process or what is known as <u>"Request for Proposals (RFPs)"</u>. On 11/27/24 Range Media published a news story about this, which was titled <u>"Public Trust Issues for C.O.P.S."</u>. The SHRC Chair agreed to be a part of that "Selection Committee".
- Held an <u>"Onboarding-Meeting for the new Commissioner"</u> with the <u>SHRC Executive Committee</u> on 12/1/24.
- Regularly communicated with the <u>SHRC Executive</u> <u>Committee</u> last month about *upcoming agenda items or other Commission issues*.

## \* Office of Civil Rights, Equity, & Inclusion (OCREI)

- The <u>OCREI Director</u> called the SHRC Chair, in order to relay the <u>City Administrations'</u> plan to remove the <u>Monaghan</u> <u>Statue</u> which the <u>SHRC</u> voted for the removal on 11/4/21. The <u>Mayor's Office</u> had a meeting on 11/19/24, which after that meeting the <u>OCREI Director</u> reached out to the SHRC Chair to get feedback on the <u>City Administrations'</u> plan for removal. The planning process includes <u>all "Stakeholders"</u> and also has a realistic timetable for the Statue to be taken down respectfully.
- Regularly communicated with the <u>OCREI Director Jerrall</u> <u>Haynes</u> last month, about upcoming agenda items or other Commission issues.
