The City of Spokane proposes the following change to RCW 82.80.140:

Vehicle fee—Transportation benefit district—Exemptions.

(1) Subject to the provisions of RCW <u>36.73.065</u>, a transportation benefit district under chapter <u>36.73</u> RCW may fix and impose an annual vehicle fee, not to exceed one hundred dollars per vehicle registered in the district, for each vehicle subject to vehicle license fees under RCW <u>46.17.350</u>(1) (a), (c), (d), (e), (g), (h), (j), or (n) through (q) and for each vehicle subject to gross weight license fees under RCW <u>46.17.355</u> with a scale weight of <u>six</u> ten thousand pounds or less.
