## Marcia Davis (Integrated Capital Management) – Financial Background to Water, Sewer & Stormwater Planning [please see attached presentation]

Marcia presented how Capital Planning and the Comprehensive Plan aim at keeping systems going that aren't found in nature like pipes and stormwater drainage. Capital Management is doing public outreach to ensure that their processes and plans are inclusive and responsive to community needs. They are also going to present to the Sustainability Action Subcommittee. It was suggested that they talk specifically to the Environmental Justice Workgroup.

They are developing outreach to impacted communities and neighborhoods with low participation. It was suggested that they go to cultural festivals and that they have materials in different languages.

### Jerrall Haynes – Civil Rights Director

The Department of Diversity, Equity & Inclusion is now hiring and seeking applicants from diverse backgrounds and lived experiences. Jerrall is also looking at the City of Spokane's Diversity Plan which is overdue for an update as well as the city's ADA Plan and Title VI Plan.

Community members and city staff are encouraged to support the newly established office by invoking it and promoting the functions of the office within the community. The Office is working with the Mayor's Communications team to reach out to the community at large and to youth at community festivals



In the aftermath of the rainbow crosswalk defacement, Jerrall worked with the police department, Odyssey Youth Movement and the Human Rights Commission on prevention and culturally appropriate responses should the incident happen again.

It was brought up that it will be a community effort to combat hate crimes and civil rights complaints just as this historic appointment was fought for by Spokane City Council, the Spokane NAACP and other community groups.

It was brought up that even nonprofits of color face discrimination in the application process.

#### Council Members Navarrete & Klitzke -- New Council Members

Council Member Klitzke is the new council member from District 3 which is the Northwest part of Spokane. It is statistically the Whitest and oldest district with a lot of retirees. Average age of North Indian Trail is 80 years old. This comes with a lot of anxiety over senior housing and aging in place.

Council Member Klitzke has committed to working with her seatmate Council Member Zappone to host townhalls throughout their district. Everyone is invited to attend.

She is particularly interested in land use and transportation and invited the subcommittee to collaborate with her about those issues as her strengths and lived experience. CM Klitzke also encouraged the subcommittee to be involved in Washington Department of Transportation community workshops and a couple of workshops that are coming up involving West Central.

Council Member Navarrete said that she is only a week into her appointment but comes from an activist background so is familiar with many issues facing District 2. She had previously worked with her seatmate Council Member Paul Dillon. As the first immigrant to serve on City Council in recent history, she is committed to diversity and inclusion initiatives and is aiming to bring more diverse voices to the Dais and committed to reaching out to communities by visiting them in person. Council Member Navarrete is also passionate about language access in government and helping those experiencing homelessness.





# Prioritize Projects using Multiple Objective Decision Analysis (MODA)



MODA is a process to assess and compare different options based on multiple criteria

- **Obefines context and goals** aligned with Spokane's values and mission
- Builds credibility by providing objective and transparent documentation
- Increases resiliency by responding to changing conditions & needs over time
  - Provides a feedback loop to guide future system planning
  - Creates a living process allowing us to adapt over time



	Risk (Drivers of Uncertainty)	Issue (Decision Point or Trigger)
Definition	event or situation that <a href="mailto:could occur">could occur</a> and <a href="mailto:cause negative impact">cause negative impact</a>	event or situation that is already occurring and causing negative impact
Example	When you are home, you see a snowstorm in the forecast, so you decide to stay in	A snowstorm occurs when you are outside, so you decide to seek shelter
Response	<ul><li>Stay home</li><li>Ride the bus</li><li>Go for it!</li></ul>	<ul><li>Seek shelter</li><li>Call a friend</li><li>Panic!!</li></ul>
