1. Member Recruitment – Sebastian Ruiz
  - No Action Taken, Discussion Only
    - Kiana suggested both looking broadly for people interested in budgeting work and doing targeted outreach to certain communities
2. Resolution Recognizing the Importance of Cultural Celebrations – Lisa Gardner
  - No Action Taken, Discussion Only
    - National Parks Services replaces MLK Day and Juneteenth with Constitution Day and Flag Day (Trump's Birthday) on their calendar
    - Proposed resolution to affirm Spokane's recognition of MLK Day and Juneteenth

1. While federally there is an effort to erase Black History and American History, the City of Spokane continues to celebrate and host cultural, historical celebrations
  - **Council will vote on January 12<sup>th</sup>**
  - Patricia asked for an invite to be sent to as many people as possible to come testify on that day
3. Equitable Budget Workgroup Update – Workgroup
  - No Action Taken, Discussion Only
    - **Overarching Goals**
      1. Disparity Mitigation
        - a. Does the budget aim at (or at least avoid worsening) social disparities? These include race, sex, gender, disabilities, geography, and income disparities.
      2. Data Driven
        - a. Does the budget enhance data collection, tracking and utility across agencies?
      3. Outreach
        - a. Has the finance committee liaison attended equity subcommittee meetings?
      4. Community Input
        - a. Does the budget name the concerns that guided the budget design? Do those concerns reflect community priorities? i.e. public safety, program efficiency, food security
      5. Expanding Funding Streams
        - a. What budget elements could be supported by private funders/philanthropy?
    - Patricia commented that these goals seem realistic and viable
    - Kiana suggested clarifying the social impacts and social disparities that we'd like the city to address
    - Patricia suggested creating a plan of action as a next step to recommending priorities that align with these overarching goals
  - **Guiding Principles**
    1. Accountability
      - a. Evidence-based budget design
      - b. Data driven policy priorities
    2. Community-informed allocation of resources
    3. Collaborative Governance: Bilateral communications between City electeds, orgs and potential funders, sponsors and philanthropy
      - a. Outreach? Via Equity Subcommittee?
    4. Deepened, more authentic relationships with Spokane Communities

#### 4. Community Engagement – Workgroup

- Considering the communities our organizations serve; considering our workload as volunteers in the ESC; what outreach strategies can we suggest?
- Examples
  1. Council liaison in all ESC meetings
  2. Invite non-member orgs to ESC meetings, share links
  3. One-on-one meetings between ESC members and their district councilmembers
  4. Consolidate Immigrant & Refugee Affairs Committee (Mayor's advisory committee)
- Anne suggested a member or group of the Subcommittee present to Greater Spokane Progress on the work that the ESC is doing
  1. Kiana feels that the group is too early in the process to present outwardly
- Different organization representatives in the ESC, such as KJ with Spectrum, were interested in being involved in this equitable budgeting work
