 - ➤ A framework was adopted by City Council with four main purposes:
 - 1. *Replenish* lost City government revenues due to the pandemic.
 - 2. **Reach out** to community partner organizations to fund initiatives.
 - 3. **Resiliency** for Spokane –investments in forward-thinking initiatives.

- 4. **Relief** for residents and businesses that were left behind by other relief programs.
- ➤ Equity Statement: "The City of Spokane is committed to equitably and effectively utilizing ARPA resources to help our community bounce back as soon as we can and in the best way possible. To do this we look to fund organizations and businesses that take into consideration past inequities and will go forward to honor the expertise, relationships, and resilience within communities of color and those historically impacted by inequities providing them with lasting partnerships and co-created solutions to eliminate systemic hardships."
- New Platform was brought in for simplified application process for ARPA grants. City tried to minimize as much as possible the barriers to attaining these funds. These efforts included:
 - 1. Public Workshops & Trusted Community Messengers
 - 2. Multiple tutorial videos for the process were created
 - 3. Language Barriers
 - a. Application could be translated into multiple languages
 - b. Application asked if the organization needed communication in another language
 - 4. Streamlined the Agreement Process
 - Application walked organization through new vendor enrollment
- Resulted in \$5M awarded to 140 nonprofits and \$4.5M awarded to 152 small businesses
- ➤ Of the \$80.9M, 48.9M was spent externally, 31.7M was spent internally (60% spent externally)
