  - i. Open comments started at 5:51pm and concluded at 5:56pm
- 4. Voting on Vision Statement wording
  - a. Ranked Choice Voting
  - b. The phrasing "carbon free" was decided on instead of "carbon neutral"
  - c. 10 votes to pass; 0 votes to deny
    - i. Buildings and Energy workgroup advisory vote, by Larry Andrews, voted a '5'- indicating disapproval for the decision
    - ii. No voting member voted '5'
- 5. Discussion on Mission Statement
  - a. This topic was not open to public comment and will not be voted on this meeting
  - b. Two (2) rounds of discussion with voting members of the steering committee

#### 3/7/2023 SAS Steering Committee Solar Permit Fees Workshop

The following is meant to provide context for Council President Beggs' request for the SAS Steering Committee to review and provide recommendations on an existing solar permit fee waiver:

SMC 15.05.040, the text of which is included in this packet, waives permit fees for solar arrays and vehicle charging stations until such time as the majority of energy "sourced" in Washington is renewable.

This incentive has become quite popular, and the City office that issues permits (i.e. the Development Services Center) wants to know definitively when they can start charging for inspections/permits again since they are an enterprise fund and thus not subsidized by general tax dollars.

Council President Beggs' personal interpretation of the existing code is that "sourced" means used - not necessarily just produced - and that it is all energy, not just electricity.

Council President Beggs requests that the SAS Steering Committee discuss this item at the March 7<sup>th</sup> meeting and consider adding this topic to their workplan with the goal of providing a formal recommendation to Council on how this code could be amended to be more clear and what data source should be used as the measure.

Council President Beggs has asked the Development Services Center for the amount of reserves they have in their fund in order to determine how urgent an issue this is for them and whether the City can continue to afford to incent installations through this fee waiver.
