#### **General Facilities Charges**

#### **April 2023**

General Facilities Charges (GFCs) are a one-time charge to connect to the City of Spokane's water or wastewater system. The funds raised through GFCs are used to pay for capital projects that support growth—not for operations and maintenance of the existing water and wastewater systems.

The City established GFCs 20 years ago, but unfortunately has not updated them since. An adjustment for inflation wasn't even included, leaving the charges woefully behind the costs of capital projects.

#### Why are GFCs needed?

Without appropriate GFCs, the burden of paying for growth-related infrastructure rests with the residents and ratepayers who are already connected to the system. The funding for capacity improvements essentially would have to come from higher monthly bills.

#### What's Happening with GFCs?

In 2023, the City proposed new GFC rates to bring the up-to-date and address current costs and infrastructure needed for growth. The timing also was tied to a moratorium on new building permits in the Latah Valley. To provide the opportunity to life that moratorium timely, an update to the GFC rates (along with Transportation Impact Fees) was required.

In March 2023, the City Council adopted new GFCs. Rates representing an inflationary increase over the rates adopted in 2002 are currently in place through March 4, 2024. After that, the adopted GFCs would rise. In the meantime, the City is working through an additional outreach and education effort to consider options or changes to the rates that would go into effect in 2024.

#### What is included in the Education & Outreach Effort?

The Mayor is creating a review committee with a variety of stakeholders.

Additionally, the City Council passed a resolution requiring outreach to additional specific groups, including the Sustainability Action Subcommittee, the Equity Subcommittee and the Housing Action Subcommittee.

#### What kinds of issues can we talk about?

- Overview of GFC proposals and how they are calculated.
- How to pay for growth-related infrastructure? Through GFCs on growth, rates paid by all, or some combination.
- What kinds of development should we incentivize (like affordable housing)?
- Should we review other GFC calculation methodologies?
- 1 or 2 zones for water GFC charges?
- Growth projections. Phase-in options. Etc.

# Transportation and Land Use Work Group Key to Spreadsheet Priorities

This document provides a full text listing of the 5 top priorities the Transportation and Land Use Work Group provided to Kara Odegard on September 27, 2022. This information was summarized in table, but we provide here the full text of the relevant Sustainability Action Plan (SAP) goals and policies related to the five priorities.

More specifically, the Transportation and Land Use Work Group identified other goals that these priorities support in the Transportation and Land Use (T&L) chapter of the SAP, as well as those in other SAP chapters. The group also assessed the priorities' alignment with the overall SAP priorities, and suggested possible financial support or other implementation potentials.

### **Priority 1**
