Excerpts of Commendations (Personal Identifying Information has been removed)

Last night one of the members of my congregation was taken into custody after an hours-long standoff. He was inebriated, suicidal, belligerent, and irrational. The sergeant even said to me after he was finally in custody, "Is he always this difficult?" To which I promptly replied, "Yes, unfortunately." I know you don't likely receive as many encouraging emails as you do critical ones, so I wanted to say thank you for how this was handled. It was done respectfully and with care, especially considering he asked the officers multiple times to please kill him. The officers treated him with dignity and an extreme amount of patience despite the situation. I know that police work is difficult for a variety of reasons, which is why I wanted to say that I am thankful for the commendable actions of the SPD last night. I want to express my gratitude to all of you as a pastor, community member, lifelong Spokane resident, and as a friend of the person taken into custody. Thank you for protecting all involved in the best ways. [Sergeants Tafoya, Fairbanks, and D. Lesser; Corporals Busch and Guzzo; Officers Braten, Edwards, English, LaBelle, M. McKitrick, and Medellin.]

It's like I've gone to heaven! Thank you and all of the SPD for your hard work! I know you were all working on it and it did take time, but it was done right. We are thrilled to have our neighborhood back. [Detective Tim Schwering.]

You guys are amazing! Thanks so much! You guys have such great customer service! If citizens don't tell you that, they should. [Police Records concealed pistol license team: Renee McCoy, Dawn Biehl, Barbara Barber, and Brandi Belcher.]

I wanted to leave a little thank you message for **Officer Christopher Bruner.** I didn't have a chance to say much to him at the scene of the accident. I just wanted to say thank you. I'm sorry for getting emotional. Just thank you for coming to the scene and coming to the hospital. It was really kind. I really did appreciate it.

I want to thank you for patrolling around 2nd and Division near our program where men are working to turn their lives around. I know there are so many people that are in need of help on the streets. Some are searching for help, some not, but I pray your officers are kept safe and remain compassionate yet serious about keeping our city safe. It is sad to see it dwindling, but there is hope. Please know that you are appreciated and there are people holding you up in prayer.

As Block Watch captain, I want to extend my sincerest appreciation for whatever efforts led to the recent reduction in street racing around Emerson-Garfield Ruby-Division area. We live on the corner of Stevens and Jackson. This weekend was one of the quietest, most peaceful weekend nights of sleeping we've experienced in months. Coincidentally, we had family visiting and it was a pleasure hosting them in a relaxing environment. Keep up the great work.



SPD maintains a process that allows us to assess the actions of our employees with the ultimate objective of improving service and holding our employees accountable. Complaints sometimes reveal the need to modify a policy or procedure or reveal a need for training. In 2023, complaints to SPD decreased 12% compared to 2022. Additionally, SPD continues to receive 3 times the commendations as complaints. In 2023, SPD saw a 12% increase in commendations compared to 2022.

It's important to note that calls for service and arrests have increased, and yet commendations are up. The call for service volume through Quarter 1 of 2024 is remaining very high at about 57,000. Arrests are up about 10% from the Q1 year prior. The chart below shows commendations versus complaints from the community through April 2024.

Sector Updates

Adam Sector (Northwest)

SPD Arrests Long Time Convicted Felon After Brief Standoff

On 5/1/24, SPD's Violent Crimes Task Force (VCTF) was seeking a suspect for robbery after he entered a woman's garage, threatened her with a firearm and stole her purse on 4/27/24. Officers located the suspect in a vehicle which pulled into a restaurant in the 1800 block of N. Monroe where he quickly barricaded himself in his car and refused to comply with orders to surrender. SPD began the process of calling in additional resources to de-escalate the situation including on-duty SWAT officers. About 20 minutes later, with still no compliance, officers breached one of the vehicle windows and deployed a pepper ball gun. The suspect exited his car and police arrested him without further incident.

Tevan T. Williams (34) was booked into the Spokane County Jail on one count of 1st Degree Robbery and an outstanding warrant for 3rd Degree Assault. Williams is a 17-time convicted felon with convictions to include felony assault, robbery, riot with a deadly weapon, extortion, and forgery.

The VCTF exists to identify and arrest the most active and dangerous offenders committing the most violent crimes including murder, rape, and robbery. So far in the first four months of this year, the VCTF has arrested 16 individuals for violent felonies and has seized 10 firearms.

Baker Sector (Northeast)

SPD Arrests Two in Park Shooting

On 4/30/24, Spokane Police officers responded to reports of a shooting at Chief Garry Park on Sinto Ave. around 5:30pm. Officers arrived to find a park busy with people gathered for baseball games and otherwise. Multiple witnesses on scene were helpful in providing information about, and pictures of, what happened. Officers learned that an argument involving a number of young people took place near the southwest part of the park. A car pulled up with two males who exited the vehicle and headed toward where the argument was heard. Shots were fired and the males from the vehicle returned to it and drove away. Shell casings were located in the grass.

Patrol officers were able to determine the registered owner of the car and learned from cooperative parents that their teenage son had the car. Officers located the vehicle at E. Euclid Ave. and N. Crestline...

St., pinned the car and detained the two males inside the vehicle without incident. At least one firearm was found inside the vehicle. Officers developed probable cause to arrest Hunter T. Simmons (18) and a 17-year-old male. Both face charges of Drive-By Shooting. At this point, no shooting victims have been located. Anyone with additional information on this incident who has not already spoken with police is encouraged to call Crime Check at 509-456-2233. Police continue to investigate whether other persons were involved in this incident. With warmer weather, more daylight hours, and more people out and about, SPD has increased patrol efforts around our area parks. We continue to encourage community members to report suspicious activity in and around parks as we all work to keep our parks safe and enjoyable for everyone.

Charlie Sector (South)

Spokane Police Arrest a Woman for Murder After Running a Man Over

On 04/09/24, SPD officers responded to the area of West Sunset Frontage Road and South Grove Road on a possible deceased person on the side of the road. Officers arrived to find a partially clothed deceased male who appeared to have been hit by a vehicle with the impact throwing him into a nearby fence. Major Crimes collision investigators and detectives were called to the scene and began an investigation. Shortly after the discovery of the deceased male, a number of witnesses called 911 reporting a truck driving erratically nearby on Highway 2 in Airway Heights. Witness reports allowed detectives to identify the reckless vehicle, and through subsequent investigation it was determined that the deceased male was the owner of that vehicle. However, officers were not able to locate the vehicle at that time. Major Crimes investigators determined that it was likely the driver had intentionally hit the man on Sunset Frontage Road.

While investigators were still on scene, Lincoln County Sheriff's Office deputies were alerted to the same truck by a concerned citizen reporting a possible impaired driver. At that time, the association with the death investigation was not known. The vehicle fled from deputies and after a short pursuit, the driver, Alyssa K. Bray (27), was taken into custody. Bray was booked into the Lincoln County Jail for DUI and Attempting to Elude a Police Vehicle.

Through further investigation, it was learned that on the evening of April 9th, Bray was walking on Sunset Highway when she accepted a ride in the truck with the male. Investigators believe that shortly thereafter, Bray took possession of the vehicle from the victim and intentionally struck him with his vehicle. Today, 04/16/24, detectives traveled to Lincoln County and arrested Bray for 1st Degree Murder. She was transported to Spokane and booked into the Spokane County Jail. The deceased has been identified by the Spokane County Medical Examiner's Office as Gerald R. Fox (70).

This was a complex investigation that unfolded rapidly over a large geographical area. The willingness of concerned citizens to report dangerous and suspicious behavior was critical in allowing investigators to make a timely arrest on this incident.



David Sector (Downtown)

SPD Responds to An Armed Robbery Downtown

On 4/10/24, SPD patrol officers responded to a reported robbery at gunpoint near the area of 500 W. Sprague around 10:00 PM. Officers contacted the victim who stated the suspect had placed a handgun in his stomach and demanded his property. The suspect even "racked the slide" of the firearm to prove it was real. The victim gave over his property and the suspect fled on foot.

Officers were able to identify the suspect as Edward F. Ramey (18) and locate him at a youth facility in the 3100 block of E. Augusta. Officers were eventually able to work with staff at the facility and the suspect was taken into custody without incident.

SPD was able to observe video footage confirming the suspect brought the firearm into the facility. At that point officers wrote and executed a search warrant for the suspect's bag, which was in the facility. Two BB guns which were replicas of actual firearms were located in the suspect's bag. Ramey was booked into jail for 1st Degree Robbery.



Drug Education with Youth

SPD is involved in an art education program with the Drug Enforcement Administration (DEA) for elementary and middle school youth. The DEA supplies an art teacher and supplies so that youth in Boys and Girls Clubs can experience art education. During the art education, SPD officers interact with the youth, providing information about safety and drugs, especially the dangers of Fentanyl and other opioids. SPD partners at ESD101 are helping teach as well.

A total of 8 sessions have been held so far at various locations in Spokane County.





Drug Take Back Event

SPD officers and volunteers participated in the Drug Enforcement Administration National Prescription Drug Take Back Day. This event's purpose to fight the drug overdose epidemic by disposing of unneeded prescription medications. We love working with our partners at ESD 101. The event was successful in collecting unused medications and in providing an opportunity for dialogue.



Discussion about Violence - Spokane Children's Theater

Spokane Children's Theater did plays about gun violence. Reserve Officer Ed Richardson was involved with supporting their efforts. He was asked to facilitate a question and answer session with the youth after their play concluded. He loves the opportunity to talk with youth about violence, bullying, drugs, and making good choices.





Behavioral Health Unit (BHU) Update

Two of our BHU officers lead the instruction of a Washington State Criminal Justice Training Commission (WSCJTC)-certified 40-hour Crisis Intervention Team (CIT) course for law enforcement officers and other service providers from around eastern Washington. The entire BHU team assisted with mock scenes during one of the training blocks.

CIT training involves working in a team with mental health practitioners, law enforcement, medical personnel, and other first responders. The focus is to provide the best services possible to the individual in a mental health crisis. The Washington CIT programs follow model policies and guidelines brought from using the foundational Memphis CIT Model, Washington State guidelines, and best practice materials from CIT International (CITI). To access the CITI website visit www.citinternational.org.

Example of the BHU helping an individual with behavioral health needs:

Client X was staying at the Cannon Shelter. The Way Out Shelter wanted to move him into their program to start working towards housing; however, he needed to get clean and sober. In November 2023, a BHU officer got him into treatment at the Spokane Regional Stabilization Center for methamphetamine substance use disorder. In January 2024, he was clean and sober, but he was struggling with his mental health. The co-deployed clinician and officer facilitated a warm hand-off with Frontier Behavioral Health's Mobile Crisis Response team in hopes of stabilizing him on mental health meds.

In April 2024, the client was able to get on a housing list, but had an Unlawful Camping warrant, which prohibited him from getting housing. Gerianne from the Salvation Army and the BHU officer used the Pioneer Navigators and worked with the courts. They were successful in getting the client's warrant dropped. As of April 29, 2024, the man was cleared for housing and was ready to move into his new apartment. He is very thankful for the assistance of BHU.

April 2024 BHU Stats:



I wanted to thank you, your crew, your supervisor, and all the agency partners for the amazing *wildfire fuel reduction work* you have recently performed in/around our West Hills neighborhood (and beyond). I've been meaning to write this letter for a while to express my gratitude for what you are doing. As you are fully aware, the increase in wildfire risk has put our neighborhood on edge. Last year we had a Level 3 evacuation on a red-flag day, the same day and same neighborhood that an arsonist started several fires just a few houses down from where I live. Fortunately, the Spokane Fire Department and Department of Natural Resources allocated significant aerial and ground resources on that fire to quickly contain it from spreading further into our neighborhood. As I walk my dog on a daily basis at the lower end of Indian Canyon golf course, *I really appreciate the fuel reduction you've done to open up the scenery and reduce the explosive fuel inventory that was formerly in that area.* I also walk my dog up Rosamond up to the top of Sunset Hill, and appreciate all the fuel reduction in that area too, which itself was charred from the previously mentioned fire in which we had to evacuate. There is probably more fuel to reduce, but I'm not complaining at all for the progress already made. I've also observed the fuel reduction along West Drive, which I think significantly reduces risk if/when a fire potentially sparks from a passing vehicle or a neglectful pedestrian.

As with anything involving our environment, I'm sure you get letters of support as well as letters of objection. *This is a letter of full support. Your efforts are meaningful and make a difference. Keep it up!*

Spokane Fire won numerous Excellence in EMS awards

Special Services: Corey Newman

Corey Newman researched and created the Naloxone Leave-Behind program. Corey is a Captain Firefighter and EMT, and as a front-line responder in the City of Spokane, he recognized the need for the patients and families or communities of patients who had experienced an opioid overdose to have additional doses of naloxone available to them on-hand should a future overdose occur. Corey found a way to get the fire department a renewable supply of naloxone at no additional cost to the city and brought all the information and ideas to the Integrated Medical Services office. He continually checked up to make sure the project was progressing until it came to fruition, and now every frontline apparatus has a supply of leave-behind nasal naloxone with just-in-time instructions that they can provide to patients and their loved ones after they respond to an overdose.

Special Services: Calle Feller

Paramedic Calle Feller gave tireless efforts in advocating for sexual assault victims in our community. Calle recognized a lack of training and knowledge in how our system handles vulnerable patients and took steps to protect them. After many hours of research and meetings with community partners she developed a comprehensive protocol for the best care for these patients. She then went on to provide education on patient management and best practices for preserving evidence of the crime. As a new paramedic in the system, Calle found a place where we had room for improvement and was the change we needed. Her contributions will have lasting impacts on our patients and their providers for many years to come.

EMS Agency: Spokane Fire Department

This agency has presented excellent care with increasingly large call volumes, and had several providers nominated for EMS Awards to recognize the outstanding work of their providers that give continuous efforts to improve the EMS system in our community.

ALS Responder: Mathew Schroeder

Matt brings his wealth of knowledge from his learnings in Paramedic school and his time working as a Respiratory Therapist in the hospital setting. Matt has taken it upon himself to begin a daily series, on shift, called Matt's Medical Minute. This training is every day and runs from 20 minutes to an hour plus depending on the topic. He continually pushes the crew and the station to become more involved in EMS and makes trainings fun and interesting. For these trainings, Matt has met with other professionals in the area, outside of the fire service to gain knowledge about topics he himself is not 100% clear on and provides the crew/station reports over these findings. He has single handedly brought his peers up to an amazing level of care providers. On all EMS incidents Matt is a true professional and does not waver from the reason he became a medic. He is compassionate to patients and will always advocate for what is best for the patient.







It is, therefore, by the City Council declared that an urgency and emergency exists for making the changes set forth herein, such urgency and emergency arising from agreement for the expansion of the SFD BRU Unit and because of such need, an urgency and emergency exists for the passage of this ordinance, and also, because the same makes an appropriation, it shall take effect and be in force immediately upon its passage.



Services Agreement

This Services Agreement, referred to as "Agreement", is effective as of May 1, 2024 ("Effective Date") by and between the University of Washington, an institution of public higher education, located in Seattle, Washington, hereinafter referred to as "University", and City of Spokane Fire Department ("Contractor"). This Agreement specifies the Terms and Conditions of Contractor's relationship with the University.

In consideration of the mutual premises hereinafter contained, the parties agree that this contract will be performed in accordance with the following conditions:

1. PURPOSE

In 2023, the State Legislature appropriated funds to provide funding for mental health professionals to provide regional behavioral health services in the field for non-law enforcement-based co-response programs. Within these programs, regional 'pilot' training HUBs will be created for the purpose of training non-law enforcement-based emergency response personnel, including Fire/EMTs, community paramedics, and co-responders who are responding to behavioral health emergencies.

Funding must be used by the Contractor to create or sustain a co-response program working in one of the following innovation areas: becoming a behavioral health agency and billing for behavioral health services; starting/expanding the administration of medications for opioid use disorder in the field; operating a crisis response or follow-up response unit that is integrated into the 988/local crisis hub system; or starting a program in a critical shortage area not being served by any co-response services. Funding must also be used to support train-the-trainer opportunities and training activities in 2025.


2. SCOPE OF WORK

2.1 Performance

The Contractor will provide services, and otherwise do all things necessary for or incidental to the performance of work, as set forth in the Scope of Work dated 5/1/24 and incorporated herein. Performances include:

Demographic Reporting (May 2024-June 2025)

The Contractor will collect and report demographic information of individuals served on a quarterly basis and include the following information: age, race/ethnicity, gender, sex, marital status, and military service. The University of Washington will provide a demographic reporting spreadsheet along with other reporting requirements.



Deliverables and Compensation



3. PERIOD OF PERFORMANCE

The period of performance under this contract will be from 5/1/24 through 6/30/25. The University of Washington reserves the right to extend this contract but shall be under no obligation to do so.

4. AMENDMENTS

The parties may change the scope of the Services and Deliverables and other matters specified in a Scope of Work only by a written amendment executed in advance by an authorized representative of each party and incorporated into the Agreement as an amendment.



5. INDEPENDENT CONTRACTOR

The parties intend that an independent contractor relationship is created by this Contract. The Contractor and his or her employees or agents performing under this Contract are not employees or agents of the UW. The Contractor, his or her employees, or agents performing under this Contract will not hold himself/herself out as, nor claim to be, an officer or employee of the UW or of the State of Washington by reason hereof, or act as attorney in fact, nor will the Contractor make any claim of right, privilege or benefit that would accrue to such employee. Conduct and control of the work will be solely with the Contractor.

6. RESPONSIBILITIES AND EVALUATION UNDER SCOPE OF WORK

The Contractor shall be responsible for completing all requirements in the Scope of Work. - 7.2 All taxes or fees assessed by any tax jurisdiction arising from the Projects outside of the U.S. are the responsibility of the University.


7.3 Expenses

"Confidential Information" means any non-public information of University which is maintained as confidential, including, but not limited to, biological materials; software; diagrams; valuable formulae; electronic files; source code; physical files; invention disclosures; patent applications; technical and scientific information; research data; draft publications; technical reports; research plans; research discoveries; business plans; financial reports, projections, and/or models; educational records; and Personally Identifiable Information (PII). Confidential Information does not include any information which Contractor can establish by competent written proof (a) was in the public domain as of the Effective Date; or (b) was independently developed by Contractor without knowledge of or assistance from the Confidential Information.

The obligations with respect to Confidential Information set forth in this Section shall survive the termination of this agreement.

10. CONFLICT OF INTEREST



The Contractor warrants and represents that the Contractor has all rights and permissions, including intellectual property rights, moral rights, and rights of publicity, necessary to grant such a license to the UW.

The UW shall receive prompt written notice of each notice or claim of copyright infringement received by the Contractor with respect to any Materials delivered under this Contract. The UW



ORDINANCE NO	

An ordinance relating to the establishment of a code relating to firearms safety and prevention; and adopting a new Chapter 10.75 to Title 10 of the Spokane Municipal Code.

WHEREAS, gun violence is a public health and public safety crisis in the United States; and

WHEREAS, the Gun Violence Archive defines a mass shooting as one with four or more people injured or killed, and there have been more than 135 mass shootings through May 2, 2024; and

WHEREAS; someone is killed by a gun every 10 hours in Washington State and gun violence is the leading cause of death for children and teens; and

WHEREAS, according to the Washington Alliance for Gun Responsibility, gun violence costs Washington state an average of \$11.8 billion every year and these figures include health care costs for medical bills and mental health support as well as police and criminal justice costs; and

WHEREAS, in 2023 in the City of Spokane, there were 16 deaths from firearms and 23 firearm injuries; and

WHEREAS, waiting for local data from PD re: gun violence

WHEREAS, gun violence is preventable and stronger gun laws have been proven to reduce gun violence; and

WHEREAS, the City of Spokane establishes criminal penalties for crimes related to firearms in Chapter 10.75 of the Spokane Municipal Code, but the code lacks specific prohibitions that would enhance safety and ensure fewer incidents in areas likely to be exposed to gun violence; and

WHEREAS, the Spokane City Council intends to update its firearms regulations to make the community safer from gun violence;

NOW, **THEREFORE**, the City of Spokane does ordain:

Section 1. There is enacted a new chapter 10.75 to Title 10 of the Spokane Municipal Code to read as follows:

Chapter 10.75 Firearms and Dangerous Weapons

SMC 10.75.010 Scope and Purpose

SMC 10.75.020 Discharge of Firearms Prohibited

SMC 10.75.030	Discharge Near Buildings
SMC 10.75.040	Possession of Firearms
SMC 10.75.050	Disposition of Firearms
SMC 10.75.060	Exemptions

10.75.010 Scope and Purpose

Gun violence is a public health issue. The impacts of gun violence, both direct and indirect, inflict an enormous burden on society, including suicide, homicide, and unintentional deaths, as well as nonfatal gunshot injuries, threats, and exposure to gun violence in all neighborhoods.

This chapter defines a process to implement prevention of gun violence and safety measures designed to save lives.

10.75.020 Discharge of Firearms Prohibited

Except as set forth in Section 10.75.060, it is unlawful for any person to discharge any firearm in the city of Spokane where there is reasonable likelihood of injury to humans, domestic animals or property.

10.75.030 Discharge Toward or Near Buildings

In all areas of the City of Spokane it shall be unlawful to discharge a firearm toward or within five hundred feet of any building:

- A. Occupied by people or domestic animals, or
- B. Used for storage of flammable or combustible materials, or
- C. Used or occupied by any preschool, or primary or secondary school, whether public or private.

10.75.040 Possession of Firearms

- A. It is unlawful for any person to enter any stadium or convention center operated by the city or other municipal or public corporation when the person knowingly possesses or knowingly has under the person's control a weapon as defined in RCW 70.74.010 or listed in RCW 9.41.250.
- B. It is unlawful for any person to knowingly open carry a firearm or other weapon, as defined in RCW 9.41.010, any public building used in connection with meetings of the governing body of the City of Spokane or Spokane County. For purposes of this section, "governing body" shall have the same meaning as in RCW 42.30.020,

- and includes, without limitation, the Spokane City Council, or other policy or rule making body of the City of Spokane or Spokane County, or any committee thereof when the committee, board, or commission acts on behalf of the governing body, conducts hearings, or takes testimony or public comment.
- C. It shall be a defense to a violation of this section if there are no posted signs at areas of ingress and egress to public buildings that provide notice of the restrictions on possession and open carry of firearms and other weapons at locations specified in this section.
- D. Nothing in this section shall apply to the lawful concealed carry of a firearm by a person who has a valid concealed pistol license.
- E. A person violating this section is guilty of a misdemeanor on the first offense. Second and subsequent violations of this section shall constitute a gross misdemeanor.
- F. This section 10.75.040 shall not apply to:
 - 1. The possession of any concealed pistol by a person licensed under RCW 9.41.070
 - 2. Individuals exempt from the firearms restrictions under RCW 9.41.060 (1) through (3), as amended from time to time
 - 3. Federal, state, or local law enforcement officers or personnel, or to members of the armed forces of the United States or the state of Washington, when such individuals are carrying a firearm or other weapon in conformance with their employing agency's policy, or when carrying a firearm or other weapon in the fulfillment of official duties or traveling to or from official duty.

10.75.050 Disposition of Firearms

- A. All firearms, magazines and ammunition that come into the possession of the police department after June 30, 1993, that are judicially forfeited under RCW 9.41.098 and are no longer needed for evidence, or that are forfeited due to a failure to make a claim under RCW 63.32.010 or 63.40.010 shall be disposed of by the police department as appropriate in its sole discretion in one or more of the following ways:
 - 1. Retained for use by the police department; or
 - 2. Destroyed
- B. Antique firearms as defined by RCW 9.41.150, as now or hereafter amended, and firearms recognized as curios, relics, and firearms of particular historical significance by the United States Treasure Department Bureau of Alcohol,

Tobacco and Firearms are exempt from destruction and shall only be disposed of by auction or trade to commercial sellers. All proceeds from the trade or auction of antique firearms occurring under this subsection shall be retained and used by the police department.

C. All firearms, magazines and ammunition that are illegal for any person to possess shall be destroyed and shall not be retained; provided, however, if firearms otherwise illegal to possess may be rendered legal to possess by removal or alteration of component parts, the police department may, in its discretion, effect such removal or alteration and may thereafter retain the firearm under the provisions of this section.

10.75.060 Exemptions to Prohibitions on Discharge

- A. Sections 10.75.020 and 10.75.030 of this Chapter shall not apply to any discharge occurring on a rifle or pistol firing range that has been issued a business license by the City for such purpose.
- B. Sections 10.75.020 and 10.75.030 of this Chapter shall not apply to the discharge of firearms by law enforcement officers engaged in the performance of their official powers or duties.
- C. ,Nothing in Sections 10.75.020 and 10.75.030 of this Chapter shall be deemed to abridge the right of the individual guaranteed by Article I, Section 24, of the State Constitution to bear arms in defense of self or others.



PURCHASED SERVICE CONTRACT

Title: ELECTRONICS PURCHASE AND INSTALLATION FOR EMERGENCY VEHICLES

This Contract is made and entered into by and between the CITY OF SPOKANE FIRE DEPARTMENT as ("City"), a Washington municipal corporation, and RACOM CORPORATION, whose address is 16608 East Sprague Avenue, Spokane Valley, Washington 99037 as ("Contractor"), individually hereafter referenced as a "party", and together as the "parties".

The parties agree as follows:

1. PERFORMANCE/SCOPE OF WORK.

The Contractor will do all work, furnish all labor, materials, tools, equipment, transportation, supplies, supervision, organization and other items of work and costs necessary for the proper execution and completion of the work described in the specifications entitled Electronics Purchase and Installation for Emergency Vehicles, IRFP 6106-24, and Contractor's Response to IRFP which is attached as Exhibit B. Work to include, but not be limited to the installation of emergency equipment on emergency response vehicles, to include but not limited to lights, sirens, controllers, radios, consoles and barriers. The emergency response vehicles will typically be sedans, pickup trucks and sport utility vehicles but may occasionally include a custom-built heavy apparatus. Equipment may be either provided by Contractor or supplied by the Spokane City Fire Department. Contractor must be familiar with the installation of Whelen WeCan components and controllers. Contractor must be experienced in the installation of visible and audible warning systems on Emergency Vehicles and knowledgeable in State and Federal guidelines and requirements pertaining to Emergency Vehicle Visibility and Conspicuity. Work must be complete within four (4) weeks from the delivery of the vehicle to Contractor. In the event of a conflict or discrepancy in the Contract documents, this City Purchased Service Contract controls.

2. TERM OF CONTRACT.

The term of this Contract is estimated to begin on June 1, 2024, and shall run through May 31, 2029, unless amended by written agreement or terminated earlier under the provisions.

3. TERMINATION.

Either party may terminate this Contract, with or without cause, by ten (10) days written notice to the other party. In the event of such termination, the City shall pay the Contractor for all work previously authorized and performed prior to the termination date.

4. COMPENSATION / PAYMENT.

Total compensation for Contractor's services under this Contract shall not exceed **ONE HUNDRED THOUSAND AND NO/100 DOLLARS (\$100,000.00)** for the first year, and **SEVENTY-FIVE THOUSAND AND NO/100 DOLLARS (\$75,000.00)**, per year for the remainder of the contract term, not including sales tax if applicable, in accordance with Contractor's rate structure, as set forth in Exhibit B, unless modified by a written amendment to this Contract. Pricing will be firm for the first twelve (12) months with the opportunity for price adjustments in the anniversary month of the contract creation. This is the maximum amount to be paid under this Contract for the work described in Section 1 above and shall not be exceeded without the prior written authorization of the City in the form of an executed amendment to this Contract.

The Contractor shall submit its applications for payment to Spokane Fire Department, Administration Office, 44 West Riverside Avenue, Spokane, Washington, 99201. Payment will be made via direct deposit/ACH within thirty (30) days after receipt of the Contractor's application except as provided by state law. If the City objects to all or any portion of the invoice, it shall notify the Contractor and reserves the right to only pay that portion of the invoice not in dispute. In that event, the parties shall immediately make every reasonable effort to settle the disputed amount.

5. INSURANCE.

During the period of the Contract, the Contractor shall maintain in force at its own expense, each insurance noted below with companies or through sources approved by the State Insurance Commissioner pursuant to RCW 48:

- A. Worker's Compensation Insurance in compliance with RCW 51.12.020, which requires subject employers to provide workers' compensation coverage for all their subject workers and Employer's Liability Insurance in the amount of \$1,000,000;
- B. General Liability Insurance on an occurrence basis, with a combined single limit of not less than \$1,000,000 each occurrence for bodily injury and property damage. It shall include contractual liability coverage for the indemnity provided under this Contract. It shall provide that the City, its officers and employees are additional insureds but only with respect to the Contractor's services to be provided under this Contract;
 - i insurance coverage limits required in this Contract; and
- C. Automobile Liability Insurance with a combined single limit, or the equivalent of not less than \$1,000,000 each accident for bodily injury and property damage, including coverage for owned, hired and non-owned vehicles; and
- D. Property Insurance if materials and supplies are furnished by the Contractor. The amount of the insurance coverage shall be the value of the materials and supplies of the completed value of improvement. Hazard or XCU (explosion, collapse, underground) insurance should be provided if any hazard exists.

There shall be no cancellation, material change, reduction of limits or intent not to renew the insurance coverage(s) without thirty (30) days written notice from the Contractor or its insurer(s) to the City. As evidence of the insurance coverage(s) required by this Contract, the Contractor shall furnish acceptable Certificates of Insurance (COI) to the City at the time it returns this signed Contract. **The certificate shall specify the City of Spokane**

as "Additional Insured" specifically for Contractor's services under this Contract, as well as all of the parties who are additional insureds, and include applicable policy endorsements, the thirty (30) day cancellation clause, and the deduction or retention level. The Contractor shall be financially responsible for all pertinent deductibles, self-insured retentions, and/or self-insurance.

6. INDEMNIFICATION.

The Contractor shall defend, indemnify, and hold the City and its officers and employees harmless from all claims, demands, or suits at law or equity asserted by third parties for bodily injury (including death) and/or property damage which arise from the Contractor's negligence or willful misconduct under this Contract, including attorneys' fees and litigation costs; provided that nothing herein shall require a Contractor to indemnify the City against and hold harmless the City from claims, demands or suits based solely upon the negligence of the City, its agents, officers, and employees. If a claim or suit is caused by or results from the concurrent negligence of the Contractor's agents or employees and the City, its agents, officers and employees, this indemnity provision shall be valid and enforceable to the extent of the negligence of the Contractor, its agents or employees. The Contractor specifically assumes liability and agrees to defend, indemnify, and hold the City harmless for actions brought by the Contractor's own employees against the City and, solely for the purpose of this indemnification and defense, the Contractor specifically waives any immunity under the Washington State industrial insurance law, or Title 51 RCW. The Contractor recognizes that this waiver was specifically entered into pursuant to the provisions of RCW 4.24.115 and was the subject of mutual negotiation. The indemnity and agreement to defend and hold the City harmless provided for in this section shall survive any termination or expiration of this Contract.

7. TAXES, FEES AND LICENSES.

- A. Contractor shall pay and maintain in current status, all necessary licenses, fees, assessments, permit charges, etc. necessary to conduct the work included under this Contract. It is the Contractor's sole responsibility to monitor and determine changes or the enactment of any subsequent requirements for said fees, assessments, or changes and to immediately comply.
- B. The cost of any permits, licenses, fees, etc. arising as a result of the projects included in this Contract shall be included in the project budgets.

8. CITY OF SPOKANE BUSINESS LICENSE.

Section 8.01.070 of the Spokane Municipal Code states that no person may engage in business with the City without first having obtained a valid annual business registration. The Contractor shall be responsible for contacting the State of Washington Business License Services at www.dor.wa.gov or 360-705-6741 to obtain a business registration. If the Contractor does not believe it is required to obtain a business registration, it may contact the City's Taxes and Licenses Division at (509) 625-6070 to request an exemption status determination.

9. SOCIAL EQUITY REQUIREMENTS / NON-DISCRIMINATION.

No individual shall be excluded from participation in, denied the benefit of, subjected to discrimination under, or denied employment in the administration of or in connection with this Contract because of age, sex, race, color, religion, creed, marital status, familial status, sexual orientation including gender expression or gender identity, national origin, honorably discharged veteran or military status, the presence of any sensory, mental or physical disability, or use of a

service animal by a person with disabilities. The Contractor agrees to comply with, and to require that all subcontractors comply with, federal, state and local nondiscrimination laws, including but not limited to: the Civil Rights Act of 1964, the Rehabilitation Act of 1973, the Age Discrimination in Employment Act, and the American's With Disabilities Act, to the extent those laws are applicable.

10. DEBARMENT AND SUSPENSION.

The Contractor has provided its certification that it is in compliance with and shall not contract with individuals or organizations which are debarred, suspended, or otherwise excluded from or ineligible from participation in Federal Assistance Programs under Executive Order 12549 and "Debarment and Suspension", codified at 29 CFR part 98.

11. AUDIT.

The Contractor and its sub-contractor shall maintain for a minimum of three (3) years following final payment all records related to its performance of the Contract. The Contractor and its sub-contractors shall provide access to authorized City representatives, at reasonable times and in a reasonable manner to inspect and copy any such record. In the event of conflict between this provision and related auditing provisions required under federal law applicable to the Contract, the federal law shall prevail.

12. ASSIGNMENT AND SUBCONTRACTING.

The Contractor shall not assign or subcontract its obligations under this Contract without the City's written consent, which may be granted or withheld in the City's sole discretion. Any subcontract made by the Contractor shall incorporate by reference this Contract, except as otherwise provided. The Contractor shall ensure that all subcontractors comply with the obligations and requirements of the subcontract. The City's consent to any assignment or subcontract does not release the Contractor from liability or any obligation within this Contract, whether before or after City consent, assignment or subcontract.

13. STANDARD OF PERFORMANCE.

The standard of performance applicable to Contractor's services will be the degree of skill and diligence normally employed by professional company performing the same or similar services at the time the services under this Contract are performed.

14. OWNERSHIP AND USE OF RECORDS AND DOCUMENTS.

Original documents, drawings, designs, reports, or any other records developed or created under this Contract shall belong to and become the property of the City. All records submitted by the City to the Contractor shall be safeguarded by the Contractor. The Contractor shall make such data, documents and files available to the City upon the City's request. If the City's use of the Contractor's records or data is not related to this project, it shall be without liability or legal exposure to the Contractor.

Under Washington State Law (reference RCW Chapter 42.56, the *Public Records Act* [PRA]) all materials received or created by the City of Spokane are *public records* and are available to the public for viewing via the City Clerk's Records (online) or a valid Public Records Request (PRR).

15. ANTI KICK-BACK.

No officer or employee of the City of Spokane, having the power or duty to perform an official act or action related to this Contract shall have or acquire any interest in the Contract, or have

solicited, accepted or granted a present or future gift, favor, service or other thing of value from or to any person involved in this Contract.

16. MISCELLANEOUS PROVISIONS.

- A. **Amendments/Modifications**: This Contract may be modified by the City in writing when necessary, and no modification or Amendment of this Contract shall be effective unless signed by an authorized representative of each of the parties hereto.
- B. The Contractor, at no expense to the City, shall comply with all laws of the United States and Washington, the Charter and ordinances of the City of Spokane; and rules, regulations, orders and directives of their administrative agencies and officers. Without limiting the generality of this paragraph, the Contractor shall comply with the requirements of this Section.
- C. This Contract shall be construed and interpreted under the laws of Washington. The venue of any action brought shall be in a court of competent jurisdiction, located in Spokane County, Washington.
- D. **Captions**: The titles of sections or subsections are for convenience only and do not define or limit the contents.
- E. **Severability**: If any term or provision is determined by a court of competent jurisdiction to be invalid or unenforceable, the remainder of this Contract shall not be affected, and each term and provision shall be valid and enforceable to the fullest extent permitted by law.
- F. **Waiver**: No covenant, term or condition or the breach shall be deemed waived, except by written consent of the party against whom the waiver is claimed, and any waiver of the breach of any covenant, term or condition shall not be deemed a waiver of any preceding or succeeding breach of the same or any other covenant, term of condition. Neither the acceptance by the City of any performance by the Contractor after the time the same shall have become due nor payment to the Contractor for any portion of the Work shall constitute a waiver by the City of the breach or default of any covenant, term or condition unless otherwise expressly agreed to by the City in writing.
- G. **Entire Contract**: This document along with any exhibits and all attachments, and subsequently issued addenda, comprises the entire Contract between the City and the Contractor. If conflict occurs between Contract documents and applicable laws, codes, ordinances or regulations, the most stringent or legally binding requirement shall govern and be considered a part of this Contract to afford the City the maximum benefits.
- H. **No personal liability**: No officer, agent or authorized employee of the City shall be personally responsible for any liability arising under this Contract, whether expressed or implied, nor for any statement or representation made or in any connection with this Contract.

IN WITNESS WHEREOF, in consideration of the terms, conditions and covenants contained, or attached and incorporated and made a part, the parties have executed this Contract by having legally-binding representatives affix their signatures below.
