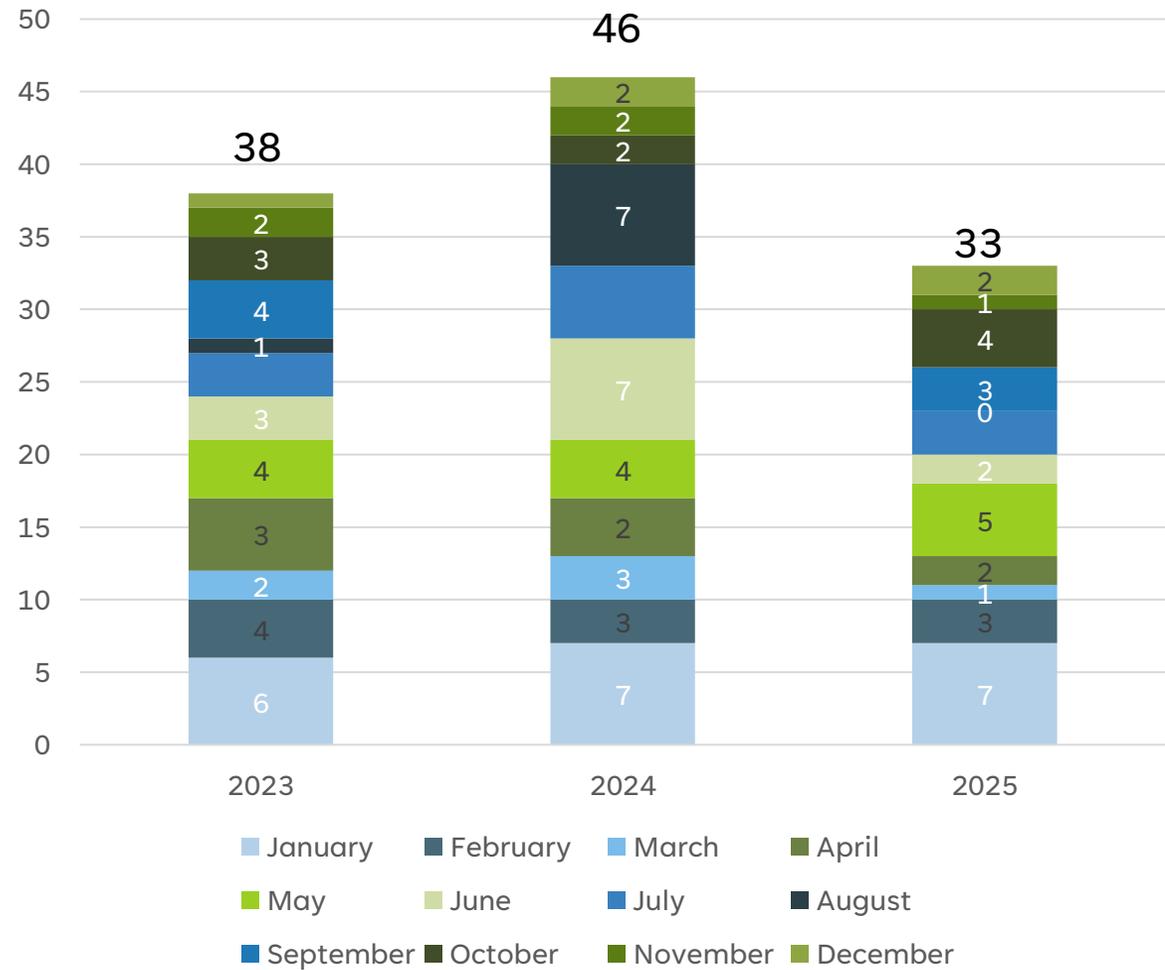

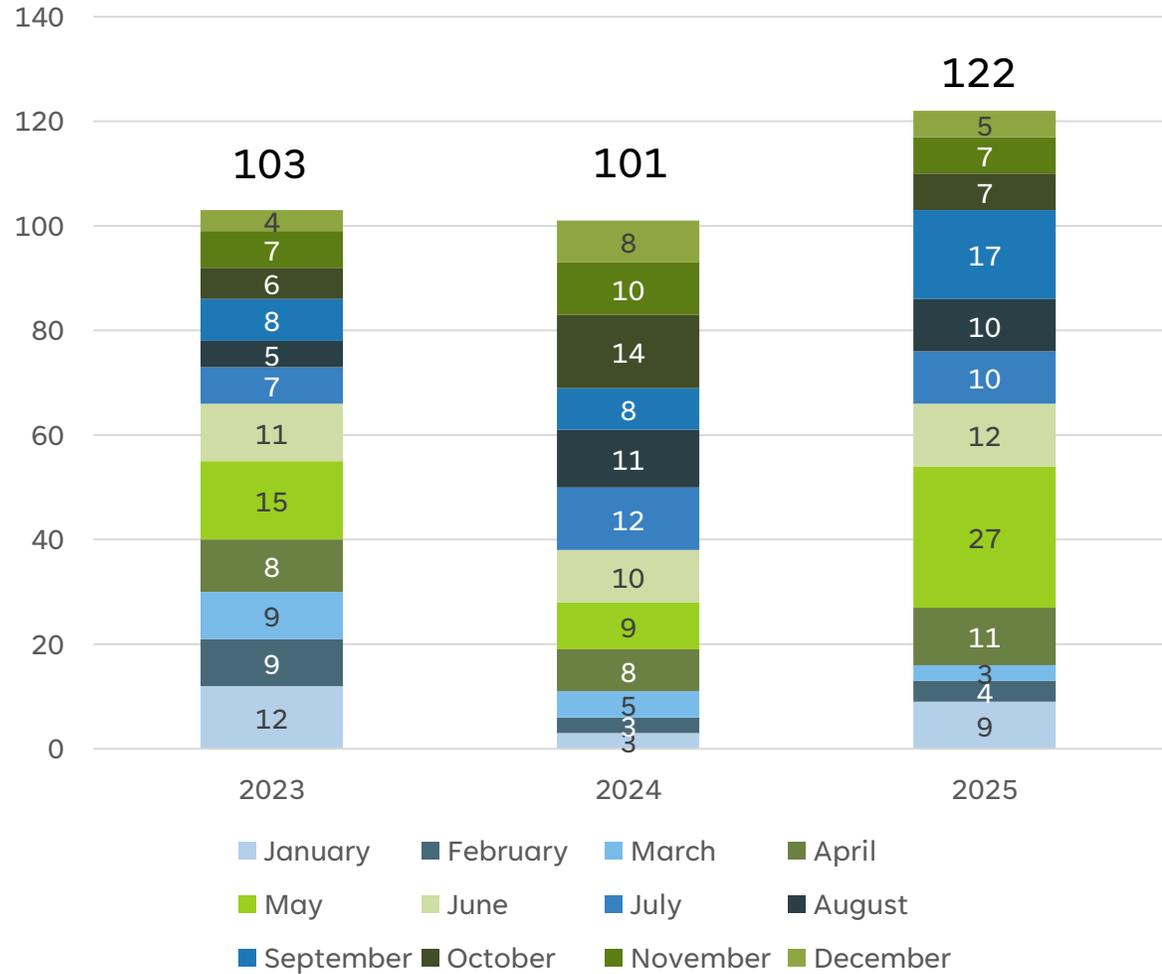
**SHOOTING CALLS FOR SERVICE WITH AT LEAST ONE VICTIM INJURY

GUN VIOLENCE REDUCTION PLAN COMPONENTS

SPD's gun violence reduction plan prioritizes a comprehensive and coordinated response that alters the underlying dynamics of violence to make lasting changes within the community.

- Leverage Data

 - RMS and CAD transition

 - SPD personnel

911 CALL RESPONSE TIMES

National response times are difficult to estimate. One sample of 13 agencies with publicly available response time data shows the average response time in mid-year 2025 was:

39.3 minutes

SPD's average time between dispatch's final call type and officer on scene in 2025:

- Priority 1: **4.8 minutes**
- Priority 2: **14.2 minutes**
- Priority 3: **41.9 minutes**

Overall SPD average: 28.4 minutes

DOWNTOWN HIGH UTILIZER PROGRAM

- Implemented in October 2025
 - 6-month pilot program
- Focused, intensive, and coordinated wraparound services and case management
- Citywide partnerships
 - Consistent Care, Pioneer, Spokane County Jail Mental Health Services, prosecutors and defense attorneys, and other public health partners

DOWNTOWN HIGH UTILIZER PROGRAM: DEC 30 SNAPSHOT

- 7 participants were in jail
 - 3 refusing services
 - 3 receiving treatment
 - 1 receiving social services only
- 4 were receiving treatment (not in jail)
- 6 were not in custody
 - 4 receiving treatment
 - 2 location unknown or uncooperative

*Note: These statistics are a point-in-time snapshot of participants on December 30, 2025. The numbers change regularly as participants' statuses change.

LAW ENFORCEMENT TRAINING AND COMMUNITY SAFETY ACT (LETCSA)

- State-mandated training requirements
 - Patrol Tactics
 - The Historical Intersection of Race and Policing
 - Alternatives to Booking
 - Implicit and Explicit Bias
 - Understanding Local Cultures
- Additional 24 hours of in-service training and 16 hours of online training

LAW ENFORCEMENT TRAINING AND COMMUNITY SAFETY ACT (LETCSA)

- Increase in-service training days from **3** to **8** in 2026
 - Spring In-Service: classroom training, legal updates, DT, and firearms.
 - Middle In-Service: tactics, active shooter, scenarios, vehicle close quarters interactions. Next year is EVOC/PIT/Pinning.
 - Fall In-Service: classroom training, UOF policy update, recertification of less lethal weapons, and firearms.
 - LECTSA/ICAT: This one-week training will encompass three days of patrol tactics, one day of ICAT, and one day of scenario training.

DIALOGUE TEAM 2025

- TAC Team responded to over 50 events (protests/demonstrations, Hoopfest, Pig Out in the Park, parades, etc.)
- Dialogue deployed at 16 demonstrations
- Consistent communication with 12 organizations
- 13 email/voicemail commendations
 - *“I wanted to reach out to give a big thank you to the Spokane police present at today's protest... They exemplified professionalism and integrity, not showing support for either side. We expect this kind of behavior and we saw it today.”*

2025 WELLNESS GRANTS AWARDED

- \$30,000 CJTC Wellness grant
 - 3 Struggle Well courses
 - 12 registrations for the 1st Responder Conference
 - Training for supervisors
- 2-year federal grant for \$186,250
 - Voluntary, confidential mental health checkups for any SPD employee who wants to participate
 - Three Struggle Well Posttraumatic Growth classes
 - Training in sleep
 - Training in nutrition
 - Training in breathing and mindfulness
 - Training in financial wellness
 - Wellness material

2025 RECRUITMENT AND RETENTION

- Hired 24 officers in 2025
 - All still employed
- Lost 9 officers in 2025
 - 8 voluntary resignations
 - 4 were new hires on probation
 - 2 left for other opportunities
 - 2 left during IA investigations
 - 1 retirement
- Hired 41 people total, lost 20 people
 - 13 voluntary resignations, 4 retirements, 2 layoffs, 1 failed probation

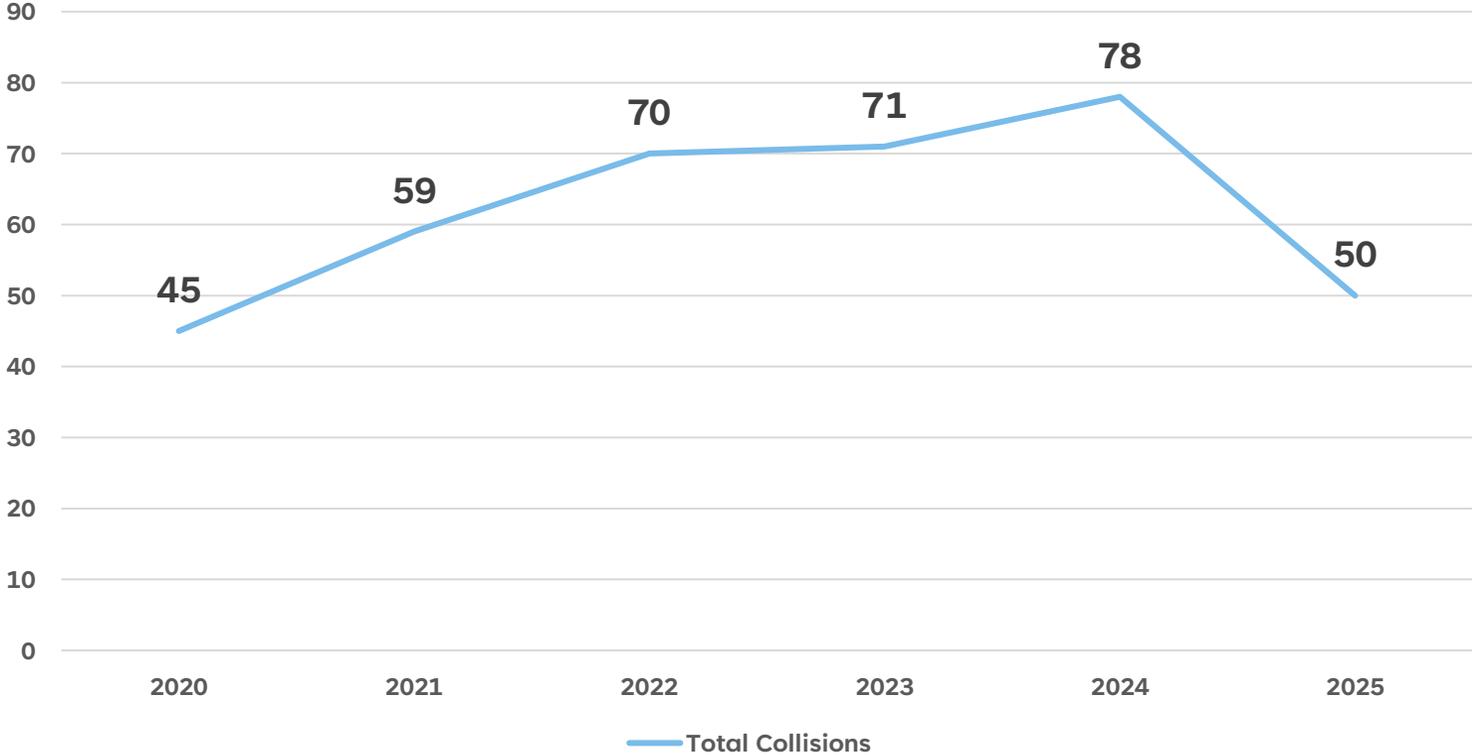

Total Collisions

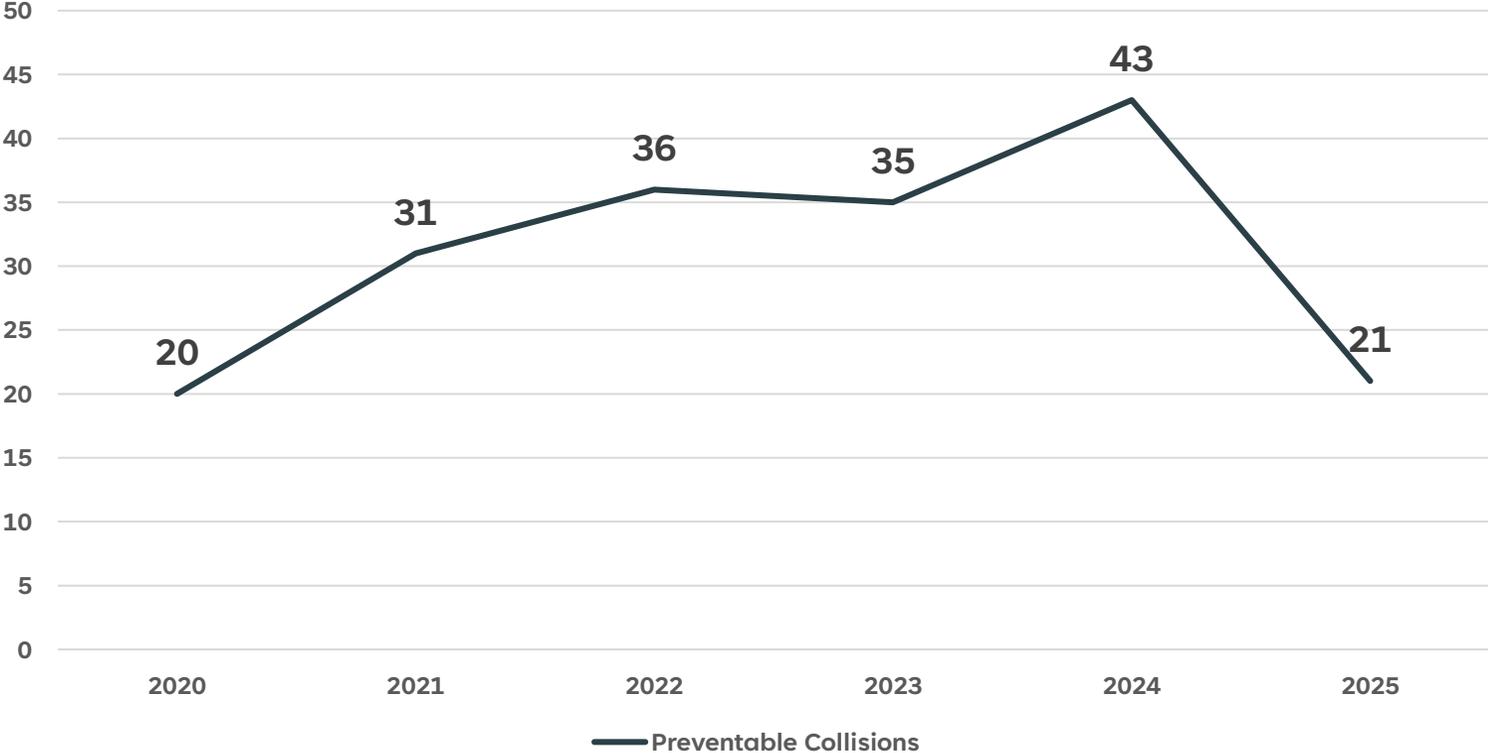


-35.9% from 2024.

Preventable Collisions



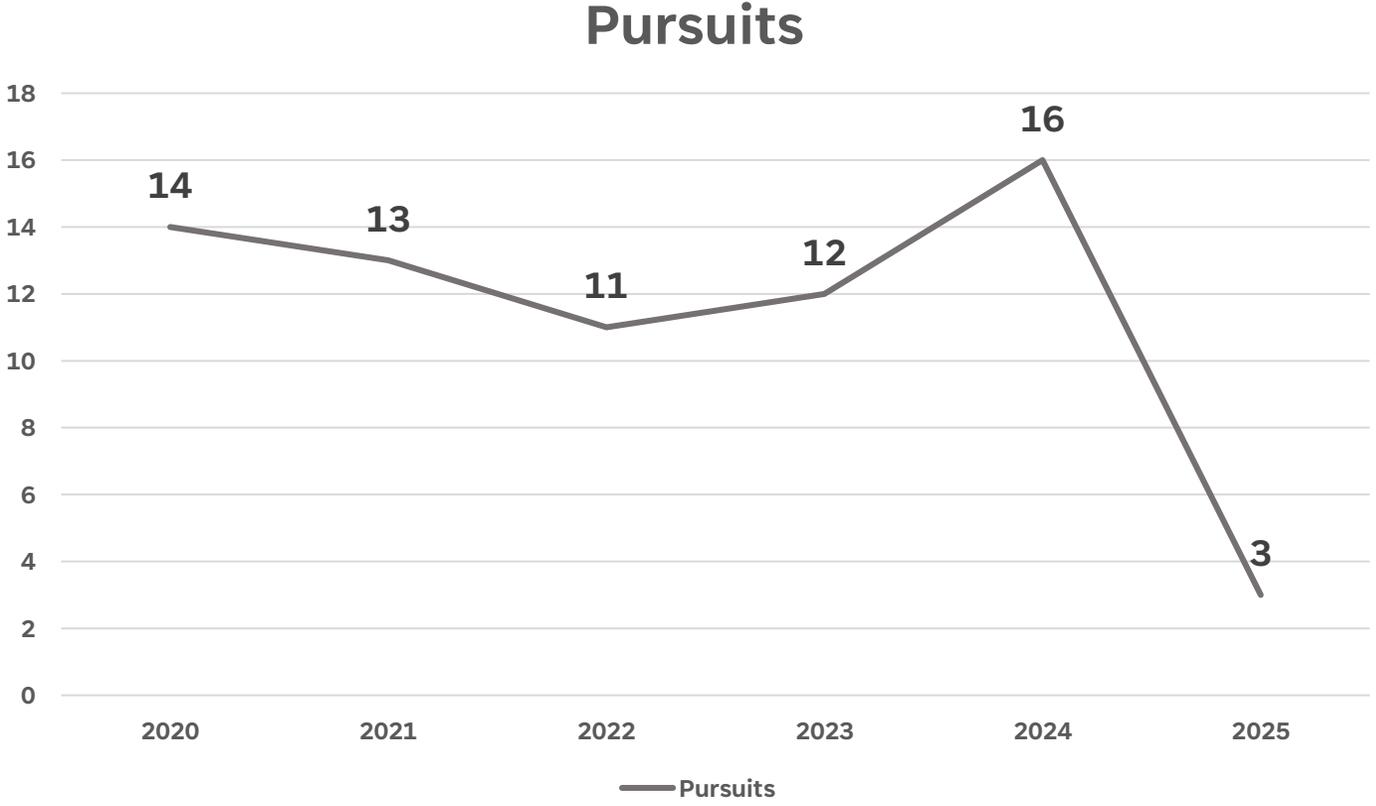
-51.2% from 2024.

2025 USE OF FORCE TRENDS: PURSUITS

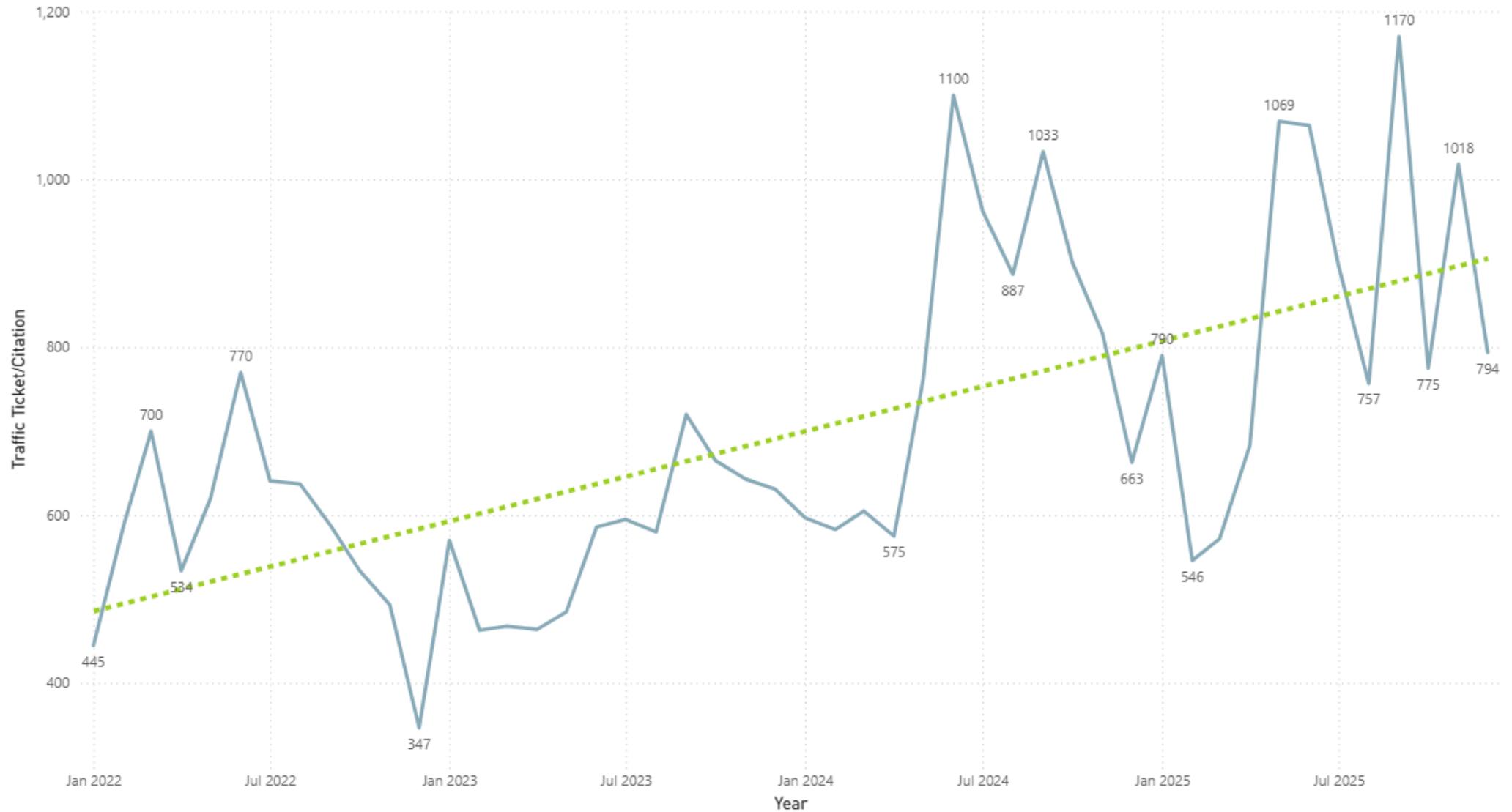
Decreased from 16 in 2024 to 3 in 2025.

5-year average (2020-2024) was 13.2 per year.



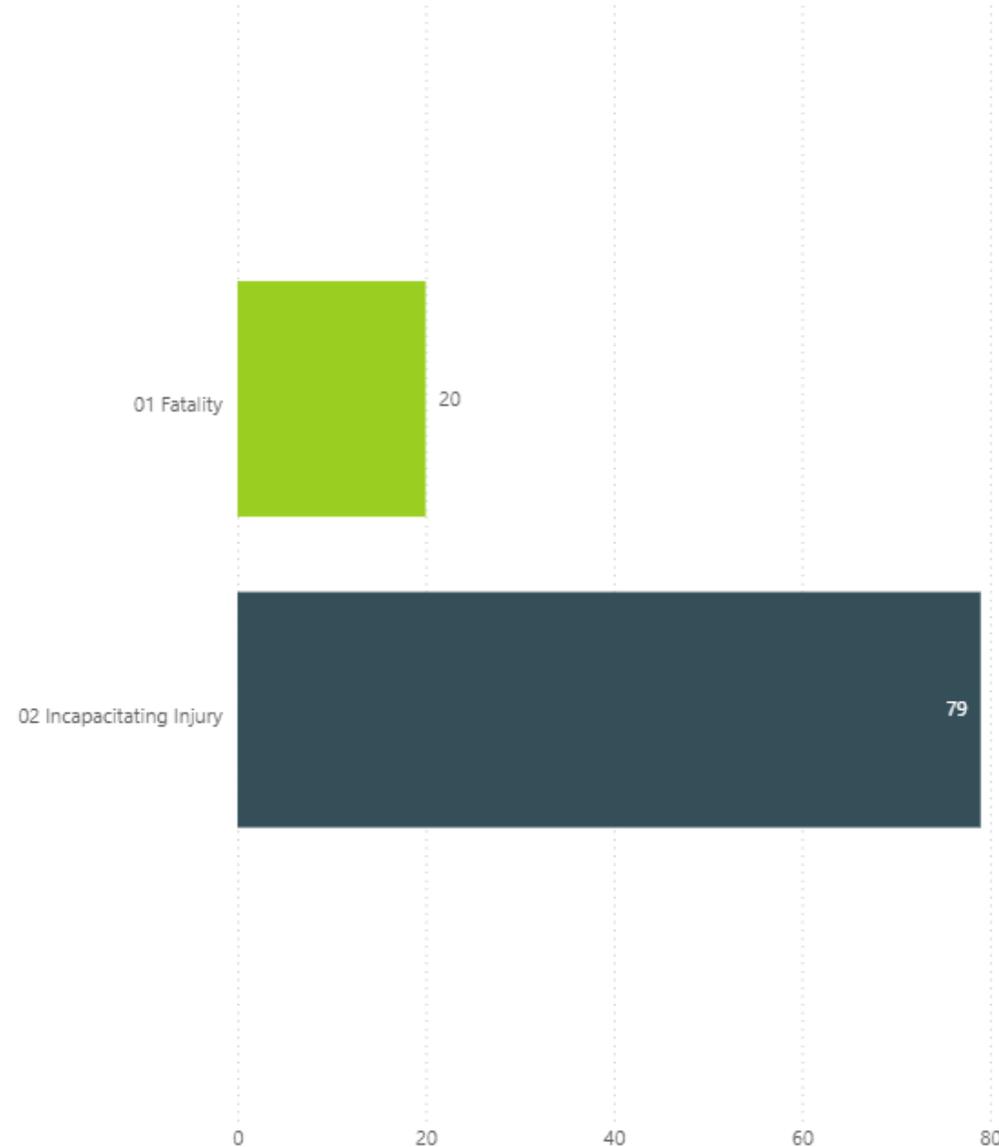
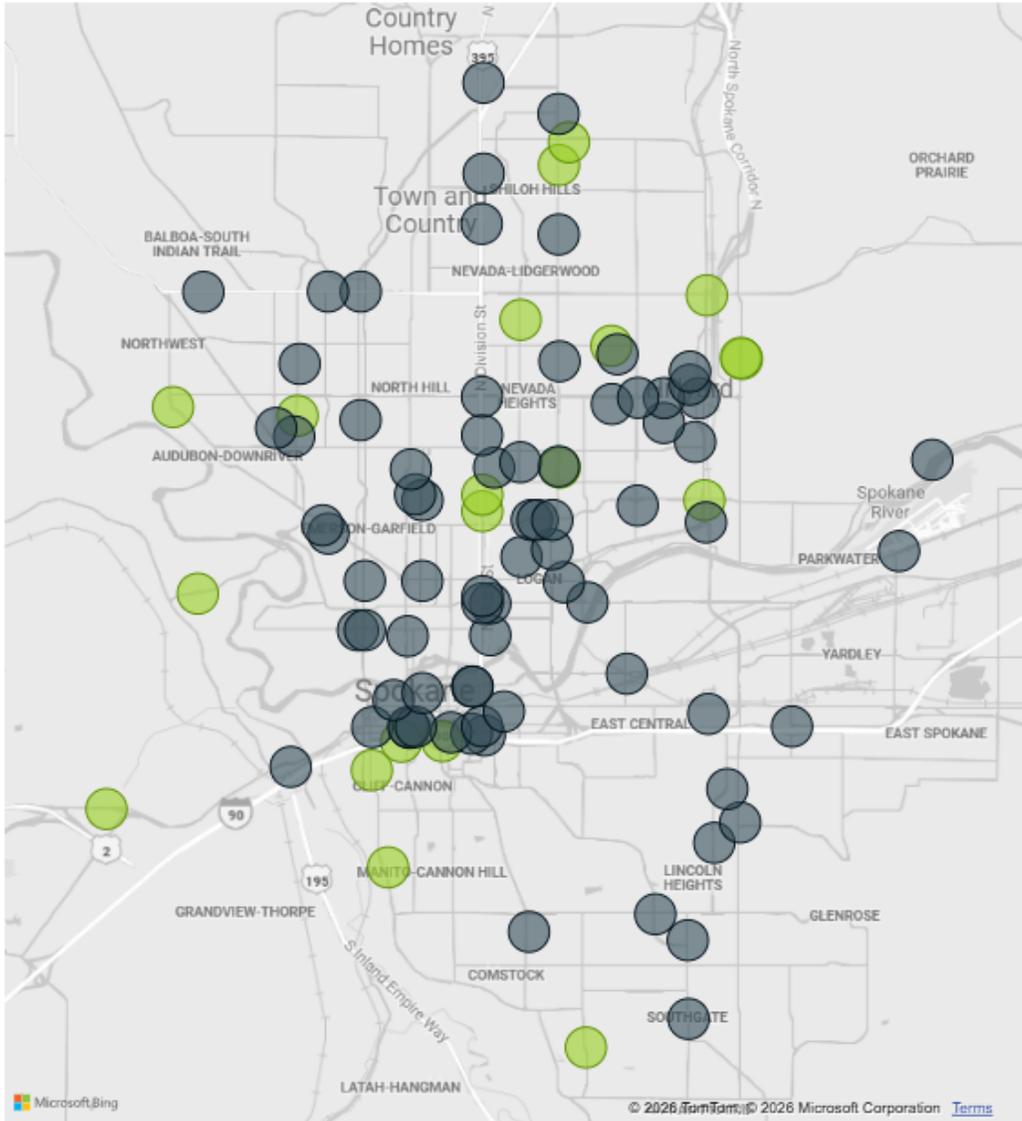
TRAFFIC CITATIONS AND INFRACTIONS JANUARY 2022 THROUGH DECEMBER 2025

There were 20 fatal collisions last year, and 79 collisions with an incapacitating injury.

4.8% decrease in serious collisions from 2024.

Collisions include those reported to SPD. Collisions reported to Washington State Patrol are not included in our data.



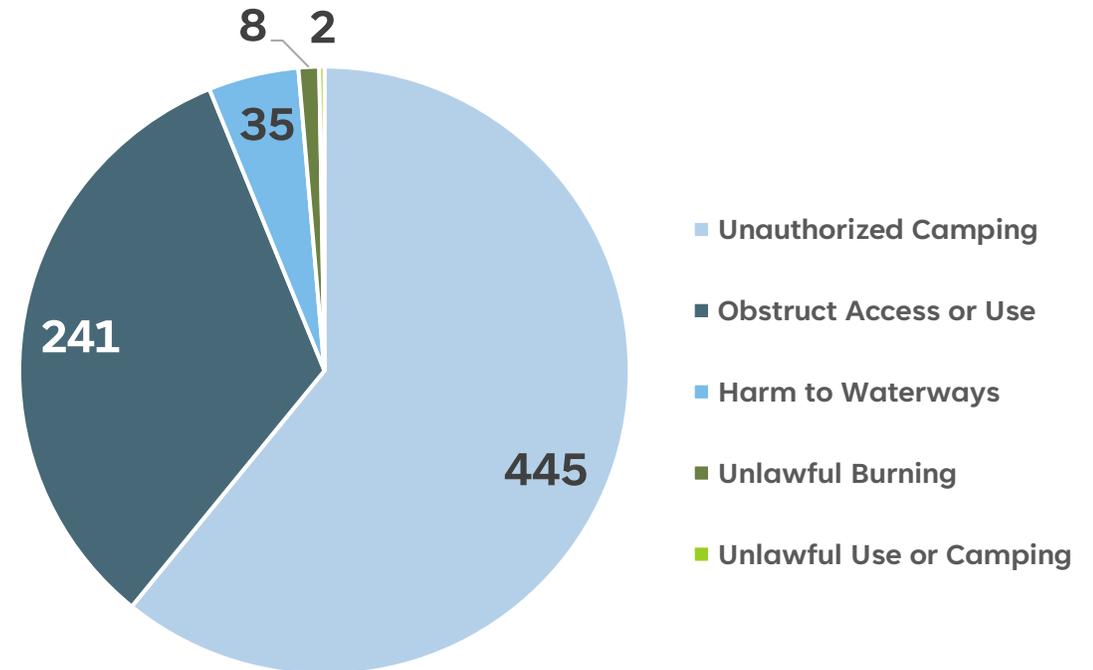

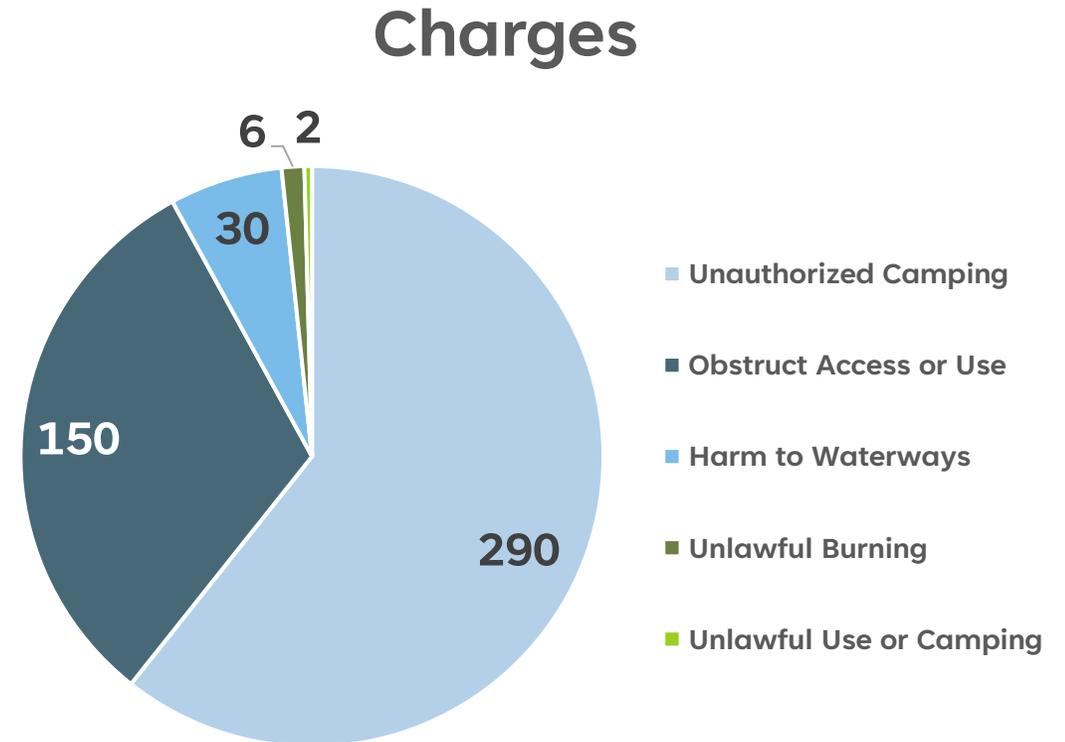

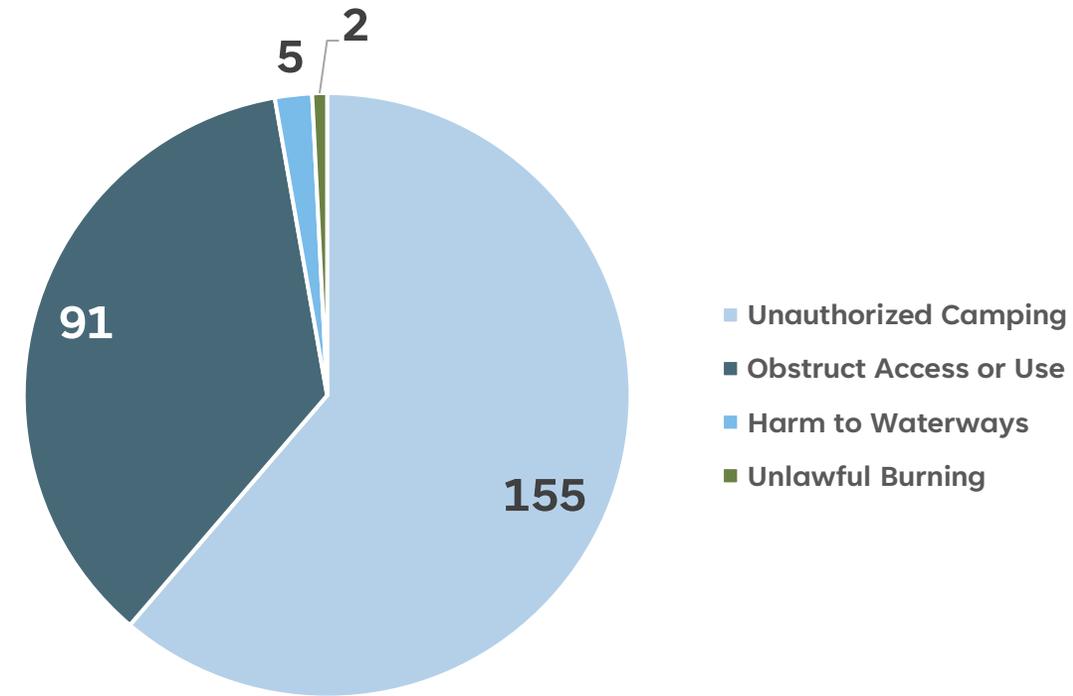
