The meeting began at 4:01 PM.

- 1. Welcome and Introductions Introductions were made. No action was taken.
- 2. Approval of Meeting Minutes June minutes were discussed. Minutes were approved as drafted (M: Mr. Iannelli, S: Ms. Papenleur, 5:0:2).
- Welcome New Members & Officer Elections Ms. Papenleur nominated Mr. Iannelli for Chair (S: Ms. Wilber). Mr. Ianelli was elected by unanimous vote. Ms. Marlin nominated Ms. Lawrence for Vice-Chair (S: Ms. Wilber). Ms. Lawrence was elected by unanimous vote. At the conclusion of voting, Mr. Iannelli took over his duties as Chair.
- 4. **Presentation and Proposal by LB Stone** Mr. Freibott conveyed to the Committee Mr. Czapla's apologies for a late conflict preventing his attendance. The item is expected on the next meeting agenda. No actions were taken.
- 5. **Status Update on West Central Project** Ms. Wende, in her capacity as project consultant, gave an update on the project to the Committee and answered questions. No actions were taken.
- 6. General Notices for NPAC Members Mr. Freibott updated the Committee on business matters, such as the need to complete OPMA/Records training and the need for each committee member to receive and utilize a City of Spokane email account for all Committee business. Mr. Freibott is to follow up with members directly on email account creation and access. No actions were taken.
