West Quadrant TIF Neighborhood Project Advisory Committee Meeting Minutes

October 1, 2025

Committee Members Present: EJ Iannelli (Chair), Liz Marlin, Fran Papenleur, Wende Wilber **Absent:** Kimberly Lawrence (Vice-Chair), Alan Chatham, Amanda Richardson

Staff Present: Kevin Freibott (Planning & Economic Development)

The meeting began at 4:01 PM.

- 1. Welcome and Introductions Introductions were made. No action was taken.
- 2. **Approval of Meeting Minutes** August minutes were discussed. Minutes were approved as drafted (M: M. Papenleur, S: M. Wilber, passed 3 to 0 with 1 abstention).
- 3. **Broadway Foods/Laundromat** A new request was presented, including public improvements installed as part of the Broadway Foods & Broadway Laundromat projects. A presentation was given by the project proponents, followed a question an answer period. The presented request was for \$174,714 in TIF funds. M. Freibott was asked to coordinate with the requestor on additional expenses that might qualify for TIF funding. Item was postponed to a future meeting with no other action.
- 4. **Broadway & Nettleton Street Crossing** Related to item 3, the crossing at Broadway & Nettleton was discussed, including the provisions in the West Central Infrastructure Study for improvements to that intersection. M. Wilber mentioned that design of improvements to that intersection are underway with Integrated Capital Management. Item was postponed to a future meeting with no other action.
- 5. **Open Forum** M. Freibott mentioned that OPMA training is once again due for all commission members. M. Freibott will send out instructions to the Committee.

The meeting was adjourned by the Chair at 5:00 PM.
