PROPOSED STREET VACATION**

A Resolution has been adopted by the City Council of the City of Spokane, Washington, on January 3, 2022, in the matter of the proposed vacation of:

The alley between Pacific Avenue and 2nd Avenue, from the east line of Sherman Street to the west line of Sheridan Street.

The City Council has set the time and place for Hearing on said proposed vacation for Monday, February 7, 2022, at 6:00 p.m.

Further information on the street vacation may be obtained from the City of Spokane Department of Engineering Services, 808 West Spokane Falls Boulevard, Spokane, Washington 99201, (509) 625-6700.

Pursuant to Governor Jay Inslee's Fifteenth Revised Proclamation 20-28.15, dated January 19, 2021, all public meetings subject to the Open Public Meetings Act, Chapter 42.30 RCW, are to be held remotely with the option of an in-person component. While all public meetings must continue to be held remotely, an option for an additional in-person meeting component is permitted in Phase 3 regions consistent with the business meetings requirements contained in the Miscellaneous Venues guidance incorporated into Proclamation 20-25, et seq. At this time, the City Council has decided to continue its meetings with remote access only and to not include an in-person attendance component. However, as the October 25 hearing date approaches, there is the possibility that an in-person component may occur. A notice containing call-in information will be included with the posted February 7, 2022, City Council Agenda packet. 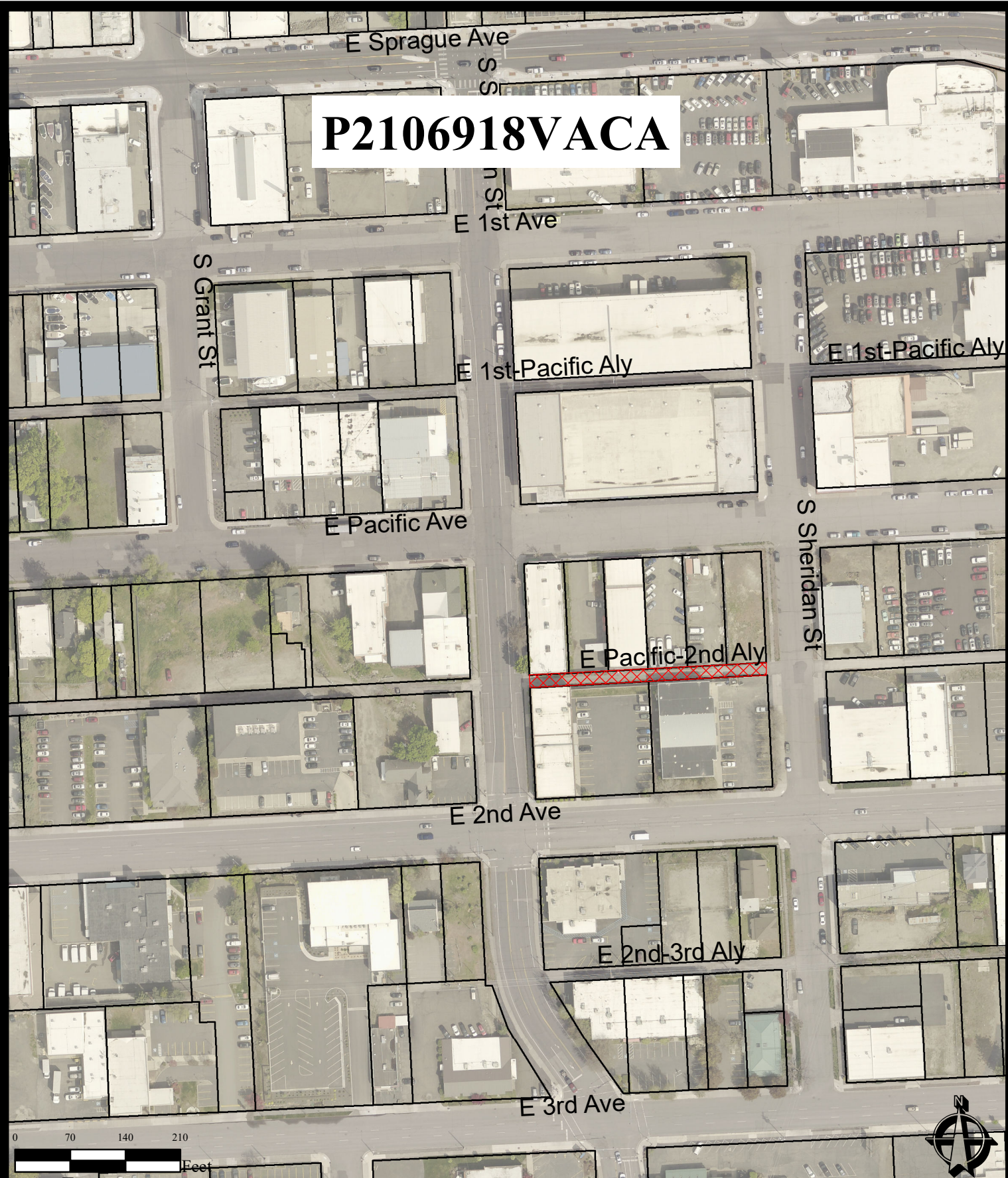
