



- 1. CONTRACTOR TO VERIFY LOCATION OF ALL UTILITIES PRIOR TO INITIATION OF ANY DEMOLITION OR CONSTRUCTION OPERATIONS. ANY DAMAGE TO EXISTING UTILITIES ON SITE OR ADJACENT PROPERTY SHALL BE CONTRACTOR'S RESPONSIBILITY.
- 2. ALL PLANT MATERIAL SHALL CONFORM TO THE LATEST EDITION OF AMERICAN ASSOCIATION OF NURSERYMAN'S; AMERICAN STANDARD FOR NURSERY STOCK, ANSI Z60.1-1990
- 3. ALL PLANT MATERIAL SHALL BE INSTALLED AS PER DETAILS AND CONTRACT SPECIFICATIONS. 4. CONTRACTOR SHALL COORDINATE PLANTING WITH IRRIGATION CONTRACTOR TO AVOID CONFLICTS
- BETWEEN HEAD PLACEMENT AND PLANTINGS. 5. NO SUBSTITUTIONS WILL BE ALLOWED WITHOUT THE WRITTEN CONSENT OF THE OWNER/LANDSCAPE
- 6. ALL TURF AREAS EXCEPT FOR SPORTS FIELD TURF AREAS SHALL RECEIVE (4") OF TOPSOIL. ALL PLANTING BEDS SHALL RECEIVE (12") OF TOPSOIL. TOPSOIL SHALL CONSIST OF 75% EXISTING SANDY LOAM SOIL AND 25% OF EKO COMPOST, OR APPROVED EQUAL, THAT HAS BEEN THOROUGHLY MIXED. ROCKS 1" AND LARGER SHALL BE REMOVED FROM TOPSOIL. ALL ROCKS AND DEBRIS ON THE SURFACE OF LANDSCAPE AREAS THAT
- ARE 1" AND LARGER SHALL BE REMOVED. 6. ALL SPORTS FIELD TURF AREAS SHALL RECEIVE (12") OF TOPSOIL. TOPSOIL SHALL CONSIST OF EXISTING SAND TOPSOIL THAT HAS BEEN SELECTIVELY HARVESTED FROM THE SITE AND EVALUATED FOR COMPLIANCE WITH THE USGA SAND BASED SPORTS REQUIREMENTS. IF ONSITE SAND SOILS DO NOT MEET USGA REQUIREMENTS, THE CONCTRACTOR SHALL HAVE TESTING LAB RECOMMEND RATIO OF MIXING EXISTING
- SAND SOILS WITH COMPLIANT SAND SOILS TO CREATE USGA COMPLIANT SAND TOPSOIL, OR CONTRACTOR SHALL IMPORT COMPLIANT SAND SOILS. ROCKS 1" AND LARGER SHALL BE REMOVED FROM TOPSOIL. ALL ROCKS AND DEBRIS ON THE SURFACE OF LANDSCAPE AREAS THAT ARE 1" AND LARGER SHALL BE REMOVED. 7. ALL SHRUB BEDS SHALL HAVE A MIN. OF 3" DEPTH OF 5/8" MINUS CRUSHED BASALT TOPDRESSING INSTALLED
- AT SURFACE. TREAT TOPDRESSING WITH PRE EMERGENT, SURFLAN PRO OR APPROVED EQUAL, PER 8. SHRUB BED EDGING SHALL BE A CONCRETE MOWSTRIP. IT SHALL SEPARATE ALL TURF AREAS FROM
- 9. FINISH GRADE OF SHRUB BEDS AFTER INSTALLATION OF MULCH SHALL BE WITHIN 1" OF TOP OF CURBS, SIDEWALKS AND SURROUNDING HARDSCAPE. 10. ALL PLANTS AND PLANT STAKES SHALL BE SET PLUMB UNLESS OTHERWISE NOTED.
- 11. ALL ROOT WRAPPING MATERIAL MADE OF SYNTHETICS SHALL BE REMOVED AT THE TIME OF PLANTING. 12. NO BARE ROOT STOCK SHALL BE USED UNLESS OTHERWISE NOTED IN CONTRACT DOCUMENTS.

- 13. CONTRACTOR IS RESPONSIBLE FOR LOCATING PROPERTY LINE AND WORKING WITHIN THE PROPERTY 14. APPLY TO ALL SHRUB BEDS - 'BIOSTIMULANT FERTILIZER': 'ROOTS' TRANSPLANT 1-STEP DRY AS
- MANUFACTURED BY ROOTS, INC. (203) 786-5295, OR APPROVED EQUAL. APPLY AT MANUFACTURER'S RECOMMENDED RATES AND DIRECTION. 15. APPLY SCOTTS AGRIFORM 20-10-5 21 GRAM PLANTING TABLETS AT THE FOLLOWING RATES FOR ALL TREES AND SHRUBS/ORNAMENTAL GRASS: TREES - 4 TABS; SHRUBS/ORNAMENTALS - 1&2 GAL - 2 TABS, 5 GAL -3 TABS. BACKFILL PLANTING HOLE HALFWAY THEN EQUALLY SPACE TABLETS AROUND ROOT BALL,
- APPROXIMATELY 1" AWAY FROM ROOTBALL. COMPLETE BACKFILL. 16. TURF ESTABLISHMENT PERIOD SHALL CONSIST OF THE FOLLOWING: (1) AGRONOMIC SOILS TEST - TEST LOCATIONS SHALL BE OBTAINED FROM TOPSOIL IN APPROXIMATE LAWN
- (3) THREE FERTILIZER APPLICATIONS FERTILIZER SHALL BE DEFINED BY THE RECOMMENDATIONS FROM THE SOILS TEST LAB. CONTRACTOR SHALL SUBMIT TEST RESULT AND FERTILIZER CUTSHEETS FOR APPROVAL. APPLICATIONS SHALL OCCUR AT:
- 1 MONTH AFTER PLANTING RATE SHALL BE 7.5 LBS PER 1,000 SQ FT 2 MONTHS AFTER PLANTING - RATE SHALL BE 7.5 LBS PER 1,000 SQ FT CONTRACTOR SHALL MAINTAIN GRASS UNTIL IT IS UNIFORMLY KNITTED INTO TOPSOIL OR FINAL COMPLETION IS ACHIEVED, WHICHEVER IS LATEST. MAINTENANCE SHALL INCLUDE MOWING AND WEED CONTROL THROUGHOUT LAWN AND SHRUB BED AREAS. LANDSCAPE ARCHITECT AND OWNER SHALL APPROVE THE ESTABLISHMENT OF THE TURF AFTER ALL REQUIREMENTS ARE MET. CONTRACTOR SHALL
- THEN APPLY ONE FINAL BROADLEAF SPECIFIC HERBICIDE APPLICATION TO LAWN. 17. CONTRACTOR SHALL GUARANTEE ALL WORK, MATERIALS, AND PLANTS FOR A PERIOD OF ONE YEAR FROM

SCHEDULE AND PLAN, THE PLAN LOCATIONS SHALL DICTATE COUNT.

- RESULT OF CONSTRUCTION ACTIVITIES. 19. CONTRACTOR SHALL VERIFY ALL QUANTITIES. IN THE CASE OF A DISCREPANCY BETWEEN THE PLANT
