ALL FOR-HIRE DRIVERS

For-Hire Application

- Complete the attached application in full

City Business License

- Must have a current Washington State Business License WITH Spokane Endorsement (Taxes & Licenses staff can verify both are current.) www.bls.dor.wa.gov or apply in person Department of Revenue, Rock Pointe Office Building, 1330 N Washington Street, Suite 5600 (cash or check only)

Registration Fee

- Payment of \$55.00 must be made at the time of application (may be prorated)
- Cash, check, money order, debit, or credit card accepted

Driver's License

- Must be 20 years old or older, with 12 months driving history

2 Identical Color Photos (1½" x 1½" or 2" x 2")

- Passport photos (may be obtained from places like Rite Aid, Walmart, Costco, Walgreens, and the Post Office)
- OR obtained at Police Records in Spokane County Public Safety Building, behind courthouse (They will also do fingerprints; the cost is \$15. Closed Mondays)

UBER & LYFT ONLY:

Verification of affiliation from UBER and/or LYFT

- Printed email, app profile or pay statement from LYFT and/or UBER which includes your name.
(If you drive for both LYFT and UBER, you will need printed documentation from both.)

TAXI CAB DRIVER ONLY:

Background Check (dated within 30 days of application)

Background check providers must be audited and accredited by the *Background Screeners Certification Council of the National Association of Professional Background Screeners* and must include the following:

- Verification of the applicant's identity
- Multistate and multi-jurisdiction criminal records locator or other similar commercial nationwide database with validation of the applicant's past seven (7) years of criminal history
- Driving record

NOTE: Background check AND a driving record is to be completed by the same company. A list of accredited companies as well as a list of disqualifying convictions are available and may be emailed to you. We no longer use *WATCH* report or *Drivers Abstract* from the Dept. of Licensing.
