REQUIREMENT CHECK LIST

For-Hire Application (paper applicants only)

- ☐ Complete the attached application in full.

City Business License (all applicants)

- ☐ Must have a current Washington State Business License WITH Spokane Endorsement (Taxes & Licenses staff will verify both are current.) Apply online at www.dor.wa.gov. Call 360-705-6741 for online help.

Registration Fee (all applicants)

- ☐ \$55 per year. Expires 1 year from date of issuance.
- ☐ Cash, Credit/Debit Card, Check/Money Order (payable to City of Spokane)

Copy of Driver's License (turn in with paper application – online applicants will upload)

- ☐ Must be 20 years old or older, with 12 months driving history.

2 Identical Color Photos (paper application only, online applicants will upload one photo)

- ☐ White background only.
- ☐ Two 1½" x 1½" or 2" x 2" "selfie" photos, may be printed on paper. Do not use HP Photo Paper
- ☐ **OR** e-mail one digital photo to taxesandlicenses@spokanecity.org
- ☐ **OR** two passport photos (Places who issue: Rite Aid, Walmart, Costco, Post Office, etc.)

****NOTE****

- Paper applications and accompanying documents may either be mailed, e-mailed to taxesandlicenses@spokanecity.org or dropped off in person at Spokane City Hall, 808 W Spokane Falls Blvd.
- We no longer require proof of affiliation with a rideshare company
- We no longer require proof of background check for Taxicab drivers.
(The Taxi company will still require the background check, but we do not need a copy)
