## Helpful Hints for Completing this Application

The fees for services over 1,000 amps rise \$5.00 for every 100 amps (or fraction thereof). Similarly, the fee for wiring new construction increases every 100 sq. ft. Round up to the nearest 100 amps to calculate.

The square footage calculation method for wiring should only be used for new buildings or additions, but NOT existing structures. Please identify the number of circuits for all remodels to include finishing basements and wiring buildings that were just a shell.

Use the Alarm/Telecomm/Theatre/Sound Systems fee item for HVAC control systems and voice & data cabling. Single Family Residences are considered one zone, otherwise the fee is \$10 per zone, which can be factored as every 2,500 sq. ft. or fraction thereof.

Please enter the amperage of each generator and transformer individually in the Fee column. The fees work out to be similar to those for 600V or less services with it equaling the \$40 for the first 200 amps and going up \$10.00 for each additional 200 amps (or fraction thereof).

Generators of 50 KW or less will be considered equivalent to a 200 amp service.

The Annual Electrical Permit fee entitles the applicant to the number of inspections identified for a one year period beginning on the day the permit is issued.
