SWIMMING POOL PERMIT APPLICATION Submittal Guidelines

The following components shall be included with the application to be considered a complete submittal.

Site Plan

These are the minimum details required to be included on the site plan:

Property Address.

Property Lines and Dimensions.

Slope of Lot.

Location and Footprint of all Existing Buildings and Structures.

Pool Location and Dimensions.

Location and Dimensions of all Proposed Buildings and Structures. (Separate permits required)

Pool Heater Location and Size.

Distance from Pool to Property Lines and Structures and Equipment.

Location of all Utility Lines and Installed Electrical Lines with Clearances to the Pool.

Fence and Gate Location(s) and Height(s).

In-Ground Pool Plans and Construction Documents

These are the minimum details required to be included as applicable:

Dimensioned Plan View of Pool and Associated Equipment.

Footing/Foundation/Pool Wall Detail with Location of Reinforcement.

Whole Pool Cross Section with Dimensions.

Electrical and Mechanical Plans with 1-Line Electrical Diagram.

Distance between the Pool and the Electrical Shutoff.

Equipment Specification (Spec) Sheets.

Above-Ground Pool Plans and Construction Documents

These are the minimum details required to be included as applicable:

Pool Manufacturer Specification (Spec) Sheets.

Pool Manufacturer Installation Documents

Pool Drainage Plans

These are the minimum details required to be included as applicable:

Location and Method of Backflow Prevention. (For In-Ground Pools)

Location for Residential Pool Water to be De-Chlorinated and Drained On-Site.

Landscaping Details that document how the De-Chlorinated Drainage will be kept On-Site.

NOTE: Drainage to sewer is not authorized.

Barrier Details

These are the minimum details required to be included as applicable:

Fence Panel Elevation Detail. (No fence openings greater than 4 inches.)

Detail of the Self-Closing/Self-Latching Mechanism for the Gate.

Identify height above grade, distance from top of gate, and indicate location will be the pool side of the gate.

Pool Safety Cover Spec Sheet identifying ASTM F1346 listing and labeling.

Window Alarm Spec Sheet documenting listing and labeling in accordance with UL 2017.
