A Solar Energy Permit submittal must contain the following components to be considered a complete submittal. Please review the EDR Electronic File Standards for document parameters and naming conventions.

	Solar Panel Layout o Photovoltaic (PV) system configuration o Dimensions of required pathways and setbacks from ridge
	 Manufacturer's Installation Instructions and Specifications Design criteria – Identify the design codes (IBC/IFC/IRC/NEC) and allowable wind and snow levels UL listings of PV panels, modules, inverters, and energy storage systems (ESS) Fire classifications Attachment methods/mounting system Dead load calculations for the combined weight of all modules, supports, mountings, raceways, etc. per square foot Point load calculations Calculations identifying the percent of PV panel roof coverage Mounting height above the roof surface
	Equipment Schedule with One-Line Diagram
	Washington State Licensed Engineer's Stamp as applicable
	Floor Plan with location of ESS as applicable
	Must follow <u>EDR Electronic File Standards</u>
SITE PLAN	For the quickest review, Site Plans should be combined with the Plans (see submittal details above) as a single combined file. Must follow EDR Electronic FileStandards .
SUPPORTING DOCUMENTS	Supporting documents may include the following: • Engineering letter – as applicable • Manufacturer's Installation Instructions and Specifications • These can be combined as single PDF and included with the Plans

APPLICATION SUBMITTAL

- Application information shall be submitted along with the required submittal documents via our online permit system <u>Accela Citizen Access</u>.
- A separate Residential Building Permit is required for any structural or other building modifications being performed on any single-family residences, duplexes, or associated accessory structures.
- For commercial, industrial, and multi-family buildings, a separate Commercial Building Permit submittal is required in addition to the above submittal.
 Complete our <u>Commercial Building Permit Application</u> and send it along with PDFs of the required submittal documents to <u>PermitTeam@SpokaneCity.org</u>.
- All documents must be in compliance with the EDR Electronic File Standards.
