



Narrative regarding the Goodwill Reports for Reporting Period: July 1, 2024 - September 30, 2024

Grant OPR-2024-0758 (Homeless Prevention):

"We have faced some challenges with enrollment timelines due to the FCS pause, which has affected the speed of approval for new participants in the FCS program. Although the pause has been lifted, approvals still lagging in processing time.

In terms of our budget, we can currently support rent payments for about 7-8 participants per month. Due to contract-related billing delays, we're maintaining a conservative approach until we have a precise understanding of our expenditures. Once billing is updated and we have an accurate budget status, we'll be able to increase enrollments as needed. We currently have two additional participants pending transfer to the HEN FCS Bridge program for November/December as well."




