

## Community Development Block Grant (CDBG) 2024 Program Year Request for Proposals (RFP)

The City of Spokane Community Housing and Human Services Department (CHHS) is seeking proposals for the 2024 Community Development Block Grant (CDBG) Program Year (PY). CHHS will review applications and provide information to the CHHS Board; who will review all applications and will hold a Public Hearing for the purpose of making a recommendation to the Spokane City Council.

Proposals must address a priority need for Public Services, Public Facilities, Senior Services, Services for Disabled, Services for Youth, and Micro Enterprise Assistance, (as contained in the 2020-2024 CDBG Consolidated Plan, 2024 CDBG Funding Policies, and 2024 PY RFP.) The 2024 CDBG RFP contains instructions, tentative timeline for the allocation process, the amount of anticipated funds available, and other information from the 2020-2024 City of Spokane Consolidated Plan.

Eligible applicants include non-profit agencies with 501(c) (3) designation who can demonstrate the capacity to carry out their proposal and ability to manage federal funds.
