## 2015 Contracting Update

- Terms and Conditions process on renewal grants.- 1 week to review and complete
- New Projects will need to complete Technical Submission- 1 week to review and complete
- City will generate new Match letters (except WA0118, WA0248-YWCA, CC-New PSH)
- Contracts from HUD / Contract with Agencies

## 2015 Competition De-Brief

CoC's received between 85% - 115% of Annual Renewal Demand (ARD) available based on application.

Spokane CoC received 109% ARD

Application Scored 174.25

Top Score for any CoC – 188 / Lowest Score- 49.5

Median Score- 149.75

## 2015 Competition De-Brief

### CoC's that did well:

- Reallocated lower performing projects (especially TH and SSO types)
- Used performance criteria to rate and rank projects
- Used Housing First practices
- Reduced homelessness in PIT

# Ranking

## **HUD's policy priorities:**

Strategic Resource Allocation. Each CoC must comprehensively review all existing projects within its geographic area, using CoC-approved scoring criteria and selection priorities, to determine the within extent to which each project is still necessary and addresses the listed policy priorities above. Funds for projects that are determined to be underperforming, obsolete, or ineffective should be reallocated to new projects that are based on proven or promising models.

## Reallocation

What type of project funds can be reallocated to is based on the NOFA.

## 2015 CoC allowable projects:

- New permanent supportive housing projects that serve chronically homeless individuals and families, including unaccompanied youth
- New rapid re-housing projects for homeless individuals and families, including unaccompanied youth, coming directly from the street or emergency shelter or fleeing domestic violence
- New projects for dedicated HMIS
- New supportive services only projects for centralized or coordinated assessment systems
