# **NEW AND UPCOMING ORDINANCES**

#### LGBTQIA2S+ Protections:

Relates to protection Spokane, ensures equitable protections, affirms the right to seek healthcare, that residents feel safe and supported in Spokane, and requires City provided health care to extend coverage for all healthcare services. The draft can be found on the April 28 Final <u>Agenda</u>.

#### **Cost Recovery:**

Relates to regular adjustment of fees, charges, and other assessments collected by the City of Spokane to ensure they reflect the actual cost of service delivery. The draft can be found on the April 28 Final Agenda.



#### **New Parks Levy:**

of Working together, representatives LGBTQIA2S+ communities in from City of Spokane Parks and Spokane Public Schools have developed the "Together Spokane" partnership, consisting of two separated but coordinated ballot measures intended to maximize investment in parks, schools and neighborhoods citywide at the least possible cost to local citizens.

# City Government: **DE-ICE, ICE, BABY**

KHQ produced a <u>story</u> based on the <u>May 12 draft agenda</u> regarding the amended purchase of Ice Kicker deicer for winter street maintenance operations. Here are some facts:

- There is not a difference between salt and deicer, all deicers are a salt. There are different kinds of salt magnesium chloride, calcium chloride, and sodium chloride are the most common kinds of salt used for deicer. Our change is moving more toward granular deicer from liquid deicer.
- Ice Kicker and liquid deicer products include a rust or corrosion inhibitor that makes it much more friendly on cars than salts without an inhibitor.
- The granular form of the deicer can be better for some conditions because it has more melting potential providing better results in a wider range of conditions than liquid deicer can.
- Liquid deicer is useful to put down before it freezes or snows and granular is useful for the top of snow and ice.
   Often those products are working together to melt from below and above, speeding up the melting process.
- All jurisdictions requiring winter maintenance use these products, this is nothing new. They just may look different depending on form and manufacturer.
- The City has been using the Ice Kicker product for over 7 years.
