

Interview Questions for District 2, Position 2 Spokane City Council Member Candidates

- Given that this is a four-month position, what are your specific priorities and what do you think you can accomplish during this time?
- What's your view of the separation of powers—not as theory, but in practice? Do you see the friction between branches as a flaw in the system, or a deliberate feature meant to guard against government overreach? Which is the greater threat to our democracy: occasional gridlock caused by strong checks and balances, or the slow erosion of those protections in the name of short-term political wins? And in today's climate of extreme partisanship, how will you handle the real-world pressure to toe the party line—even when it risks undermining sound policy, responsible governance, or the independence of the City Council itself?
- One of our main responsibilities is to approve the budget proposed by the Mayor and her Administration. Share your understanding of budgeting principles necessary to shape a good municipal budget. What, if anything, did we get wrong in our last budget and how should we correct that? What did we get right and how should we improve upon that?
- Community Workforce Agreements can help ensure larger construction projects are completed on time and on budget while emphasizing the need to hire workers historically excluded from construction. Would you support the Spokane City Council moving forward with a local Community Workforce Agreement for public works projects over \$5M?
- What hours will you be available to work with Council and attend important meetings? And how do you plan to use the City of Spokane's motto in your work?
- If there was one aspect of the City of Spokane that you could immediately change, what would it be and why? What is one aspect you would keep the same?
