**Important Notice to Tenants Facing Eviction**

**Have you been served with a pre-eviction notice for NONPAYMENT OF RENT?**

- Contact an organization below within 30 days of receiving the notice and apply for rental assistance
- IF you receive a Summons and Complaint for an eviction case, you *must* respond by the date to avoid a default eviction entered against you.

**If you are a tenant, you have the following rights:**

- Your landlord is required to give you **30 days** after serving you with a pre-eviction notice to apply for rental assistance *prior* to filing the eviction in court. You must apply ASAP.
- If/when your case is filed in court – you have the right to be represented by a free lawyer if you are a qualifying low-income renter
