The defendant states as follows:

- 1) I am the person named above. I agree that I have committed the infraction listed on the citation number shown above and ask the Court to defer entry of a finding that I committed the infraction.
- 2) I do not possess a commercial driver's license (CDL) and I did not receive the citation while operating a commercial vehicle.
- 3) I have not had another moving non-moving (check one) traffic infraction deferred by any court in the State of Washington within the past 7 years.
- 4) I understand that my citation may be deferred up to one year and may be conditioned upon payment of an administrative fee up to the amount of the citation penalty; and receiving no committed determinations for subsequent infractions.
- 5) I understand that upon compliance with all of the conditions imposed the infraction will be dismissed and no notice will be sent to the Department of Licensing.
- 6) I understand that if I fail to comply with any of the conditions imposed, the following will occur:
 - a) The administrative fee will be forfeited
 - b) I will be found committed of the charge
 - c) The original penalty will be imposed
 - d) I will receive notice of the payment terms
 - e) The Department of Licensing will be notified of the committed finding
