 - c. If admitted, the Defendant must schedule an alcohol/drug (needs) evaluation as soon as possible and submit the results to Travis Lindsley.
 - d. Schedule a CARS evaluation (risk) with Travis Lindsley.
 - e. If the Defendant qualifies as high risk/high needs, an Order Transferring the case to DUI Court will be entered and a hearing for the plea will be scheduled.
