- No owner or occupant of private property may deposit or accumulate, or permit the deposit or accumulation of, garbage upon his/her property.

A property with an accumulation of solid waste and refuse warrants a visit from a Code Enforcement Officer to persuade them to remove the solid waste.



Though the percentage of persons who immediately comply is quite high, often as much as 93%, it is still necessary to contact these potential violators to inform them of their civic responsibility to properly dispose of their debris.

- Remember: FORMS MUST BE SIGNED anonymous complaints not accepted, non-disclousure option available.

Complaint Process

- 1. Code Enforcement Officer will investigate the complaint.
- 2. If found to be a violation of the Spokane Municipal Code, a notice will be sent to the owner and occupant.
- 3. The violator will be given a chance to comply with the law.
- 4. If there is no compliance, a citation may be issued.
- 5. With the property owener's permission, the City of Spokane will clean the property at the cost of the owner.

Did You Receive A Notice Of Violation?

- You should clean your property promptly and dispose of the debris appropriately. Failure to do so will likely result in a citation of \$536.00.
- If you have mitigating circumstances, you should contact the officer provided on the notice ASAP.
