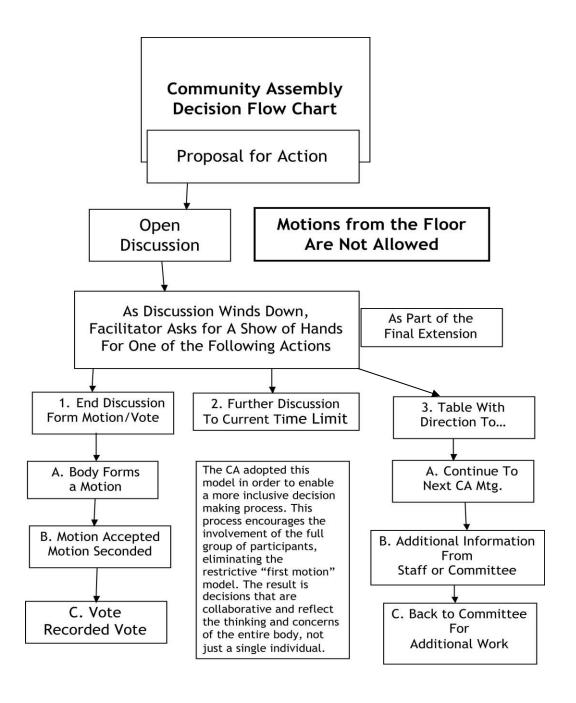

Meeting called to order at 5:30pm by Jennifer Cumbie

#### Attendance:

#### **Administrative:**

- 1. Introductions: The facilitator asked for all CA Reps to identify themselves and their NC in a poll for attendance and for permission to record the meeting for Gabby Ryan (CA Admin Committee Liaison) to provide accurate minutes. This request was approved, 13-approve, 3-deny, and 0-abstain.
- **2. Propose Agenda:** Mark Davies moved. Daniel Zapotocky seconded to approve the agenda. Motion passes with 13-approve, 0-deny, and 2-abstain.
- **3. August Minutes**: Mark Davies moved. Daniel Zapotocky seconded to approve the amended August minutes. Motion passes with 15-approve, 0-deny, and 4-abstain.

#### 4. Open Forum:

- Mary: Manito Cannon Hill concert at The Scoop from 6-8pm, Sept 7th. Abbey Crawford & Mardi Gras Growlers performing!
- Mark: Will we move to in-person meetings soon? Feels it's time to return to the practice of in-person.
- Fran: BSN Committee is reconvening this month on 9/26 from 12-1pm at Shadle Library or via Zoom

#### Legislative Agenda:

#### 5. Councilmember Wilkerson's Report:

- Matt Boston is the Budget Director for City Council. City Council is in the depths of 2023 budget planning, and will give a brief presentation (included in the packet). The presentation reviews the kinds of fund structures, and what feeds/takes away from the specific funds.
- Slides in the presentation also break down the allocation of the 2022 budget by the departments in the City.
- Question: What will you do about the 2022 Budget shortfall? No solid-set plan for addressing that. Budget shortfall will be driven under collective bargaining agreement between the employee union groups. We have an anticipated shortfall of \$20 million, we have unallocated reserves around \$12 million, and about \$13 million left in ARPA funds. There will be strategic shifts to cover budget shortfalls.

- Move to extend discussion by 5 minutes, first extension. Fran motioned, Daniel seconded. Motion passes: 12- approve, 4- deny, 2- abstain.
- Question: What is happening about inflation and cost of living raises? Council ended up shaving off a significant amount of budget to cover COLA and inflation in relation to collective bargaining agreements.
- Trent Shelter opening today (9/1/22), it will open for public use on Tuesday, Sept 6.
- Question: Is ARPA funds figured into budget calculations or is that a separate budget? It is a separate budget, since they're one-time funds. About \$13 million is remaining in ARPA pot.

#### 6. City Redistricting Board (Rick Friedlander):

- Rick is the Chair of the Redistricting Committee. The presentation that was given will be sent to neighborhoods and CA members in an email.
- Criteria was reviewed for the rules that the new plan must follow. Some districts may have to change, due to the populations and the requirement that they must be nearly equal in population size.
- Thought exchange survey resulted in results that expressed a desire for neighborhoods to remain intact as much as possible.
- Public outreach is an important part of this process. They will publish the 4 drafted maps that can be selected from, and there will be a survey sent out where people can provide feedback and ideas. The survey will be shared out when it launches. A town hall-style meeting where comments/feedback on the maps will take place on Oct 4 at 5:00pm in the City Council Chambers.
- Question: When will the maps be published? Likely in a week or so.
- Question: As the city continues to grow, any consideration to add additional districts, i.e. split from 3 to 6 to better manage neighborhood representation? *Moving forward, it's definitely something that might have to be considered.*
- Question: What are the population numbers impacting the possibility of needing to change neighborhoods' district assignment? About 400 people currently impact this.

#### 7. Design Review Board 101 (Dean Gunderson):

- Dean's presentation will be emailed out to neighborhoods and CA Reps.
- The presentation covers how Spokane's design review process goes. The process is considered an
  element of economic development, because design review is about amplifying the quality of the
  public realm.
- Design Review's Relationship to other City of Spokane Policies and Codes:
  - They look at the City's Comprehensive Plan, Subarea Plans (ex.: Downtown Plan), and Neighborhood Plans. The DRB is the only citizen body that looks at and evaluates development proposals.
- They don't review every proposed project, they focus on the ones that the public has expressed being most important. These include any projects of major size in the downtown area, storage units near residential areas, any public project/structure. Those are automatically subject to design review.
- They adopted a full list of design guideline values that allow for a thorough evaluation of design projects.

- Move to extend discussion by 5 minutes, first extension. Mark motioned, Daniel seconded. Motion passes: 11- approve, 3- deny, 2- abstain.
- During the Collaborative Workshop, the developer, advisory board and community members all provide presentations/feedback. Then the advisory board provides Advisory Actions, which is advice given back to the applicant. "Based upon the interest of the public realm, these are suggestions to your project." And they have 12 months to address these advisory actions. They then come back to the Recommendation Meeting, and present new information on any changes made and how they took the advisory actions and public comments into consideration. The advisory board then makes recommendations, not to the developer, but to the Action Approving Authority (who is in charge of issuing the permit). If the advisory board unanimously votes on the recommendations, then the Action Approving Authority must add those recommendations as a condition of permit.
- Move to extend discussion by 5 minutes, second and final extension. Daniel motioned, Carol seconded. Motion passes: 10- approve, 4- deny, 3- abstain.
- What's the difference between Design Guidelines and Design Standards?
  - Design Standards are part of the Unified Development Code. Design Guidelines are a vision statement about the quality of design. Standards do not take into account the quality of design.
- The CA Liaison to the Design Review Board are given full voting abilities. The previous Liaison (Kathy Lang) was elected as the Chair of DRB.

#### 8. Plan Commission Liaison (Mary Winkes):

- Authorized by and Date: Authorized through Charter Section 128, in 1910 and SMC 04.12
- Mission Statement/Purpose: The Plan Commission provides advice and makes recommendations on broad planning goals and policies and other matters as requested by the City Council. The minutes from the Plan Commission meetings and their findings and recommendations are available on this website.
- The Plan Commission holds public hearings and makes recommendations to the City Council regarding the following matters:
  - o Amendments to the City's Comprehensive Plan and the development regulations implementing the Comprehensive Plan
  - Changes in the corporate limits of the City, including the land use designations and zoning to become effective upon the annexation of any area proposed for annexation or which might reasonably be expected to be annexed by the City at any future time.
- Meeting date, time and location: The <u>Plan Commission</u> meets the second and fourth Wednesday of each month at 2 p.m. in the Council Briefing Center, 808 W. Spokane Falls Blvd., in Spokane City Hall.
- Meeting date, time and location: The <u>Transportation Subcommittee</u> meets the first Tuesday of each month at 9 a.m. in the Council Briefing Center, 808 W. Spokane Falls Blvd., in Spokane City Hall.
- Meeting date, time and location: <u>Housing Action Subcommittee</u> meets every 2nd and 4th Wednesday
  of the month at 1:00pm until 1:30 pm. These will be held in a hybrid format on Webex and in the City
  Council Briefing Center.
- There may be an opportunity for the Liaison to the have voting ability on the Plan Commission in the future, but currently, Mary is doing her absolute best within her role's ability to be the voice of the CA and the neighborhoods. CA members profusely thanked Mary for her work on the Plan Commission.

#### 9. NRO Updates (Colleen Gardner):

- Colleen is not representing or serving as a spokesperson for Spokane Police Department; the information presented is what she found when she did research as a neighborhood council chair.
- Worries about Neighborhood Resource Officers going away. Colleen is discussing changes with some
  of the Chief's command staff.
- In January 2023, the precinct model that currently stands might change to sectors, 4 sectors will be in
  place. North precinct will be divided into NW and NE sector (Division being dividing line). This will
  place more officers on the streets in a patrol role, sectors will have 24/7 response. This sector model
  will impact how they work with neighborhoods, and whether or not they'll be able to attend NC
  meetings as guests has not been finalized. The sectors will determine their community outreach
  model once they're established.

- Colleen will keep folks up-to-date on news as she finds out.

#### 10. Budget Committee Updates (Ken Cruz):

- Ideas of doing a SWOT (Strengths, Weaknesses, Opportunities and Threats) analysis to gauge where the CA is.
- There may be an opportunity to record the training. There are options for food, do folks feel comfortable with a potluck, bringing their own lunch, or pre-ordering meals for the retreat? There will be a survey going out to gauge interest in lunch arrangements. Gail will be providing coffee and Luke will be bringing Donut Parade.
- Some topic suggestions: Inclusion, and being more inviting and welcoming to newcomers, especially those of different underrepresented populations.

#### 13. Roundtable Discussion:

- Randy: Follow-up with CA about work been happening with PeTT and CTAB. Getting folks up-to-speed
  on CTAB. Focusing on building a process on how to communicate on traffic-related projects with the
  neighborhoods. Is experiencing difficulty in emailing participants because emails are getting sent to
  spam, so have folks check spam box if they're expecting communication. Randy's contact info is
  chair@ecspokane.org, (509) 495-1161.
- Luke: Mayor created a Police Reform Advisory Task Force, Luke represented CA in the few meetings they held. Luke wanted to ask CA how he should proceed with continuing participation on the task force since they've been inactive and not received any communication from Mayor or Communications. There was support for writing a formal letter asking the Mayor to address the status of the task force and how CA can be involved.

How is this different than a Design Standard?

Design Standard: an obligatory design requirement for any project.

These standards are not advisory, they must be followed – just like the requirements in the building code, fire code, or electrical code.

The design review process cannot waive compliance with these standards.

While Design Standards and Design Guidelines are similar in that they are both about a project's design, they differ mostly in that the standards are mandatory obligations applied to that project – while guidelines are a list of relevant subjects, and examples, intended to improve the design of any project subject to design review.

The standards were adopted to ensure that all development in the city achieve a minimum quality of design.


The guidelines are used in order to improve the quality of design above bare minimums, for a select set of projects. Those projects have already been identified by the community for special consideration.

## CityWide Design Guidelines

This is not a type of project or development, but may be best described as a set of urban design Best Management Practices. The reason these are necessary relates back to why we have design guidelines in the first place – in order to facilitate effective conversations about a project or plans design elements in order to meet the community's aesthetic expectations.

When would such guidelines be used?

- When Urban Design staff or the Design Review Board are asked to provide advice on a Plan (not connected to a development proposal).
- When Urban Design staff or the Design Review Board are tasked with evaluating a Design Departure (to determine whether an alternative design proposal is superior in design and may qualify for a departure).
- When Urban Design staff or the design Review Board are asked to provide advice in unique projects that have no adopted design guidelines.



- Spokane School District Buildings and Structures Elementary Schools, Middle Schools, Senior Highs, Administrative and Maintenance Buildings)
- Charter School Building and Structures » Public Colleges and Universities Buildings and Structures (SCC, SFCC, EWU, WSU, UW)
- Spokane Public Libraries
- Spokane Transit Authority Buildings and Structures
- County, State, and Federal Buildings and Structures




## **URBAN DESIGN**

Area of Influence: Region, City, Neighborhood, District

Design Objective

Urban Design guidelines assist designers and developers in recognizing and respecting physical systems that extend beyond the site so projects can respond to regional, municipal, neighborhood, and district patterns in space and time. Any new intervention should extend, mend, connect, or enhance the context through all aspects of the project, big and small from public amenities to site design to the street-path network serving all modes of transportation, natural systems (e.g., natural resources, stormwater flow, topography, land forms), or historic settlement patterns.



## **PUBLIC AMENITIES**

Area of Influence: Public Realm

Design Objective

Public Amenity guidelines assist designers and developers in creating projects that enhance the public realm; including streetscapes and open spaces.



## PEDESTRIAN ENVIRONMENT

Area of Influence: Public Realm


#### Design Objective

Pedestrian Environment guidelines assist designers and developers in creating skywalks that define the pedestrian environment.

The intent of the guidelines is to promote a safe and healthy environment where the pedestrian is the priority.

While there is a need for automobile, bicycle and transit in Spokane, in all cases the most important consideration is the ease of pedestrian movement. Where intersections with other transportation modes occur, the pedestrian's comfort, safety and best interests must not be compromised.

The pedestrian should be unimpeded and relatively comfortable in all seasons and hours of the day, in all areas of Spokane.



## ARCHITECTURAL EXPRESSION

Area of Influence: Building, Structure, & Site

Design Objective

Architectural Expression guidelines assist designers and developers in creating skywalks that relate to the neighborhood context and promote quality development that reinforces the individuality, spirit, and values of Spokane. The guidelines are intended to promote architectural design that is complementary to Spokane's heritage

and character. The following objectives and guidelines for Spokane primarily address the exterior of skywalks and their relationship to its architectural surroundings.




## **ACCESS & SCREENING**

Area of Influence: Building, Structure, & Site

Design Objective

Access and Visual Impact guidelines assist designers and developers in creating skywalks that minimize adverse environmental impacts.



## THE LIAISON COMMITTEE PROPOSES THE COMMUNITY ASSEMBLY TAKE THE FOLLOWING ACTION TO CONTINUE MARY WINKES ON THE PLAN COMMISSION:

In accordance with the provisions of Spokane municipal code SMC 04.12.040 Plan Commission / Liaison Members at B., the Community Assembly hereby nominates Mary Winkes to the mayor as its Plan Commission liaison for a second and final term of three (3) years from 1/1/2023 to 31/12/25 subject to appointment by the city council.

The Administration Committee is also requested to convey the nomination to the office of the mayor and to the planning director.

#### **BACKGROUND:**

Title 04 Administrative Agencies and Procedures Chapter 04.12 Plan Commission Section 04.12.040 Liaison Members

- A. The city council shall appoint one city council member to serve as a liaison to the commission and shall also appoint an alternate city council member to serve in the absence of the liaison.
- B. The community assembly shall nominate a member of the assembly to serve as a liaison to the plan commission, subject to confirmation by the mayor and appointment by the city council.
- C. The liaison members shall be non-voting participants in commission business.

First appointment by City Council December 17, 2019

Appointment of Mary Winkes to a three-year term, from 01.01.20 - 12.31.22, as the Community Assembly liaison to the Plan Commission, as recommended by the Community Assembly.

#### Welcome/Introductions

Meeting was called to order by Chair, Randy McGlenn.

Attendees introduced themselves and their neighborhood connections.

#### **Committee Reports**

Plan Commission Transportation Subcommittee (PCTS) – Charles Hansen

Charles said the committee has not met in three months.

Bicycle Review Board (BAB) – no one present Citizen Transportation Advisory Board (CTAB) – no update

#### Colin-Quinn Hurst, Pedestrian and Bicycle Planner- Amendments to Bike Network Map

Colin said he had a mobile meeting in northwest Spokane. Afterwards the group had pizza and talked about what they saw on their tour, including routes that were uncomfortable and needed to be fixed. Northwest Blvd and Assembly/Driscoll/Frances were mentioned. He said the group will meet again in October. Colin mentioned the Bike Project Six Year Plan. He said Amendments to the Bike Network Map were in the last 3 years of Comprehensive Plan Amendment Updates. He said changes in development and traffic made updates to the Bicycle Master Plan necessary. He wants to keep up with best practices and make routes safe and comfortable. Colin said there are 14 amendments in the 2021-2022 Comprehensive Plan Amendment Updates. He said the TR-5 Bicycle Facilities Map is an appendix in Chapter 4 of the City's Comprehensive Plan. He said a goal is to design routes for all ages and abilities. He said 46 percent of the city bike routes are the complete. He said there are 117 miles remaining. He cited a quote by Ed Reiskin, the director of SFMTA, "Being strategic about how we invest money...the most cost-effective investment we can make for moving people is bicycle infrastructure." Colin said health, financial savings and sustainability are important goals. He said he also wants to accommodate people who need it

most such as residents of the downtown House of Charity. Colin also said driver's licenses peaked in 1983 and dropped 30 percent. He said today's young techies are less interested in owning cars and use transit or walk or bike to work. He said bicyclists shop more frequently at local businesses. He said they don't pallet-buy toilet paper or rice and spend on impulse buys. They also travel at a pace to see storefronts and come back later in a car to shop. Bike routes increase retail sales by 49 percent. A decrease in crashes and an increase in safety and comfort was also noted. Colin went over the 14 proposed Bike Map Modifications: Pacific Ave, Euclid and Pacific Avenue (a county park response), Washington Street (previously adopted in the downtown master plan but street department has asked amendment be withdrawn), Fiske Steet (Ray/Freya crossover response), Fish Lake Trail Head (consistent with recent study), Lincoln and Howard (can apply for a grant for Lincoln), West Broadway (request by neighborhood), East Illinois (request by neighborhoods), West Cascade Way (Division Connect Study response), East Garland Avenue (Children of the Sun connection/collaboration response), South Ray and South Thor (a Ray/Freya crossover response), East Thurston Ave (a Ray/Freya crossover response), South Inland Empire Way ( I-95 study response due to increase traffic with opening of Inland Empire Way), and South Spring Creek Lane (I-95 study response to for safe bike/walk pathway). Colin said there will be no amendments to the Bike Network Map in 2023 due to the suspension of the Comprehensive Plan Amendments for one year. Colin answered questions. He said impact fees can add bike lanes, but he wasn't sure about separated pathways. Colin said striped bicycle lanes are required to be installed as part of the city's complete streets, but bigger projects like signals and pathways are not required. He said the city council will have a study session and hearing on the amendments. Mary said the Plan Commission will have a hearing on 9/28/22.

#### **Project Review**

There were no projects for review this month

#### Roundtable

There was a discussion for a permanent home for the meetings. Mary had gone to the Central Library and Hive Library before being told the meeting was at the Liberty Park library. Randy said the Central Library will not let anyone stay late. He suggested the Hive because the group can stay late, it is locked and has security and has hybrid capabilities. The group voted in favor of the Hive. It was noted the former location, West Central Community Center, has no hybrid capabilities. Randy will work with the library staff to schedule the meetings.

Mary inquired on the status of Shauna Harshman. It was confirmed that she had left the city and is employed by the Spokane Low-Income Housing Consortium. It was also noted that Jeff Gunn, legislative assistant to Zack Zaponne would be taking over the Traffic Calming Program. It was also noted that the Traffic Calming Program is presently in the hands of the consulting engineers and Inga Note until at least January.

Carol requested a speaker on traffic studies. Her neighborhood had a traffic study on Altamont

Loop funded and wanted to know what a traffic study entails. It was noted the Cycle 10 traffic studies funded were not on the table yet and would most likely be done by an external engineer. Randy will check to see if a city engineer can speak on traffic studies.

John Hall's resignation was discussed. Annie said she has applied for the ONS director position. She said Shauna Harshman has also applied.

Carlie Hoffman said there was a SRTC plan update: The information was posted in the chat and sent via email: https://www.srtc.org/human-services-transportation-plan/ SRTC, in partnership with Spokane Transit, is working on the 2022 update to the Coordinated Public Transit-Human Services Transportation (CPT-HSTP). The plan update process will take place through Fall 2022, and a project page has been established to learn more and take input from public transportation users, service providers, and other community members in our region.

  - a. Garrett gave details of the EXPO+50 marketing team which Greater Spokane Inc. and Visit Spokane graciously hosted. The meeting focused on a timeline, the message to be relayed, and how marketing will fit in with the events. A follow-up meeting will focus on establishing event themes and planning the beginning and end timeframes of the EXPO+50 commemoration.
  - b. Garrett and Rick met with David Evans, an engineer from the original Expo '74, and Mike Kobluk, former Director of Performing and Visual Arts for Expo '74, who gave feedback on a possible timeline for EXPO+50, and stressed the need for a full-time employee, focusing on funding, sponsorship, and grant opportunities.
  - c. Chuck Murphy, Vice President of Strategic Initiatives for Gonzaga, and students from the Environmental Science and Business programs will attend the next Infrastructure meeting to discuss a business plan for activating the Spokane River.
  - d. Garrett relayed that notification has been received that the South Suspension Bridge repair is one of the top five ranked projects in the state for a Recreation and Conservation Office 50% funding match. City Council and Avista may also assist with funding. Suggestions were made to involve the Historic Preservation Office, Northwest Museum of Arts and Culture, and Gonzaga history students for help with story-building the historical aspect of Expo.
- "Friends" groups presentations update Kelly Brown
  Kelly mentioned that the "Friends' toolkit was discussed at the previous DVCAC meeting but not
  much feedback was received. Trevor Finchamp gave a presentation, which will be shared with the
  DVC once finalized.

#### **Minutes**

A. **Call to order/introductions** – The meeting was called to order at 4 p.m. by committee chair Kelly Brown.

#### B. Discussion items

- 1. Friends Toolkit update Fianna Dickson.
  - a. Fianna shared that legal had some great advice regarding creating a Friends Toolkit and needing to develop an administrative policy on how to work with park friends groups. She hopes to have a policy draft to bring to both the DVCAC and DVC meetings next month for review and discussion.
  - b. Fianna thanked everyone for the feedback received so far on the toolkit and requested any additional feedback be provided to her. She will share another draft when further along in the policy.
  - c. Fianna shared a guiding document (Volunteer with Spokane Parks & Recreation!) to help with the direction of the policy. She explained this would be a three-step process to forming a Parks Friends group. The first step would be volunteering with parks, the second step would be adopting a park, and the third step would be to form a Park Friends group.
  - d. Lindsey Shaw inquired if a Parks Friends group could have a fiscal sponsor rather than having their own 501c3. Fianna indicated that would be a possibility and that part of what

- the tool kit would outline is different ways to set up a Friends group fiscally.
- e. Lee Williams suggested people connect with their neighborhood council to let them know they will be in the parks. Fianna confirmed one of the action steps in the tool kit is to connect with the neighborhood council.
- f. Fianna shared that they have four rough draft videos which highlight a volunteer, someone donating, and a partner sponsor. The four rough draft videos will be combined into one video and should be ready soon, highlighting all the ways people can engage with Parks & Recreation.
- 2. Friends groups upcoming events/volunteer support Kelly Brown
  - a. Lee Williams (Friends of Coeur d'Alene Park) shared that the Friends of Coeur d'Alene Park is having Spook Walk in Brownes Addition on October 28-31. There will be two tours per night and each tour lasts about one hour. Information will be posted on the Friends of Coeur d'Alene website and on Facebook.
  - b. Lindsey Shaw (Community Assembly representative/Logan Neighborhood and Northeast Spokane) shared that they just had the Logan block party at Mission Park and it was amazing. This was the second Logan block party this year, the first one was held in April.
  - c. Trevor Finchamp (Friends of The Bluff) shared the Friends of The Bluff had their benefit concert and annual meeting at Rocket Market on September 10. It went really well and was a fun way to present their annual meeting. About \$5,000 was raised, which will go toward their Access Initiatives.

#### C. Standing reports

- 1. EXPO+50 overview Kelly Brown
  - a. Kelly relayed that Garrett Jones and Rick Romero gave an update yesterday at the DVC meeting outlining more details regarding the celebration. Garrett and Rick are working to outline more details for the celebration, including a timeline for the event, messaging, and programming for the event. They would like to get sister cities involved, and get smaller outlying cities to partner with the event. They are also working with Gonzaga University to have them help with the activating the river piece. Kelly shared that 7 of 12 partners have been secured.
  - b. Bob Anderson advised things are still in the planning stages. He shared that three people who originally helped plan Expo 74 have been contacted and will help and provide ideas. A full-time person may need to be hired to coordinate events and marketing, as it may be too much for a volunteer position to coordinate. He said there are two departments with students at Gonzaga that want to help, he also noted that Gerry Sperling suggested getting other Universities involved as well.
  - c. Lindsey Shaw asked if they will be including neighborhoods along the river. Bob said they have discussed getting neighborhood councils and friends groups, as well as others involved. He said they are not at that stage yet and he is not sure of the timeline.
