- Trash Talk beginning Tuesday, Jan. 2, residents are asked to have garbage and recycling ready at the curb by 6 a.m. (formerly 7 a.m.) on their designated collection day.
- The City of Spokane’s new online registry for **long-term** rental properties is open. Registration is an online process where applications will be submitted directly to the City using our existing online application system, [Accela Citizen Access \(spokanepermits.org\)](http://spokanepermits.org). Spokane City Council passed the Regulation of Residential Rental Housing ordinance in March 2023.
- The City will start **short-term rental (less than 30 days) monitoring** this month. Hosts operating without a permit will receive a letter that they’ve been identified as having a non-compliant short-

term rental. Spokane City Council passed amendments to the short-term rental regulations on July 10, 2023, and the regulations went into effect on Sept. 1, 2023. Read our [blog](#) for more information.

- City of Spokane Parks & Recreation received a \$100,000 grant to repair broken **play equipment** at 16 parks, awarded by the Washington State Recreation and Conservation Office (RCO) through its first Local Parks Maintenance grant program. Repairs will include about 43 broken and damaged equipment pieces like slides and swings and are anticipated to be done in 2024.
