- Free curbside Christmas tree pickup Jan. 2-12. The City's Solid Waste department will be pick
  up fresh-cut trees that are 6-feet tall or cut in half if taller. Residents should place trees 3 feet
  from garbage or recycling carts on their regularly scheduled pickup day.
- o Beginning Tuesday, Jan. 2, residents are asked to have garbage and recycling ready at the curb by 6 a.m. (formerly 7 a.m.) on their designated collection day.
- The City of Spokane's <u>new online registry for long-term</u> rental properties is open. Registration is an
  online process where applications will be submitted directly to the City using our existing online



application system, <u>Accela Citizen Access (spokanepermits.org)</u>. Spokane City Council passed the Regulation of Residential Rental Housing ordinance in March 2023.

- The City will start *short-term* rental (less than 30 days) monitoring this month. Hosts operating without a permit will receive a letter that they've been identified as having a non-compliant short-term rental. Spokane City Council passed amendments to the short-term rental regulations on July 10, 2023, and the regulations went into effect on Sept. 1, 2023. Read our <u>blog</u> for more information.

Local Parks Maintenance grant program. Repairs will include about 43 broken and damaged equipment pieces like slides and swings and are anticipated to be done in 2024.
