If a neighborhood council wants an older application from a previous year to be reconsidered, that was not selected, please contact Annica Eagle (509.625.6156, aeagle@spokanecity.org). This is to confirm the neighborhood still wishes to pursue a previous unfunded project. All previously submitted applications are saved on file.

School related projects will now be submitted through a separate application process/program, the School Safety Program. For questions please contact Annica Eagle with the contact information listed above.

A neighborhood can phase a project over multiple years to complete a project, and if funds are available City Council may choose to fund an entire project in one funding year.

Due to the competitiveness of this process, a neighborhood council may want to consider cost effectiveness while selecting a proposed project.
