#### MINUTES OF SPOKANE CITY COUNCIL

Monday, June 10, 2013

### **BRIEFING SESSION**

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Chambers in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

### **Roll Call**

On roll call, Council President Stuckart and Council Members Allen, Fagan, Salvatori, and Snyder were present. Council Members McLaughlin and Waldref arrived at 3:32 p.m. City Administrator Theresa Sanders, Assistant City Attorney Mike Piccolo, and City Clerk Terri Pfister were also present on the dais.

### Advance Agenda Review

Council received input from staff on the June 17, 2013, Advanced Agenda items.

Interlocal Agreement with Spokane County to Establish the Spokane Area Workforce Development Council (OPR 2013-0448) and Interlocal Consortium Agreement under the Workforce Investment Act of 1998 with Spokane County (OPR 2013-0449)

**Motion** by Council Member Waldref, seconded by Council Member Salvatori, to suspend the Council Rules; **carried unanimously.** 

**Motion** by Council Member Fagan, seconded by Council Member Waldref **to add** the following two items to the Council's June 17 Advance Consent Agenda; **carried unanimously:** 

- Interlocal Agreement with Spokane County to establish the Spokane Area Workforce Development Council
  as a Washington Non-profit corporation and to designate the SAWDC as the fiscal and administrative agent
  of the Spokane Area Consortium. (OPR 2013-0448)
- Interlocal Consortium Agreement under the Workforce Investment Act of 1998 with Spokane County to terminate the most recent (2000) Interlocal Cooperation Agreement and form a new consortium with the newly created Workforce Development Council non-profit corporation as the fiscal and administrative agent. (OPR 2013-0449)

Assistant City Attorney Mike Piccolo and City Clerk Terri Pfister were also present.

Council President Stuckart and Council Members Allen, Fagan, McLaughlin, Salvatori, Snyder, and Waldref were present.

### COUNCIL COMMITTEE REPORTS

### **Public Works Committee**

Council Member Salvatori reported on the Public Works Committee meeting held earlier today (June 10). Minutes of the Public Works Committee meetings are filed with the City Clerk's Office and are available for review following approval by the Public Works Committee.

### **ANNOUNCEMENT**

Council President Stuckart announced that on Friday, June 14, from noon to 7:00 p.m., TSA's Office of Law Enforcement, the Federal Air Marshal Service, and the Spokane Transit Authority will be teaming up for prevention and response on that day, and he noted they often also work with the Border Patrol.

### **TOWN HALL FORUM**

- **Mr. Rick Bocook** spoke regarding SPARC (Spokane Police Accountability Reform Coalition). He expressed the need for more crisis intervention training. In addition, he spoke about incidents involving Police that occurred in the community.
- Mr. Henry Valder remarked on his health/weight, Jimmy's curse, and provided various other comments.
- **Mr. Daniel Peck** commented on youth baseball fields, and the Parks proposed \$3 an hour price increase for all kids playing at Merkel and \$2 an hour for Franklin. He noted this doubles the price that has been paid for fields for kids in the last three years. In addition, he stated the City (Parks) has come in and said they are taking all ten fields, and they are all going to be dedicated for adult softball. He stated at some point in time the City has to pay more attention to its kids.
- **Mr. Gabriel Elliott** noted he will not be at City Council meetings for a few weeks as he will be attending meditation boot camp at the South Hill Unity Spiritual Center on Mondays. He also commented that he was pleased with the happenings at Riverfront Park for the LGTB community.
- **Ms.** Leslie Sigrah advised she is with Spokane Babe Ruth and runs the baseball program for kids with disabilities. She commented on the charge to play on fields that the youth practice on. She remarked on the need for baseball fields for youth and stated the City needs to step up and help with this.

**Naima Quarles Burnley** commented she has a child with special needs and is part of the Babino Buddy Ball League, which is part of the Spokane Baseball Association. She made an appeal, on behalf of herself and others, for their own baseball field that will be handicap accessible.

- Jen Hussey reported on West Central Neighborhood.
