#### MINUTES OF SPOKANE CITY COUNCIL

Monday, December 16, 2013

#### **BRIEFING SESSION**

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Chambers in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

#### Roll Call

On roll call, Council President Stuckart and Council Members Allen, Fagan, McLaughlin, Salvatori, Snyder, and Waldref were present.

Assistant City Attorney Mike Piccolo, and City Clerk Terri Pfister were also present on the dais.

#### ACKNOWLEDGEMENT/RECOGNITION

Council President Stuckart recognized Council Member McLaughlin and acknowledged this is Ms. McLaughlin's last (regular) meeting, after serving eight years on the Council. Council Member McLaughlin noted it has been an honor serving the community and stated it is all about relationships and moving Spokane forward.

#### Advance Agenda Review

There was no Advance Agenda Review held, as the regular City Council meeting on December 23, 2013, is canceled. In addition, the regular City Council meeting on December 30, 2013, is canceled.

#### **CITY ADMINISTRATION REPORT**

#### SADD (Students Against Destructive Decisions) Program / Underage Drinking Presentation

Mr. Kelly Cruz of the West Central Neighborhood introduced students who spoke regarding North Central's SADD Program and the grant they received. Mr. Cruz noted SADD is a coalition that has been in existence since 1994, and it's a collaboration of non-profits, social service organizations, and government entities who meet monthly to address improving the health of the youth in the community. Carlie Stephens from North Central's SADD Program and a member of Washington Drug Free Youth shared a story as to how underage drinking has affected her personally and noted she lost a sister to drinking and driving. Mr. Cruz then informed the Council about a Law Enforcement partnership grant in the amount of \$6,500 received through the State which will go toward a media campaign to bring awareness and inform the community about the costs and consequences associated with underage drinking; and the other part of the grant is the law enforcement portion, which is to do compliance checks and work with Spokane County to do purchase surveys of retailers. Sheriff Ozzie Knezovich as a partner in this spoke about the law enforcement part relating to compliance checks. In addition, Allan Zeuge with Spokane Community Services, Housing and Community Development spoke regarding community prevention and wellness. Jonathan Whitmore, a student at Whitworth, spoke regarding the media campaign portion.

#### **Update on Downtown Livability Initiative**

Council President Stuckart provided an update on the progress of the Downtown Livability Initiative in partnership with Downtown Spokane Partnership, Spokane Police, as well as other partners from the business community. He went through the 10 action steps and provided an update on each.

#### **COUNCIL COMMITTEE REPORTS**

#### Planning, Community, and Economic Development (PCED) Committee

Council President Stuckart reported on the PCED Committee meeting held earlier today (December 16). Minutes of the PCED Committee meetings are filed with the City Clerk's Office and are available for review following approval of the PCED Committee.

#### **OPEN FORUM**

**Mr. Gabriel Elliott** stated meditations are ongoing for peace and love under will at the Unity Churches, north on Lincoln and south on Bernard. In addition, he provided other remarks.

**Mr. Ron Peyton** addressed Council regarding two issues: the constant degradation of the on-duty strength of the Fire Department and fire apparatus. He encouraged Council to set up a replacement schedule to fund both firefighters and replacement of fire apparatus.

**Mr. Tim Lively** addressed concerns regarding Fire response in the City of Spokane. He noted he lives in the southeast portion of the City. He encouraged Council to look outside the box and provide a solution for fire service in the Latah Valley area.

**Ms. Kelly Petrick** voiced concerns regarding the Fire Department, specifically Station 9, and the services they are able to provide to her neighborhood on the South Hill.

**Mr. Ryan Morris** voiced concern regarding the policy change in the Fire Department referred to as jumping where firefighters are required to take a medical vehicle over the firefighting apparatus to any call other than a fire.

**Ms. Debra Morris** asked for a significant change in the way the City has been addressing issues with funding of the Fire Department. She noted Spokane Valley has better equipment, funding, and staffing than the Spokane Fire Department.

**Ms.** Joan Medina thanked the City for expanding the resources for the homeless shelters in the Downtown area; however, she noted it's not enough and there's always going to be people on the street who cannot take advantage of the shelters for very valid reasons.

Mr. Rick Bocook spoke regarding homeless people and the battle of commerce against rights.

**Mr. George McGrath** spoke regarding monies going into projects and the lack of maintenance preparation planning for the projects.

**Mr. Justin Pimsanquan** noted he is the founder of the "Don't Shoot" grass roots movement which has a goal to reduce gun violence. He spoke regarding comments by Ron Wright at a community meeting last Thursday relating to trajectory evidence and how the coroner's reports don't always match the Police reports.

**Ms. Teresa Simon** spoke regarding 633 S. Greene and the Hubley family.

**Mr. Chance Addison** wished to remark on Police oversight.

(Note: At 6:55 p.m., due to comments presented by Mr. Addison, Council President briefly recessed the meeting and called the meeting back to order at that same time.)

Contract Award for Design-Build Service for the Nelson Service Center (PRO 2013-0037 / ENG 13633 / BID 3970-13)
Utilities Division Director Rick Romero presented a presentation on the Nelson Service Center, and he responded to Council inquiries and comments, along with Solid Waste Director Scott Windsor. Subsequent to the opportunity for public testimony, with no individuals requesting to speak, and Council comment, the following action was taken:

**Upon Unanimous Roll Call Vote,** the City Council **approved** the Contract Award for Design-Build Services for the Nelson Service Center to Garco Construction, Inc. as the Design-Build General Contractor and Bernardo-Wills Architects as the Architect and Designer of Record—\$14,200,000.

#### **FINAL READING ORDINANCES**

#### Final Reading Ordinance C35068 Relating to Sitting, Lying on Sidewalk

Council Member Allen introduced an amended version of Ordinance C35068, and the following action was taken:

**Motion** by Council Member Fagan, seconded by Council Member Salvatori, to adopt the amended version of Ordinance C35068; **carried unanimously**.

Council Member Allen then provided an overview of Ordinance C35068, as amended. Considerable public testimony was received and Council commentary and debate held. The following action was taken:

**Motion** by Council Member Waldref, seconded by Council President Stuckart, to defer action until both the Criminal Justice Commission finishes its work and the Urban Task Force finishes its work, which is just getting started, and then the Council would actually have some programming and recommendations to put into place that would make an ordinance like this effective; **rejected 3 to 4 (Council Members Allen, Fagan, McLaughlin, and Salvatori voting "no").** 

Following further Council commentary, the following action was taken:

Upon 4-3 Roll Call Vote (Council President Stuckart and Council Members Snyder and Waldref voting "no"), the City Council passed Final Reading Ordinance C35068, as amended, relating to sitting, lying on sidewalk in a designated zone; amending Spokane Municipal Code Section 10.10.026.

For Council action on Final Reading Ordinance C35069, see section of minutes under "Special Considerations (continued)."

#### **Council Recess**

The City Council took a recess at 9:24 a.m. and reconvened at 9:29 p.m.

#### **SPECIAL CONSIDERATIONS (continued)**

### Collective Bargaining Agreement with Police Guild (OPR 2013-0864) and Final Reading Ordinance C35069 Relating to the Office of Police Ombudsman

The City Council considered the Collective Bargaining Agreement with the Police Guild covering wages and benefits for 2012-2015 and Final Reading Ordinance C35069 relating to the Office of Police Ombudsman. Police Chief Frank Straub provided a presentation on the Police Department and Final Reading Ordinance C35069 relating to the Office of Police Ombudsman. In addition, John Gately, President of the Police Guild, made a statement to strongly encourage the City Council to approve the tentative agreement with the Police Guild and Final Reading Ordinance C35069. Council debate and commentary was held, and the following action taken:

**Motion** by Council Member Allen, seconded by Council Member Waldref, to defer the ordinance until February 3 (with the goal of forming a task force made up of citizens, Police, the Guild, to continue the work already done and to have that out a week before the 3<sup>rd</sup> so citizen comment can happen); **carried 5-2 (Council Members McLaughlin and Snyder voting "no").** 

\*Motion by Council Member Allen, seconded by Council Member Waldref, to defer the tentative agreement until February 3 (with the goal of forming a task force made up of citizens, Police, the Guild, to continue the work already done and to have that out a week before the 3<sup>rd</sup> so citizen comment can happen); rejected 3 to 4 (Council Members Fagan, McLaughlin, Salvatori, and Snyder voting "no").

\*Additional Council comment was held on the ramifications of splitting the deferral on the ordinance and the tentative agreement. Council President Stuckart requested the vote on the tentative agreement be erased and re-voted on. Council discussion further ensued on the matters, with input by Assistant City Attorney Mike Piccolo. Subsequently, the following action was taken:

**Motion** by Council Member Allen, seconded by Council Member Waldref, to defer the tentative agreement until February 3 (with the goal of forming a task force made up of citizens, Police, the Guild, to continue the work already done and to have that out a week before the 3<sup>rd</sup> so citizen comment can happen); **carried 4 to 3** (**Council Members Fagan, McLaughlin, and Snyder voting "no").**

**Approval of Minutes**: Council Member Fagan moved approval of October 21, 2013 minutes; M/S Council Member Salvatori passed unanimously.

#### Staff Update:

1. <u>Development Agreement, Indian Trial</u> – Scott Chesney provided background information regarding the adopted Ordinance C 34931; the applicant undertaking land use actions that were anticipated in the Comprehensive Plan Land Use Map Amendment approved by City Council in November of 2012.

- 2. <u>IPG Contract</u> –Scott Chesney reported on the selection of Maul Foster Alongi, Inc., to provide professional services for the University District Integrated Planning Study; the scope of work and background information was included in the briefing paper.
- 3. <u>Developer Partnership Policy</u> Scott Chesney provided the incentive matrix for discussion regarding guidelines for developer incentives for City Council consideration. Targeted areas, geographic areas and infill are some of those redevelopment guidelines; currently working with GSI, developers and City Staff on when incentives could be triggered. This will be forwarded to the Plan Commission for recommendation prior to City Council action.
- 4. Greene Street Bridge Jan Quintrall and Mike Taylor updated City Council on the project and the issues that have developed that requires change orders; tasks include injecting and sealing cracks in the inclement weather, the estimate did not reflect accurate hard costs; thief of materials created a need for security and also played a part in the increase to the project. The bridge was substandard and we had to repair or replace in order to handle truck traffic.
- 5. <u>Consolidated Homeless Grants</u> Jerrie Allred introduced acceptance of \$2,505,489 in homeless assistance funding through a Department of Commerce grant, which would provide resources for operations, facility support, and rental assistance for low income households, in addition to funding for the Housing and Essential Needs program.
- 6. <u>Human Service Grant Funding Recommendations</u> Jerrie Allred provided handouts regarding the grant review process, new this year, and the CHHS Board funding recommendations. This process combines City and partner agencies coordination of Phase 1 funding for services agencies to provide priority services to Spokane low and moderate income households.
- Housing Rehab Program Management Allen Schmelzer and Paul Trautman requested approval of a 15-month, \$729,063 contract with Kiemle and Hagood Company for City Housing Rehabilitation program management services. Contract construction and management costs are fully funded by HUD grants and program income from previous HUD grant funded activities

#### **Action Items:**

- 1. Maximum Occupancy Limits report from Heather Trautman on the legal aspects and federal cases that protect families that does and cannot regulate the number of members; defined that six unrelated inhabitants are allowed to reside in residence; hard to enforce city wide. Many Cities have enacted rental licensing programs across the state and that reflects the number at licensing time, hard to regulate otherwise.
- 2. Full briefing from Engineering Services on the Martin Luther King Way Phase II/III project; inclusive of Erie Street, to be scheduled with PCED. Right-of-Way Acquisition for Martin Luther King Way, Phase II, Dave Steele reported on the acquisition for all or portions of approximately 10 properties necessary for the completion of the project; inclusive of relocation services/costs where applicable. Federal grant funds are the source of funding. Council comments:
  - Concern for Second Harvest/truck parking issues
  - Status of Erie Street improvements as part of overall project

1. Convention Center Hotel Project Update – Jan Quintrall provided a drawing of the selected design of the hotel. City Council is requesting additional information at an upcoming meeting.

#### Staff Update: Picture of current design and DRB

- 1. <u>Building Department & Spokane Municipal Code</u> Jan Quintrall provided a briefing requesting Developer Services Center will be included in the Spokane Municipal Code as the replacement for the Building Department.
- 2. <u>North Division ASCT System Detection</u> Mark Serbousek and Val Melvin reported on the purchasing equipment for a detection system to optimize ASCT performance at each of the twelve project intersections. The cost of the system is \$292,000.
- 3. Riverfront Park Master Plan Juliet Sinisterra and Leroy Eadie reported that the Park Board is considering the Advisory Committee recommendations for adopting a final Master Plan for Riverfront Park spring, 2014. The resulting Master Plan will directly affect and define a bond request from the Parks Board to the City Council. Input and feedback from the Council on recommendations, areas of concern, or areas that are being overlooked and should be included. No outside funding at this time. Council Members comments:
  - would like to see the park remain a four-season venue and program all year round
  - strongly urge keeping IMAX, invest and update
  - preferred the Ice Palace remain in the vicinity could see it as a draw into the park
  - North Bank would benefit as a lively retail/mixed-use area as well as sport oriented

Jan Quintrall reported on the Martin Luther King Way Project - Phase II/III Staff have found a number of solutions for parking for Union Gospel Mission. Additional meetings will be scheduled. In January will update on the status of the project in the area.

## Ordinances

If an ordinance is vetoed by the Mayor, the Mayoral veto will be published in a subsequent issue of the Official Gazette.

#### ORDINANCE NO. C - 35068

AN ORDINANCE relating to sitting, lying on sidewalk in a designated zone; amending SMC section 10.10.026.

The City of Spokane does ordain:

Section 1. That SMC section 10.10.026 is amended to read as follows:

#### 10.10.026 Sitting, Lying on Sidewalk in ((Retail)) a Designated Zone

#### A. Prohibition.

- 1. No person may sit or lie down upon a public sidewalk, or upon a blanket, chair, stool or any other object placed upon a public sidewalk during the hours between ((seven)) six a.m. and ((nine p.m.)) midnight in the ((retail)) zone ((of the congested district as defined in SMC 16A.04.020)) designated in this section.
- 2. At all times it is unlawful to sit or lie on any drinking fountain, trash container, planter, bicycle rack, or any other sidewalk fixture not designed primarily for the purpose of sitting.
- 3. At all times it is unlawful to sit or lie in any entrance to or exit from any building or parking lot, or on any loading dock.

#### B. Exceptions.

The prohibition in subsection (A) of this section does not apply to any person:

1. sitting or lying down due to a medical emergency or due to a sensory, mental, or physical disability;

- 2. who, as the result of a sensory, mental, or physical disability, utilizes a wheelchair, walker, or similar device to move about the public sidewalk;
- 3. operating or patronizing a business with permission to occupy the sidewalk;
- 4. participating in or attending a parade, festival, performance, rally, demonstration, meeting, or similar event conducted on the public sidewalk pursuant to a special event or other applicable permit;
- 5. sitting on a chair or bench supplied by a public agency or by the abutting private property owner pursuant to the appropriate permit or license; or
- 6. sitting within a bus stop zone while waiting for public or private transportation;
- 7. sitting on privately-owned sidewalk fixture with the permission of the owner;
- 8. engaging in constitutionally protected expressive activities which would otherwise be ((unreasonably)) restricted by the limitations in subsection (A) of this section;
- 9. who is homeless during a time frame when shelter space is unavailable.
- C. No person shall be ((cited)) <u>subject to enforcement</u> under this section unless the person engages in conduct prohibited by this section <u>within the entirety of the zone designated in this section</u> after having been notified by a law enforcement officer that the conduct violates this section and has been given a reasonable amount of time to comply or has refused to comply. If the individual fails to comply in a reasonable time <u>or engages in prohibited conduct in another location within the designated zone</u>, a law enforcement officer may than ((issue a citation under)) enforce this section.
- D. The zone where such conduct is prohibited is established in the map set forth in Attachment A.
- E. ((D)) This section does not permit any conduct which is prohibited by SMC 10.10.025 regarding interference with pedestrian or vehicular traffic.
- F. It is the intent of the city council that homeless individuals subject to enforcement under this section be directed to emergency shelters, community/drug/mental health court, or other interventional services.
- G. ((€)) A violation of SMC 10.10.026 is a misdemeanor.
- <u>H.</u> The provisions of this section are declared to be separate and severable. The invalidity of any clause, sentence, paragraph, section, or portion of this section, or the invalidity of the application thereof to any person or circumstance does not affect the validity of the remainder of this section, or the validity of its application to other persons or circumstances.
