#### NOTICE OF CITY COUNCIL PUBLIC HEARING PROPOSED AMENDMENT TO SPOKANE MUNICIPAL CODE SECTION 17C.230 PARKING & LOADING (Proposed Ordinance No. C35264)

Notice is hereby given that there will be a public hearing before the City of Spokane City Council on <u>June 15, 2015, at</u> <u>6:00 p.m.</u> in the City Council Chambers, Lower Level of City Hall, 808 West Spokane Falls Boulevard, Spokane, Washington, to receive public testimony on a proposed ordinance to amend Section 17C.230, Parking & Loading, of the Spokane Municipal Code. A project map and full project details can be found at: <u>https://my.spokanecity.org/projects/neighborhood-retail-parking-standards-update/</u>.

This amendment changes parking requirements in Neighborhood Retail (NR) zones. These zones are small commercial areas with historic roots as local community or "streetcar" business locations. A total of 72 NR zoned areas currently exist within the City of Spokane. The proposal gives a parking exemption for existing, new, or building additions with a floor area of three thousand square feet or less in NR zones. Additionally, a credit of three thousand square feet is provided for buildings with a floor area of five thousand square feet or less. This approach balances the need for parking requirements for large developments while focusing reductions at small scale, neighborhood serving establishments.

Written comments and oral testimony at the public hearings for these proposed actions will be made part of the public record. Only the applicant, persons submitting written comments and persons testifying at a hearing may appeal the decision of the City Council.

The 1st Reading of the ordinance before City Council is scheduled for Monday, June 8, 2015. Generally, no presentations are made at the 1st reading, and no public testimony is taken at the 1<sup>st</sup> reading. The 2<sup>nd</sup> reading and public hearing for the proposed amendment is scheduled for Monday, June 15, 2015, at 6:00 p.m., as indicated above. At this meeting there will be opportunity for public testimony. The public may also submit written comment to the City Council at citycouncil@spokanecity.org. The City Council reserves the right to continue this public hearing.
