MINUTES OF SPOKANE CITY COUNCIL**Monday, June 22, 2015****BRIEFING SESSION**

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Chambers in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

Roll Call

On roll call, Council President Stuckart and Council Members Allen, Fagan, Mumm, Snyder, Stratton, and Waldref were present.

Brian Coddington, Director of Communications and Marketing; Council's Policy Advisor Brian McClatchey; and City Clerk Terri Pfister were also present on the dais.

Advance Agenda Review

Council received an overview from staff on the June 29, 2015, Advance Agenda items.

Action to Approve June 29, 2015, Advance Agenda

Following staff reports and Council inquiry and discussion regarding the June 29, 2015, Advance Agenda items, the City Council took the following action (pursuant to Council Rule 2.1.2):

Motion by Council Member Fagan, seconded by Council Member Allen, **to approve** the Advance Agenda for Monday, June 29, 2015, **carried unanimously.**

ADMINISTRATIVE SESSION**Current Agenda Review**

Council reviewed items on the June 22, 2015, Current Agenda for any changes and/or additions.

Low Bid of T. LaRiviere Equipment & Excavation, Inc. (PRO 2015-0015) (deferred from June 15, 2015, Agenda)

Motion by Council Member Fagan, seconded by Council Member Mumm, **to table indefinitely** Consent Agenda Item No. 14—Low Bid of T. LaRiviere Equipment & Excavation, Inc. for Rowan Avenue Rehabilitation Phase 1 from Driscoll Boulevard to Alberta Street; **carried unanimously.**

Purchase and Sale Agreement with North Gorge Residential Partners LLC and Greenstone Corporation (OPR 2015-0555)

Motion by Council Member Fagan, seconded by Council Member Snyder, **to suspend** the Council Rules; **carried unanimously.**

Motion by Council Member Fagan, seconded by Council Member Snyder, **to add** Consent Agenda No. 15—Purchase and Sale Agreement with North Gorge Residential Partners LLC and Greenstone Corporation for Kendall Yards 5th Addition Tendered Improvements—to the June 22 Current Agenda; **carried unanimously.**

CONSENT AGENDA

Upon motion of Council Member Allen, seconded by Council Member Mumm, Council on 6-1 vote (Council Member Fagan voting “no”) approved Staff Recommendations for the following:

Low Bid of Red Diamond Construction, Inc., (Spokane, WA) for Indiana Avenue from Division Street to Dakota Street -

Phase I—\$1,545,334.76 (plus tax). An administrative reserve of \$154,533.48 (plus tax), which is 10% of the contract price, will be set aside. (PRO 2015-0020 / ENG 2014134)

Value Blanket Order with M&L Supply, (Spokane, WA) for miscellaneous sizes of backflow prevention devices for the City of Spokane Water Department—\$106,404.81 (incl. tax). (OPR 2015-0550 / BID 4141-15)

Emergency Contract with Inland Asphalt Company, (Spokane, WA) to do all work, furnish all labor, materials, tools, construction equipment, transportation, supplies, supervision, organization and other items of work and costs necessary for the proper execution and completion of the work described in the specifications entitled Emergency Resolution No. 2015-0055—not to exceed \$150,000. (OPR 2015-0551)

Consultant Agreement with LSB Consulting Engineers, (Spokane, WA) for Combined Sewer Overflow structural engineering—\$650,000. A Management Reserve Fund of \$65,000 which is 10% of the contract amount will be set aside. (OPR 2015-0552 / RFQ 4125-15)

Amendment No. 2 to Interlocal Agreement with Spokane County for transfer and disposal of solid waste and purchase of transfer stations. (OPR 2014-0060)

Amendment No. 1 to Contract with American Traffic Safety (Tempe, AZ) for reduced rate on Fixed Site Speed Zone Camera to be installed in 2015—\$35,200 and 2016—\$105,600. (OPR 2008-0120)

Extension No. 3 to Contract with Inland Environmental Resources Inc., (Spokane, WA) to supply Magnesium Hydroxide to the Riverside Park Water Reclamation Facility for effluent pH adjustment from July 1, 2015 through June 30, 2016, estimated cost—\$528,499.40. (OPR 2014-0461)

Report of the Mayor of pending claims and payments of previously approved obligations, including those of Parks and Library, through June 15, 2015, total \$5,667,091.85 (Check Nos. 510383-510804; ACH Payment Nos. 18779-18909), with Parks and Library claims approved by their respective boards. Warrants excluding Parks and Library total \$5,539,662.18. (CPR 2015-0002)

City Council Meeting Minutes: June 8, 2015. (CPR 2015-0013)

Purchase and Sale Agreement with North Gorge Residential Partners LLC and Greenstone Corporation for Kendall Yards 5th Addition Tendered Improvements—\$612,032.93. (OPR 2015-0555) (Clerical Note: Prior to the meeting, Council Members received an updated version of the Purchase and Sale Agreement which reflected an adjusted dollar amount from \$660,234.78 to \$612,032.93. The dollar amount reflected on the Council's June 22 Current Agenda was \$660,234.78; however, upon reading the Current Consent Agenda items into the record, the City Clerk read the correct updated dollar amount of \$612,032.93.)

(Note: Council Member Fagan indicated he missed requesting that Item No. 10—Amendment No. 1 to Contract with American Traffic Safety—be taken separately, and that is the reason for voting “no” on the Consent Agenda items.)

Contract Extension with Greater Spokane Incorporated (OPR 2014-0295) (taken separately)

Council Member Snyder stated he is against the idea of paying for open ended recruitment services and feels it's an outdated way of doing economic development. He further stated the City should be recruiting on targeted areas or doing entrepreneurial programs, which he feels pay off a lot better than open ended recruitment. However, Council Member Snyder noted that is not the reason he is against the Contract Extension. He stated treating an economic development contract the way we would a labor contract in effect that is in force and incurring expense for the City if we don't have a new contract in place is a bad precedent and sets a bad practice. He further stated if the City doesn't have an economic development contract in place, the contract should just end when the term ends and it shouldn't be considered an open-ended expense that the City is incurring, and so that is why he will be voting against this time. Subsequent to additional Council commentary, the following action was taken:

Upon 6-1 Voice Vote (Council Member Snyder voting “no”), the City Council **approved** Contract Extension with Greater Spokane Incorporated to continue Business Recruitment Services through June 30, 2015, while completing the Request for Proposal process—\$28,220.

Executive Session/Council Recess

The City Council adjourned to an Executive Session at 3:54 p.m. to discuss labor negotiations for 15 minutes. Assistant City Attorney Erin Jacobson and Council's Policy Advisor Brian McClatchey were present during the Executive Session. The City Council reconvened at 6:00 p.m. for the Legislative Session, with Council President Stuckart and Council Members Allen, Fagan, Mumm, Snyder, Stratton, and Waldref present. Council's Policy Advisor Brian McClatchey and City Clerk Terri Pfister were also present.

LEGISLATIVE SESSION

Pledge of Allegiance

The Pledge of Allegiance was led by Council President Stuckart.

Roll Call

On roll call, Council President Stuckart and Council Members Allen, Fagan, Mumm, Snyder, Stratton, and Waldref were present.

There were no **Appointments**.

There were no **City Administration Reports**.

Public Works Committee

Council Member Waldref reported on the Public Works Committee meeting held earlier today (June 22). Minutes of the Public Works Committee meetings are filed with the City Clerk's Office and are available for review following approval by the Public Works Committee.

OPEN FORUM

Rick Bocook commented on chalk art and people getting away with calling the police with false accusations.

Gabriel Elliot commented on meditation that occurs at 29th and Bernard on Sundays and made various other remarks.

George McGrath commented on stewardship of the citizens' money and expressed that the installation of a push button cross way at the corner of 17th or 18th and Grand Boulevard is a waste of time, effort, and money.

Henry Valder requested a moment of silence for the people who lost their life during prayer. In addition, he commented on his service dog Bear, homelessness, and presented other comments.

LEGISLATIVE AGENDA

EMERGENCY BUDGET ORDINANCE

Emergency Budget Ordinances C35273

Subsequent to and opportunity for public testimony, with no individuals requesting to speak, the following action was taken:

Upon Unanimous Roll Call Vote, the City Council **passed Emergency Budget Ordinance C35273** amending Ordinance No. C35185 passed the City Council November 24, 2014, and entitled, "An Ordinance adopting the Annual Budget of the City of Spokane for 2015, making appropriations to the various funds, departments and programs of the City of Spokane government for the fiscal year ending December 31, 2015, and providing it shall take effect immediately upon passage," and declaring an emergency and appropriating funds in:

Continuum of Care Fund

FROM: Housing & Urban Development, \$3,530,580,
TO: Contractual Services, same amount;

and

Community Development Fund

FROM: Various Accounts, \$4,886,921,
TO: Various Accounts, same amount;

and

Human Services Grants Fund (Essential Needs Grant)

FROM: Housing & Urban Development, \$268,994;
TO: Contractual Services, same amount.

(This action increases the Community Housing and Human Services budget by \$8,686,495 for 2015 grant awards.)

There were no **Emergency Ordinances**.

RESOLUTIONS**Resolution 2015-0060 (CR: OPR 2015-0554)**

Subsequent to an opportunity for public testimony, with no individuals requesting to speak, the following action was taken:

Upon Unanimous Roll Call Vote, the City Council **adopted Resolution 2015-0060** declaring Huber Escamax perforated plate screen system a sole source provider and authorizing the purchase and installation of replacement parts from Huber Technology Inc. without public bidding and authorizing contract—\$414,187.70 (incl. tax).

Resolution 2015-0061

Subsequent to an overview of Resolution 2015-0061 by Council Member Snyder, public testimony from one individual, and Council commentary, the following action was taken:

Upon 6-1 Roll Call Vote (Council Member Fagan voting “no”), the City Council **adopted Resolution 2015-0061** regarding approval of projects recommended by the Parking Advisory Committee.

FINAL READING ORDINANCES**Final Reading Ordinance C35272**

Council Member Snyder provided an overview of Final Reading Ordinance C35272. Police Officer Teresa Fuller noted that effective July 1, all the standard fees for traffic enforcement will go up and she stated the base fee will go up to \$136. She suggested the photo enforcement for photo red also match that amount. Officer Fuller noted the current code says \$124 and that should be adjusted to the State standard. Subsequent to public testimony from one individual, Council discussed deferring the ordinance for one week in order to make the proposed change to the ordinance (to match the State standard). Subsequently, the following action was taken:

Motion by Council Member Snyder, seconded by Council Member Waldref, **to defer** Final Reading Ordinance C35272—relating to the use of automated traffic safety cameras for school speed zones—for one week (to June 29, 2015,) ; **carried unanimously**.

FIRST READING ORDINANCES**First Reading Ordinance C35274**

Council President Stuckart suggested First Reading Ordinance C35274 be deferred for six weeks in order to send it to negotiations. Council Member Snyder presented a motion to defer the ordinance in order to give the Administration a chance to speak with the bargaining units about the impact of this ordinance. Subsequently, the following action was taken:

Motion by Council Member Snyder, seconded by Council Member Allen, **to defer** First Reading Ordinance C35274—Relating to the process for filling vacancies in the position of police ombudsman;

amending SMC section 04.32.080 and SMC section 04.32.090—for six weeks to give some time for that dialogue (between Administration and the bargaining units) to occur; **carried unanimously**.

(Clerical Note: The deferral of Ordinance C35274 for six weeks falls on Monday, August 3, 2015. The City Council meeting for August 3 has been canceled. Therefore, the matter is instead deferred to Council's August 10, 2015, Agenda.)

There were no **Special Considerations**.

HEARINGS

Hearing on Remaining Portion of Vacation Relating to the West 17 Feet of Madison Street (deferred from June 15, 2015, Agenda)

Council President Stuckart stated that staff has requested Council table indefinitely this matter. Subsequently, the following action was taken:

Motion by Council Member Allen, seconded by Council Member Fagan, **to table indefinitely** the Hearing on the remaining portion of vacation relating to the West 17 feet of Madison Street from the South line of 2nd Avenue to the North line of 3rd Avenue; **carried unanimously**. (Note: The portion of this vacation relating to the alleys was approved, subject to conditions, by City Council on May 18, 2015, and the first reading of Ordinance C35262 was also held at that time, with further action deferred.)

Following the above action, Council Member Snyder noted that staff has asked Council to table the matter at the request of the business owner who is withdrawing it.

Hearing on Resolution 2015-0057 relating to the Six-Year Comprehensive Street Program, 2016-2021 (CR: PRO 2015-0017)

The City Council held a hearing on Resolution 2015-0057 relating to the Six-Year Comprehensive Street Program, 2016-2021. Brandon Blankenagel from Capital Management provided an overview of the Six-Year Comprehensive Street Program, 2015-2021.

Council Member Snyder presented an amendment to the Six-Year Comprehensive Street Program. He indicated it (the amendment) would be a project under the bond program chapter and the project name would be this: 2016-2017 ADA Grant Replacement Project, and Project Description: A two-year ADA ramp replacement project to construct missing ramps within the Downtown and Council District areas. Initial locations have been identified on the attached list for 2016 that we've come up with. 2017 projects will be identified by 2016 utilizing the similar process of working with Council members to help identify project locations. Final projects will be selected based on the results of preliminary engineering and available funds. The intent is to balance the work within the Downtown area and the area of Council Districts. Subsequently, the following action was taken:

Motion by Council Member Snyder, seconded by Council Member Fagan, **to add** that project (as described by Council Member Snyder); **with friendly amendment** by Council Member Waldref and accepted by Council Members Snyder and Fagan, that 2017 projects will be identified by utilizing a similar process working with Council members and the Pedestrian Master Plan. Motion **carried unanimously**.

(Regarding the "attached list for 2016," see Attachment 1 to these minutes.)

Subsequent to public testimony from one individual and additional Council commentary, the following action was taken:

Upon Unanimous Roll Call Vote, the City Council **adopted Resolution 2015-0057** relating to the Six-Year Comprehensive Street Program, 2016-2021, **as amended**.

SECOND OPEN FORUM

Allen McDowell commented on fee for services and insurance companies.

Laura Carder commented on government subsidies, taxation and regulation.

ADJOURNMENT

There being no further business to come before the City Council, the Regular Legislative Session of the Spokane City Council adjourned at 7:06 p.m.

SPOKANE CITY COUNCIL
Thursday, June 18, 2015**

A Special Meeting of the Spokane City Council was held on the above date at 4:00 p.m. in the City Council Briefing Center, Lower Level – City Hall, 808 West Spokane Falls Boulevard, Spokane, Washington.

The purpose of the special meeting was for the City Council to hold a Special Legislative Session.

SPECIAL LEGISLATIVE SESSION

Pledge of Allegiance

Council President Stuckart led the Pledge of Allegiance.

Roll Call

On roll call, Council President Stuckart and Council Members Allen, Fagan, and Stratton were present. Council Member Waldref arrived at 4:36 p.m. Council Member Mumm arrived at 3:49 p.m. Council Member Snyder was absent.

Executive Session

Following roll call, the City Council adjourned into an Executive Session at 4:02 p.m. for approximately 35 minutes to discuss personnel matters. At 4:35 p.m., Council President Stuckart announced that City Council would be in Executive Session for an additional ten minutes. Assistant City Attorneys Mike Piccolo and Erin Jacobson and Council's Policy Advisor Brian McClatchey were present during the Executive Session. The Executive Session ended at 4:40 p.m. and the City Council reconvened at that time into an open session.

Second Roll Call

On the second roll call, Council President Stuckart and Council Members Allen, Fagan, Mumm, Stratton, and Waldref were present. Council Member Snyder was absent.

SPECIAL LEGISLATIVE AGENDA

Consideration to Remove Board and Commission Members

Council President Stuckart stated he is looking for three actions during the Special Legislative Session. He noted the City Council has received a letter of resignation from Kevin Berkompas, OPO Commission Member. Council President Stuckart indicated that motion number one, for somebody to make and somebody to second, would read: "That the Council accept the resignation of OPO Commission Member Kevin Berkompas effective immediately." Subsequent to an opportunity for Council discussion, the following action was taken:

Motion by Council Member Mumm, seconded by Council Member Allen, **to so move** (that the Council accept the resignation of OPO Commission Member Kevin Berkompas effective immediately); **carried unanimously (Council Member Snyder absent).**

Council President Stuckart stated the second motion is based on Adrian Dominguez, who is a current OPO Commission Member and who is out of town without access to a computer, and he has requested an extension until next Wednesday. He noted the motion would read: "That the Council set a hearing for Wednesday, June 24, to consider the question of whether OPO Commission Member Adrian Dominguez should be removed based upon his conduct described in the June 15, 2015, report to the Whistleblower Committee and to allow Mr. Dominguez the opportunity to be heard on that question." Subsequently, the following action was taken:

Motion by Council Member Allen, seconded by Council Member Mumm, **to so move** (that the Council set a hearing for Wednesday, June 24, to consider the question of whether OPO Commission Member Adrian Dominguez should be removed based upon his conduct described in the June 15, 2015, report to the Whistleblower Committee and to allow Mr. Dominguez the opportunity to be heard on that question); **carried 5-1 (Council Member Stratton voting "no" and Council Member Snyder absent).**

Council President Stuckart then presented for consideration a third motion. He noted the Council has not heard from Commissioner Dolezal. He stated the third motion would read: "That the Council remove OPO Commissioner Rachel Dolezal effective immediately based upon her conduct described in the June 15, 2015, report to the Whistleblower Committee; namely: (a) consistent failure to perform commission member duties; (b) demonstration of a real or perceived bias, prejudice, or conflict of interest; and (c) violation of her confidentiality agreement." Subsequently, the following action was taken:

Motion by Council Member Fagan, seconded by Council Member Allen, **to so move** [That the Council remove OPO Commissioner Rachel Dolezal effective immediately based upon her conduct described in the June 15, 2015, report to the Whistleblower Committee; namely: (a) consistent failure to perform commission member duties; (b) demonstration of a real or perceived bias, prejudice, or conflict of interest; and (c) violation of her confidentiality agreement]; **carried unanimously (Council Member Snyder absent)**.

Council President Stuckart inquired if any Council Members wished to make any comments, with none heard. Council President Stuckart stated he hopes we're able to move forward quickly and rapidly in replacing OPO Commission members.

Accept Resignation of a Police Ombudsman Commission Member

City Council considered the resignation of a Police Ombudsman Commission Member Adrian Dominguez. Council President Pro Tem Snyder called for public testimony, with no individuals requesting to speak. Subsequent to Council commentary, the following action was taken:

Motion by Council Member Mumm, seconded by Council Member Waldref, **to accept** the resignation of Police Ombudsman Commission Member Adrian Dominguez; **carried unanimously (Council President Stuckart and Council Members Allen and Fagan absent)**.

The Special Legislative Session adjourned at 3:09 p.m. The City Council immediately reconvened into the Study Session portion of the Special Meeting.
