#### MINUTES OF SPOKANE CITY COUNCIL

Monday, June 29, 2015

#### **BRIEFING SESSION**

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Chambers in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

#### Roll Call

On roll call, Council President Stuckart and Council Members Allen, Fagan, Mumm, Snyder, and Stratton were present. Council Member Waldref arrived at 3:32 p.m.

Council's Policy Advisor Brian McClatchey and City Clerk Terri Pfister were also present on the dais.

#### Advance Agenda Review

There was no Advance Agenda to review since the City Council's regularly scheduled meeting on July 6, 2015, is canceled.

#### ADMINISTRATIVE SESSION

#### **Current Agenda Review**

Council reviewed items on the June 29, 2015, Current Agenda for any changes and/or additions.

# Interdepartmental Agreement Between the City's Utilities, Finance, and Business & Developer Services Divisions (OPR 2015-0561)

Council President Stuckart noted there were some minor changes made to the Interdepartmental Agreement. He requested a motion to replace the agreement on file with the agreement with changes. Subsequently, the following action was taken:

**Motion** by Council Member Fagan, seconded by Council Member Mumm, **to so move** (to replace the agreement on file with the agreement with changes); **carried unanimously (Council Member Waldref absent).** 

#### Set Hearing before City Council on Proposed Initiative No. 2015-1 Petitions (LGL 2014-0023)

Council President Stuckart noted there is a request to move Current Consent Agenda Item No. 11—Setting Hearing before City Council for Monday, July 13, 2015, on Proposed Initiative No. 2015-1 petitions filed on behalf of Jackie Murray, sponsor, relating to immigration status information—to the Legislative Agenda. He further noted he would make a statement that, with respect to testimony tonight, the Council is just setting the hearing and not doing anything more than that.

#### Parking Lot Lease Agreement Amendment (OPR 2005-0440)

At the request of Council, Dave Steele of Asset Management explained the change made to the Parking Lot Lease Agreement Amendment related to Spokane Transit Authority and the under I-90 parking currently used for the Eastern Washington Park and Ride. He noted the Agreement has been updated to reflect appropriate current language, and the language now reflects CPI not to exceed four percent. Subsequently, the following action was taken:

**Motion** by Council Member Fagan, seconded by Council Member Allen, **to accept** the new version (of the agreement as filed with the City Clerk's Office on June 25); **carried unanimously.** 

#### **CONSENT AGENDA**

Upon motion of Council Member Fagan, seconded by Council Member Allen, Council unanimously approved Staff Recommendations for the following:

Purchases from Freedom Truck Centers (Spokane, WA) for the City of Spokane Fleet Services Department for:

- a. Installation of a heavy duty platform, storage bins, HD ICC Bumper, crane and outriggers, as a replacement unit for the Water Department—\$172,949.09. (OPR 2015-0556 / BID 4135-15)
- b. Installation of one custom fabricated platform/hoist and winch with accessories as a replacement unit for the Parks Department—\$60,604.60. (OPR 2015-0557 / BID 4136-15)

Contract Amendment with Moloney & O'Neill Life, Inc. (Spokane, WA) for benefit insurance broker services effective July 1, 2015 through June 30, 2017—Annual fee: \$135,000. (OPR 2012-0526 / BID 3854-12)

Loan Agreement and other documents with Volunteers LIHTC LLC (Spokane, WA) for construction of VOA 2nd Avenue, a 51-unit apartment building at 217 East 2nd Avenue—\$1,100,000 HOME funds. (East Central neighborhood) (OPR 2015-0560)

Interdepartmental Agreement (as revised) between the City's Utilities, Finance, and Business & Developer Services divisions regarding the use of the right of way system for managing stormwater and accommodating water and wastewater utility infrastructure needs. (OPR 2015-0561)

Parking Lot Lease Agreement Amendment (as revised) related to Spokane Transit Authority and the under I-90 parking currently used for the Eastern Washington Park and Ride through May 10, 2021. (OPR 2015-0440)

#### **Executive Session/Council Recess**

The City Council adjourned at 3:36 p.m. No Executive Session was held. The City Council reconvened at 6:00 p.m. for the Legislative Session, with Council President Stuckart and Council Members Allen, Fagan, Mumm, Snyder, Stratton, and Waldref present. Council's Policy Advisor Brian McClatchey and City Clerk Terri Pfister were also present.

#### **LEGISLATIVE SESSION**

#### Pledge of Allegiance

The Pledge of Allegiance was led by Council President Stuckart.

#### Roll Call

On roll call, Council President Stuckart and Council Members Allen, Fagan, Mumm, Snyder, Stratton, and Waldref were present.

There were no **City Administration Reports**.

#### COUNCIL COMMITTEE REPORTS

#### Community, Health, and Environment Ad Hoc Committee

Council President Stuckart reported on the new Community, Health, and Environment Ad Hoc Committee Meeting that was held earlier today. He noted the Council may be holding this meeting monthly from now on, on the third Monday of the month.

#### Association of Washington Cities (AWC) Conference

Council Member Allen briefly reported on the AWC Conference he attended last week.

#### **APPOINTMENTS**

#### Spokane Public Library Board (CPR 1981-0400)

Upon Unanimous Roll Call Vote, the City Council confirmed the appointment of Vickie Williams to the Spokane Public Library Board of Trustees for a term of June 29, 2015, to March 31, 2020.

#### **OPEN FORUM**

Scott Cooper, Cheryl McDaniel, and Joann Pena expressed comments in support of a sick and safe leave policy.

Ryan Park expressed concerns regarding Uber and enforcement of the City's rules and the contract that was signed.

Alfredo Llamedo remarked on racism and biased free policing.

**Tim Benn** commented on the requirement of providing proof of lawful or permanent residency or U.S. citizenship when applying for and/or renewing a commercial driver's license.

**Bill Boomer** commented on the State Legislature's passage of (SB) 5550 requiring all Uber and Lyft drivers to license cars with the State of Washington, a \$55 fee; obtain a UBI (unified business identifier) number, a \$110 fee; and have commercial insurance for the whole period of time they are in their car.

**George McGrath** remarked on requiring businesses to provide days off and he spoke about the responsibility of government officials.

**Mike Noder** commented on a town hall meeting with the Sheriff and expressed concern with the time it is taking to obtain a copy of the bicycle incident report from a year ago, and he spoke about police oversight.

Steve Black read a portion of the Declaration of Independence, and he commented on government usurping its authority.

Alan McDowell commented on Memory Programs LLC.

#### **LEGISLATIVE AGENDA**

#### **EMERGENCY BUDGET ORDINANCES**

#### Emergency Budget Ordinances C35275, C35276, and C35277

Council President Stuckart referenced Ordinance C35277 where it says "action mitigates the North/South Freeway by working with the Public Development Authority." He noted it may not be the PDA in the end that purchases the land, and stated he talked to two board members of the PDA earlier today (June 29). Council President Stuckart indicated the action that is being taken is putting the money into Asset Management and Land Acquisition.

Subsequent to an opportunity for public testimony, with one individual speaking on Emergency Budget Ordinance C35275 and one individual speaking on Emergency Budget Ordinance C35276, and Council commentary, the following action was taken:

**Upon Unanimous Roll Call Vote,** the City Council **passed** the following Emergency Budget Ordinances amending Ordinance No. C35185 passed the City Council November 24, 2014, and entitled, "An Ordinance adopting the Annual Budget of the City of Spokane for 2015, making appropriations to the various funds, departments and programs of the City of Spokane government for the fiscal year ending December 31, 2015, and providing it shall take effect immediately upon passage," and declaring an emergency and appropriating funds in:

**ORD C35275** General Fund

FROM: Unappropriated Reserves, \$25,000;

TO: Parks & Recreation, \$25,000;

and

Parks and Recreation Fund

FROM: Transfer from General Fund, \$25,000;

TO: Contractual Services, \$25,000.

(This action appropriates funding for a study of the area around Corbin Art Center to allow for a bike and pedestrian pathway that connects the central portion of the South Hill to Downtown.)

ORD C35276 General Fund

FROM: Unappropriated Reserves, \$25,000; TO: Transfer to Golf Fund, \$25,000;

and

Golf Fund

FROM: Transfer from General Fund, \$25,000;

TO: Advertising, \$25,000.

(This action provides a one-time transfer for marketing the City's golf courses/programs to increase rounds of play and introduce new people to golf.)

ORD C35277 General Fund

FROM: Unappropriated Reserves, \$45,000;

TO: Asset Management, \$45,000;

and

Asset Management Fund

FROM: Transfer from General Fund, \$45,000;

TO: Land Acquisition, \$45,000.

(This action mitigates the impacts of the North/South Freeway by working with the Public Development Authority to purchase a lot in Hillyard via an intergovernmental arrangement.) (Note: See Council President Stuckart's comments above in reference to the PDA.)

There were no **Emergency Ordinances**.

#### **RESOLUTIONS**

#### **Resolution 2015-0062**

Subsequent to an opportunity for public testimony, with no individuals requesting to speak, the following action was taken:

**Upon Unanimous Roll Call Vote**, the City Council **adopted Resolution 2015-0062** relating to Assessment Segregation relating to LID No. 2011082, for the improvement of 15th Avenue from Chestnut Street to Inland Empire Way; 14th Avenue from Chestnut Street to Inland Empire Way; and to segregate County Assessor's Parcel Numbers 25251.0621 in the amount of \$5,958.95 and 25251.0622 in the amount of \$6,213.13.

#### FINAL READING ORDINANCES

#### Final Reading Ordinance C35258 (Deferred from June 15, 2015, Agenda)

Council Member Fagan requested the Council accept a revised version of Final Reading Ordinance C35258. Subsequently, the following action was taken:

**Motion** by Council Member Fagan, seconded by Council Member Allen, **to accept revised version** of Final Reading Ordinance C35258 [as filed with the City Clerk's Office earlier today (June 29)]; **carried 6-1 (Council Member Mumm voting "no")**.

Subsequent to public testimony and Council commentary, the following action was taken:

Motion by Council Member Mumm, seconded by Council Member Snyder, to defer to July 13, 2015, the Final Reading of Ordinance C35258, as amended, relating to indecent public exposure; adopting a new section 10.06.050 to chapter 10.06 of the Spokane Municipal Code; carried 4-3 (Council President Stuckart and Council Member Allen and Fagan voting "no").

#### Final Reading Ordinance C35272 (Deferred from June 22, 2015, Agenda)

Council Member Snyder provided an overview of Final Reading Ordinance C35272 relating to the use of automated traffic safety cameras for school speed zones. He noted in the version of the ordinance discussed last week there was reference to the actual dollar amount for the fine. He further noted the City does not have control over the dollar amounts of the fines, and he stated they are set by the State Supreme Court. Council Member Snyder indicated the language needs to be changed to track it with the State. Subsequent to public testimony and Council inquiry and commentary, the following actions were taken:

**Motion** by Council Member Snyder, seconded by Council Member Mumm, **to amend** Ordinance C35272 to add the new language (as referenced by Council Member Snyder and as filed with the City Clerk on June 24, 2015); carried 6-1 (Council Member Fagan voting "no").

**Upon 6-1 Roll Call vote (Council Member Fagan voting "no"),** the City Council **passed Final Reading Ordinance C35272, as amended,** relating to the use of automated traffic safety cameras for school speed zones; amending SMC sections 16A.64.210 and 16A.64.220 of the Spokane Municipal Code.

There were no First Reading Ordinances.

#### **SPECIAL CONSIDERATIONS**

#### Setting Hearing on Proposed Initiative No. 2015-1 Petitions (LGL 2014-0023)

City Clerk Terri Pfister reported that proponents of Initiative No. 2015-1 filed with the City Clerk's Office petitions bearing 3,317 signatures. This constitutes 6.696 percent of the votes cast at the last general election held November 5, 2013. Ms. Pfister also presented the options available to the Council at the hearing under SMC 2.02.080 and Section 84 of the City Charter. Subsequent to Council commentary, the following action was taken:

**Upon Unanimous Roll Call Vote,** the City Council **set Hearing** (before City Council) for Monday, July 13, 2015, on Proposed Initiative No. 2015-1 petitions filed on behalf of Jackie Murray, sponsor, relating to immigration status information.

There were no **Hearings**.

#### **SECOND OPEN FORUM**

**Jackie Murray** remarked on Initiative No. 2015-1 petitions.

**Gabriel Elliot** provided an invitation to meditation on Sundays at the Bernard and 29<sup>th</sup> Spiritual Center, and he provided other remarks.

Laura Carder noted she supported those who obtained signatures for Initiative No. 2015-1, and she commented on public sector unions.

#### **ADJOURNMENT**

There being no further business to come before the City Council, the Regular Legislative Session of the Spokane City Council adjourned at 7:31 p.m.

ESTABLISHMENT OF THE MAYOR'S SALARY

ORDINANCE NO. C - 35202

An ordinance submitting a ballot proposition to the voters of the City of Spokane to amend Section 7 of the Charter of the City of Spokane relating to the establishment of the Mayor's salary.

WHEREAS, Section 5 of the Spokane City Charter created the position of Mayor as the chief executive officer of the City; and

WHEREAS, Section 7 A. of the City Charter provides that the minimum salary of the Mayor shall be an amount equal to the salary of the highest paid city employee, other than the city administrator as provided in Section 24 of the Charter; and

WHEREAS, the City Council adopted chapter 2.05 SMC, pursuant to RCW 35.21.015, to create the Salary Review Commission that would establish the base salaries of the Council President and the Council Members; and

WHEREAS, pursuant to Section 84 of the City Charter, the City Council, of its own motion, may submit to popular vote for adoption or rejection at any election, any proposed ordinance or measure, in the same manner and with the same force and effect as provided in the article for submission on petition; and

WHEREAS, pursuant to Section 125 of the City Charter, the City Council, of its own motion, may submit to popular vote for adoption or rejection at any election, proposed amendments to the City Charter; and

WHEREAS, pursuant to its authority set forth in sections 84 and 125 of the City Charter, the City Council has determined that an amendment to Section 7 of the City Charter providing that the Mayor's salary shall be established by the City's Salary Review Commission should be submitted to the voters of the City for their adoption or rejection on the August 4, 2015 scheduled primary election.

Section 1. That Section 7 of the City Charter of the City of Spokane regarding the salary of the Mayor shall be amended as follows:

#### Section 7. Salary

- A. The ((minimum)) annual base salary of the mayor shall be ((an amount equal to the salary of the highest paid city employee (other than the city administrator as provided in Section 24))) established by the City's Salary Review Commission consistent with the rules and procedures set forth in the Spokane Municipal Code and state law.
- B. The salaries of the council president and council members shall be established by ordinance adopted by the city council or pursuant to state law and may be increased or decreased from time to time. Any change in the salary for the office of council president or council member established by ordinance adopted by the city council shall not be applicable to the term then being served by the incumbent. Any change in the salary of the office of council president or council member established pursuant to state law shall become effective pursuant to the applicable state law.

Section 2. That this ordinance be submitted to the voters of the City of Spokane for their approval or rejection at the special election to be held on August 4, 2015 in conjunction with the scheduled primary election, as the following proposition:

SPOKANE MUNICIPAL COURT

ORDINANCE NO. C - 35254

An ordinance submitting a ballot proposition to the voters of the City of Spokane amending Sections 5, 6, 7 and 8 of the Spokane City Charter and adopting a new Article XVII to the City Charter, all relating to the Spokane municipal court and municipal court judges.

WHEREAS, pursuant to Section 84 of the City Charter, the City Council, of its own motion, may submit to popular vote for adoption or rejection at any election, any proposed ordinance or measure, in the same manner and with the same force and effect as provided in the article for submission on petition; and

WHEREAS, pursuant to Section 125 of the City Charter, the City Council, of its own motion, may submit to popular vote for adoption or rejection at any election, proposed amendments to the City Charter; and

WHEREAS, Sections 5, 6, 7 and 8 of the City Charter relate to the elected officials of the City and the qualifications, salaries and vacancy provisions of those officials, as currently set forth in the Spokane Municipal Code; and

WHEREAS, the City established its own municipal court pursuant to state law, which commenced operation January 1, 2009, including the appointment of three municipal court judges, as currently set forth in the Spokane Municipal Code; and

WHEREAS, the proposed amendments to Sections 5, 6, 7 and 8 of the City Charter and adoption of a new Article XVII are appropriate and necessary to provide for 1) the inclusion of the municipal court judges as elective officials of the City, 2) the qualifications, salary and vacancy provisions for municipal court judges and 3) the establishment and jurisdictional authority for the municipal court; and

WHEREAS, pursuant to its authority set forth in Sections 84 and 125 of the City Charter, the City Council has determined that amendments to Sections 5, 6, 7 and 8 of the City Charter to provide for the inclusion of the municipal court judges as elective officials of the City and the qualifications, salary and vacancy provisions for the municipal court judges, and that the adoption of a new Article XVII relating to the establishment and jurisdictional authority of the municipal court should be submitted to the voters of the City for their adoption or rejection on the August 4, 2015 scheduled primary election.

#### NOW, THEREFORE, THE PEOPLE OF THE CITY OF SPOKANE ORDAIN:

Section 1. That Section 5 of the City Charter of the City of Spokane regarding the elective officials of the City shall be amended to read as follows:

#### **Section 5. Elective Officials**

- A. The elective offices of the City shall be the mayor, council president, ((and)) six council members, and three judges of the Spokane Municipal Court. The mayor shall be the chief executive officer of the City. The city council, consisting of the council president and six council members, shall constitute the legislative body of the City. The Spokane Municipal Court, consisting of a presiding judge and two associate judges shall constitute the judicial branch of the City. They shall be elected to a term of four years each by the qualified electors of the City in the manner provided in this Charter and by the general laws of the state.
- B. The City shall be apportioned into three council districts of generally equal population, numbered one through three. Each district shall have two city council positions, numbered one and two.
- C. General municipal elections are held in November in odd-numbered years. At one such election there shall be elected the mayor, council president, and three council members in position number one; at the next, the three council members in position number two and the three judicial positions of the Spokane Municipal Court shall be elected.
- D. Candidates for city council shall be nominated and elected by the electors within each candidate's district; candidates for mayor and council president shall be nominated and elected by the electors of the entire City.

Section 2. That Section 6 of the City Charter of the City of Spokane regarding the qualifications for elective officials of the City shall be amended to read as follows:

#### Section 6. Qualifications

- A. A person must be a qualified voter of the City of Spokane and have been a resident of the City, and of the appropriate council district, for the one year immediately preceding the time of filing as a candidate for, or the time of appointment to, the office of mayor, council president, or council member. No person shall be eligible to hold the office of mayor after having served two consecutive terms as mayor. No person shall be eligible to hold the office of council president after having served two consecutive terms as council president. No person shall be eligible to hold the office of any council member in any city council district after having served two consecutive terms as a council member from any city council district. The elected offices of mayor, council president, and council member are separate elective offices each with a separate term of office and term limitation. No person shall be eligible to hold any elective city office while holding any other elective public office, nor shall any elective official of the City engage in any other capacity in city employment or office. More than one-half term shall count as a whole term.
- B. <u>In order to maintain harmony between the City Charter and the Revised Code of Washington, as provided for in RCW 3.50.057, a judge of the Spokane Municipal Court need not be a resident of the City of Spokane, but must be a resident of Spokane County, Washington.</u>

((B))C. An elected office, other than that of municipal court judge, shall be declared vacant, pursuant to Section 8(A) of this Charter, should the official cease to maintain residency in the city, and primary residency within his or her district, in the case of council members. A council member shall not be disqualified from his or her current term of office if district lines change, causing the council member to live outside his or her respective district. When this affects a current council member, that person shall be allowed to complete his or her current term of office. "Residency" for the purpose of qualifying to hold elective office means a person's permanent address where he or she physically resides and maintains his or her abode. However, no person gains residence by reason of his or her presence or loses his or her residence by reason of his or her absence while employed in the civil or military services of the state or of the United States or due to other reasons recognized by state law. Residence and voting within the limits of any territory, which has been included in, annexed to or consolidated with the city, shall be construed to be residence within the city.

Section 3. That Section 7 of the City Charter of the City of Spokane regarding the salaries for elective officials of the City shall be amended to read as follows:

#### Section 7. Salary

- A. The minimum annual salary of the mayor shall be an amount equal to the salary of the highest paid city employee (other than the city administrator as provided in Section 24).
- B. The salaries of the council president and council members shall be established by ordinance adopted by the city council or pursuant to state law and may be increased or decreased from time to time. Any change in the salary for the office of council president or council member established by ordinance adopted by the city council shall not be applicable to the term then being served by the incumbent. Any change in the salary of the office of council president or council member established pursuant to state law shall become effective pursuant to the applicable state law.
- C. The salaries of the municipal court judges shall be equal to ninety-five percent (95%) of the annual salary set by the Washington Citizens' Commission on Salaries for Elected Officials (WCCSEO) for full-time district court judges.

Section 4. That Section 8 of the City Charter of the City of Spokane regarding vacancy provisions of elective officials of the City shall be amended to read as follows:

#### Section 8. Vacancies

- A. The office of mayor, council president, or council member shall be deemed vacant because of:
  - 1. failure to qualify within ten days after certification of election or as otherwise provided by state law, or
  - 2. death. or
  - 3. resignation, or
  - 4. removal from office by recall, or
  - 5. failure to maintain residency requirement of the office, or
  - 6. absence by the council president or a council member from four consecutive regularly scheduled meetings of the city council without being excused by the council, or
  - 7. conviction of a felony, or
  - 8. incompetency judicially declared.
- B. A vacancy on the council of a council member elected by district shall be filled by the selection of a qualified person, resident in the district in which the vacancy occurs, by majority vote of the remaining members of the council. The appointee so selected holds office until the next general municipal election at which election a person is elected to the office for the unexpired term, or for the next full term, as the case may be.
- C. In the event of a vacancy in the office of mayor or council president, the members of the council may follow the procedure of Section 8(B), or they may elect one of their number to the vacant office of mayor or council president and follow the procedure of Section 8(B) to appoint a person from the district in which the vacancy occurred to the position left vacant by the person assuming the office of mayor or council president.
- D. The office of municipal court judge shall be deemed vacant because of:
  - 1. death,
  - 2. disability, or
  - 3. resignation.
- E. A vacancy of a municipal court judge shall be filled by the mayor, for the remainder of the unexpired term. The appointment shall be subject to confirmation by the city council. The appointed judge shall be qualified to hold the position of judge of the municipal court as provided in Chapter 3.50 RCW.

Section 5. That there is adopted a new Article XVII to the City Charter of the City of Spokane regarding the establishment and jurisdiction of the municipal court to read as follows:

Article XVII: Municipal Court

- Section 131 Ratification of Establishment
- Section 132 Jurisdiction

#### Section 131: Ratification of Establishment

The establishment of the Spokane Municipal Court under the provisions of Section 5A.01.010 of the Spokane Municipal Code and Chapter 3.50 of the Revised Code of Washington is hereby ratified.

#### Section 132: Jurisdiction

- A. Pursuant to RCW 3.50.020, the municipal court shall have exclusive original jurisdiction over traffic, parking, and other civil infractions arising under City ordinances; exclusive original criminal jurisdiction of all violations of City ordinances duly adopted by the City; and shall have original jurisdiction of all other actions brought to enforce or recover license penalties or forfeitures declared or given by such ordinances or by state statutes. The municipal court shall also have the jurisdiction as conferred by statute.
- B. The municipal court is empowered to forfeit cash bail or bail bonds and issue execution thereon, and in general to hear and determine all causes, civil or criminal, including traffic infractions, arising under City ordinances and to pronounce judgment in accordance therewith. So long as it participates in the program established by the administrative office of the courts pursuant to RCW 2.56.160, the municipal court shall have jurisdiction to take recognizance, approve bail, and arraign defendants held within its jurisdiction on warrants issued by any court of limited jurisdiction participating in the program.

Section 6. That this ordinance be submitted to the voters of the City of Spokane for their approval or rejection at the special election to be held on August 4, 2015 in conjunction with the scheduled primary election, as the following proposition:

This proposition will amend Sections 5, 6, 7 and 8 of the Spokane City Charter providing for the inclusion of the municipal court judges as elective officials of the City and the qualifications, salary and vacancy provisions for the municipal court judges, and will adopt a new Article XVII regarding the establishment and jurisdiction of the municipal court, all as set forth in Ordinance No. C- 35254.

## NOTICE OF REPUBLICATION ORDINANCE C35269

This is notification that an incorrect version of Ordinance C35269 (passed by City Council on June 15, 2015) was published in the June 24, 2015, issue of the *Official Gazette* (Vol. 104, Issue No. 25). The previously published version contained a clerical error in Section 4. The correct version of Ordinance C35269 is published below.

#### **ORDINANCE NO. C35269**

An ordinance approving and confirming the assessments and assessment roll for Local Improvement District No. 2012042 for Kendick Avenue from approximately 1,200 feet west of Nine Mile Road to Nine Mile Road Water Main Extension., and levying and assessing the amounts thereof, according to benefits, against the several lots, tracts and parcels of land and other property as shown on said roll; providing for the collection of said assessments and the issuance of local improvement installment notes or bonds to pay the cost and expense of said improvement; fixing the date of issue of said installment notes or bonds; and providing for delinquency penalties.

THE CITY OF SPOKANE DOES ORDAIN:

- Section 1. That the assessments and assessment roll of **Local Improvement District No. 2012042** as the same now stands, be and the same hereby are, in all things approved and confirmed.
- Section 2. That each of the lots, tracts and parcels of land and other property shown upon said roll is hereby declared to be specially benefited by said improvement in at least the amount charged against the same, and that the assessment appearing against each lot, tract or parcel of land and other property is in proportion to the several assessments appearing upon said roll. There is hereby levied and assessed against each such lot, tract and parcel of land, and other property described in said roll, the amount finally charged against the same thereon.
- Section 3. That the City Clerk is hereby directed to certify and transmit said assessment roll to the City Treasurer for collection pursuant to state law and the ordinances of the City of Spokane.
- Section 4. That said assessments shall become due and payable on **August 15, 2015**, and thereafter shall bear interest at an effective rate of three-fourths of one percent in excess of the rate at which installment notes or bonds may be sold as authorized in the next following section of this ordinance. All or any portion of any assessment may be paid without penalty or interest at any time before said date. Any portion of any assessment not paid as aforesaid shall be paid to the City Treasurer in **twenty** equal annual installments, the first of which shall be due, payable and delinquent on **August 15, 2016** and on the same day in each year thereafter, together with interest thereon. All delinquent installments, consisting of principal and interest, shall bear interest at the aforesaid rate to the date of payment of foreclosure sale and, in addition, the total of the foregoing shall be subject to a penalty, the rate and calculation of which shall be as by general ordinance prescribed.
- Section 5. That the **15th** day of **September, 2015** is hereby fixed as the date of issue of the installment notes or bonds required to be issued on account of said improvement; provided, a later date may be fixed by resolution of the City Council. No installment notes or bonds shall be issued in excess of the cost and expense of said improvement, or before the expiration of fifty (50) days from and after the date of the first publication of notice by the City Treasurer that said roll is in his/her hands for collection.
- Section 6. The City Council hereby declares its official intent under Treasury Regulation Section 1.150-2 on behalf of the City to issue bonds to finance that portion of the improvements ordered by Section 1 of **Ordinance No. C34896**, that are to be paid from assessments. The Council reasonably expects that, (a) the City will reimburse expenditures for the improvements with proceeds of such bonds, and (b) the maximum principal amount of such bonds will be **\$131,474.22**.
  - Section 7. This ordinance shall take effect and be in force from and after its passage.

#### **ORDINANCE NO. C35272**

An ordinance relating to the use of automated traffic safety cameras for school speed zones; amending SMC sections 16A.64.210, 16A.64.220 and 16A.64.240 of the Spokane Municipal Code.

WHEREAS, the City of Spokane has been using automated traffic safety cameras for the red light enforcement at two arterial intersections with traffic control signals; and

WHEREAS, additional analysis has been performed by the Police Department regarding use of automated traffic safety cameras for school speed zone enforcement, and

WHEREAS, the Police Department presented its analysis to the City Council Public Safety Committee during its meetings on January 5, 2015 and March 2, 2015, which has been submitted as part of the legislative record for this ordinance; - - Now, Therefore,

The City of Spokane does ordain:

Section 1. That SMC 16A.64.210 is amended to read as follows:

#### 16A.64.210 Authorized Use of Automated Traffic Safety Cameras

A. Law enforcement officers of the City and persons specially commissioned by the chief of police are authorized to use automated traffic safety cameras for the enforcement of RCW 46.61.050, requiring obedience to traffic control devices for stoplights for two-arterial intersection and RCW 46.61.440, requiring obedience to school speed zones.

Use of automated traffic safety cameras shall comply and be consistent with RCW 46.63.170, as well as other applicable state laws and regulations regarding automated traffic safety cameras.

B. For the purposes of this section, "automated traffic safety camera" means a device that uses a vehicle sensor installed to work in conjunction with an intersection traffic control system, a railroad grade crossing control system, or a speed measuring device, and a camera synchronized to automatically record one or more sequenced photographs, microphotographs or electronic images of the rear of a motor vehicle at the time the vehicle fails to stop when facing a steady red traffic control signal or an activated railroad grade crossing control signal, or exceeds a speed limit in a school speed zone as detected by a speed measuring device.

Section 2. That SMC 16A.64.220 is amended to read as follows:

#### 16A.64.220 Procedures of Use of Automated Traffic Safety Cameras

The use of automated traffic safety cameras is authorized for issuance of notices of infraction for violations regarding obedience to traffic control devices for stoplights at two-arterial intersection and school speeding zones and is subject to the following requirements:

- A. Use of automated traffic safety cameras is restricted to two-arterial intersections and school speeding zones only.
- B. Automated traffic safety cameras may only take pictures of the vehicle and vehicle license plate and only while an infraction is occurring. The picture must not reveal the face of the driver or of passengers in the vehicle.
- C. A notice of infraction must be mailed to the registered owner of the vehicle within fourteen days of the violation, or to the renter of a vehicle within fourteen days of establishing the renter's name and address under SMC 16A.64.240(B). The law enforcement officer issuing the notice of infraction shall include with it a certificate or facsimile thereof, based upon inspection of photographs, microphotographs, or electronic images produced by an automated traffic safety camera, stating the facts supporting the notice of infraction. This certificate or facsimile is prima facie evidence of the facts contained in it and is admissible in a proceeding charging a violation under this chapter. The photographs, microphotographs or electronic images evidencing the violation must be available for inspection and admission into evidence in a proceeding to adjudicate the liability for the infraction. A person receiving a notice of infraction based on evidence detected by an automated traffic safety camera may respond to the notice by mail.
- D. The registered owner of a vehicle is responsible for an infraction under SMC 16A.64.270(A) unless the registered owner overcomes the presumption in SMC 16A.64.270(B), or, in the case of a rental car business, satisfies the conditions under SMC 16A.64.240(B). If appropriate under the circumstances, a renter identified under SMC 16A.64.240(B)(1) is responsible for an infraction.
- E. Pursuant to RCW 46.63.170(1)(f), notwithstanding any other provision of law, all photographs, microphotographs, or electronic images prepared under this section are for the exclusive use of law enforcement in the discharge of duties under this section and are not open to the public and may not be used in a court in a pending action or proceeding unless the action or proceeding relates to a violation under this section. No photograph, microphotograph or electronic image may be used for any purpose other than enforcement of violations under this section nor retained longer than necessary to enforce this section.
- F. All locations where an automated traffic safety camera is used must be clearly marked by placing signs in locations that clearly indicate to a driver that he is entering a zone where traffic laws are enforced by an automated traffic safety camera.
  - Section 3. That SMC 16A.64.240 is amended to read as follows:

#### 16A.64.240 Notice and Disposition of Traffic Infractions

A. Infractions detected through the use of automated traffic safety cameras are not part of the registered owner's driving record under RCW 46.52.101 and RCW 46.52.120. Additionally, infractions generated by the use of automated traffic safety cameras under this section shall be processed in the same manner as parking infractions, including for the purposes of RCW 3.46.120, RCW 3.50.100, RCW 35.20.220, RCW 46.16.216, and RCW 46.20.270 (3). A notice of infraction for stoplight and school speed zone ((-,)) violations detected through the use of automated traffic safety cameras shall result in a fine ((of one hundred twenty-four dollars)) equal to the total penalty, including the base penalty plus any statutory assessments authorized under state law, for such violations otherwise detected by a police officer.

- B. If the registered owner of the vehicle is a rental car business, the police department shall, before a notice of infraction being issued under this section, provide a written notice to the rental car business that a notice of infraction may be issued to the rental car business if the rental car business does not, within eighteen days of receiving the written notice, provide to the police department by return mail:
  - 1. a statement under oath stating the name and known mailing address of the individual driving or renting the vehicle when the infraction occurred; or
  - 2. a statement under oath that the business is unable to determine who was driving or renting the vehicle at the time the infraction occurred; or
  - 3. in lieu of identifying the vehicle operator, the rental car business may pay the applicable penalty.

Timely mailing of this statement to the police department relieves a rental car business of any liability under this section for the notice of infraction.

C. Nothing in this section prohibits a law enforcement officer from issuing a notice of traffic infraction at the time a violation occurs to a person in control of a vehicle under the Washington Model Traffic Ordinance

Section 2. That in the budget of the Parks and Recreation Fund, and the budget annexed thereto with reference to the Parks and Recreation Fund, the following changes be made:

FROM: 1400-54100 Parks and Recreation Fund

99999-39710 Transfer from General Fund <u>\$ 25,000</u>

TO: 1400-54100 Parks and Recreation Fund

74210-54201 Contractual Services <u>\$ 25,000</u>

Section 3. It is, therefore, by the City Council declared that an urgency and emergency exists for making the changes set forth herein, such urgency and emergency arising from the need to provide funding for a study of the area around Corbin Art Center to allow for a bike and pedestrian pathway that connects the central portion of the South Hill to Downtown and vice versa, and because of such need, an urgency and emergency exists for the passage of this ordinance, and also, because the same makes an appropriation, it shall take effect and be in force immediately upon its passage.

#### **ORDINANCE NO C35276**

An ordinance amending Ordinance No. C-35185, passed the City Council November 24, 2014, and entitled, "An ordinance adopting the Annual Budget of the City of Spokane for 2015, making appropriations to the various funds, departments, and programs of the City of Spokane government for the fiscal year ending December 31, 2015, and providing it shall take effect immediately upon passage", and declaring an emergency.

WHEREAS, subsequent to the adoption of the 2015 budget Ordinance No. C-35185, as above entitled, and which passed the City Council November 24, 2014, it is necessary to make changes in the appropriations of the General Fund and Golf Fund, which changes could not have been anticipated or known at the time of making such budget ordinance; and

WHEREAS, Golf is off nearly 64,000 rounds of golf per year since 2000, yet Golf only budgets 1/10 percent of its overall budget to marketing; and

WHEREAS, this ordinance has been on file in the City Clerk's Office for five days; - Now, Therefore,

The City of Spokane does ordain:

Section 1. That in the budget of the General Fund, and the budget annexed thereto with reference to the General Fund, the following changes be made:

Section 2. That in the budget of the Golf Fund, and the budget annexed thereto with reference to the Golf Fund, the following changes be made:

99999-39710 Transfer from General Fund \$ 25,000
