#### MINUTES OF SPOKANE CITY COUNCIL

August 31, 2015

#### **BRIEFING SESSION**

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:34 p.m. in the Council Chambers in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

#### Roll Call

On roll call, Council President Pro Tem Snyder and Council Members Fagan, Mumm, and Stratton were present. Council Member Waldref joined the meeting via telephone at 3:45 p.m. Council President Stuckart and Council Member Allen were absent.

Council's Policy Advisor Brian McClatchey and City Clerk Terri Pfister were also present on the dais.

#### **Advance Agenda Review**

There was no Advance Agenda review since the City Council meeting on Tuesday, September 8, 2015, is canceled. (Note: Monday, September 7, 2015, is the recognized Labor Day holiday.)

#### COUNCIL COMMITTEE REPORTS

#### **Finance and Technology Committee**

Council President Pro Tem Snyder reported on the Finance and Technology Committee meeting held earlier today (August 31). Minutes of the Finance and Technology Committee meetings are filed with the City Clerk's Office and are available for review following approval by the Finance and Technology Committee.

#### **OPEN FORUM**

Bill Boomer commented on the Uber contract and stated the Uber drivers are becoming aggressive towards the taxi industry.

**Robert Lantz** also commented on Uber and there is no business license requirement and no tax liability on Uber drivers. He also commented on the "click" fraud that is going on.

**Rocky Sansanelli** stated he is with Checker Cab and remarked on an incident where an Uber driver attacked him. He commented on the false clicks that are costing money and they are unable to tell what is a real customer or what is a fake customer.

**Mara Sptizer** thanked the activists who came to her aid at the Convention Center over the weekend. She encouraged the Council to repeal the sit and lie ordinance. She also commented on preparedness issues and remarked on the fires.

**George McGrath** commented on Planned Parenthood and the selling, harvesting, and making of money from baby parts and commented it is the murdering of babies.

**Alfredo Llamedo** thanked various people and businesses for the shelter provided at the Convention Center for Native Americans as a result of the air quality being horrible. He noted activists in the community came together and really made the community shine.

**George Taylor** commented on the proposal to arm resource officers in public schools and stated in his judgment it is not a good idea for two reasons: it is ineffective and does not prevent violence from happening in schools and it sends the wrong message to young people.
