### MINUTES OF SPOKANE CITY COUNCIL

September 14, 2015

### **BRIEFING SESSION**

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Chambers in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

### Roll Call

On roll call, Council President Pro Tem Snyder and Council Members Allen, Fagan, Mumm, Stratton, and Waldref were present. Council President Stuckart was absent.

City Administrator Theresa Sanders, Council's Policy Advisor Brian McClatchey, and City Clerk Terri Pfister were also present on the dais.

### Advance Agenda Review

Council received input from staff on the September 21, 2015, Advance Agenda items.

### Action to Approve September 21, 2015, Advance Agenda

### Resolution 2015-0096 Relating to Contracting Indebtedness

**Motion** by Council Member Waldref, seconded by Council Member Fagan, **to defer** Resolution 2015-0096—relating to contracting indebtedness; providing for the issuance of up to \$5,000,000 principal amount of a Limited Tax General Obligation Bond, 2015 Series A, of the City for general City purposes to provide funds with which to pay the cost of acquiring capital assets for public purposes; fixing the date, form, maturity, interest rate, terms and covenants of the bond; authorizing the sale and delivery of the bond to the City, and providing for other matters properly relating thereto—for two weeks (to September 28, 2015); **carried unanimously (Council President Stuckart absent).**

### Pledge of Allegiance

The Pledge of Allegiance was led by Council President Pro Tem Snyder.

### Roll Call

Council President Pro Tem Snyder and Council Members Fagan, Mumm, and Stratton were present. Council President Stuckart was absent. Council Member Waldref arrived at 6:01 p.m. and Council Member Allen arrived at 6:04 p.m. Council President Stuckart was absent.

Council's Policy Advisor Brian McClatchey and City Clerk Terri Pfister were also present on the dais.

### **PROCLAMATIONS**

September 18, 2015 POW / MIA Recognition Day

Council President Pro Tem Snyder read the proclamation and presented it to Wesley Anderson. The United States National POW / MIA Recognition Day is observed across the nation on the third Friday of September each year. Many Americans take the time to remember those who were prisoners of war and those who are missing in action, as well as their families. The proclamation urges all citizens to celebrate the strength of Spokane's diversity.

September 19, 2015 Global Kidical Mass Day

Council Member Waldref read the proclamation and presented it to Bill Bender. The proclamation recognizes that the Kidical Mass Movement was started in 2008 to teach children to safely use their bikes for transportation, recreation, and fitness. The Spokefest Association has joined over 30 other cities in the United States and internationally to hold Kidical Mass rides for kids and families since 2013 to celebrate that kids are traffic too. On September 19, Spokane will be part of the first ever Global Kidical Mass where thousands of families around the world will ride together showing that cities that plan for family biking are more livable, sustainable, profitable, and fun.

September 14-18, 2015 Health and Transportation Week

Council Member Stratton read the proclamation and presented it to Heleen Dewey. The City of Spokane is pursuing the enhancement of public health and safety through the link Spokane Plan which integrates transportation and utility infrastructure to improve services citizens receive while decreasing their costs. Citizens in walkable, bike-able, transit oriented communities are more physically active, experience lower traffic-related injuries, and are less exposed to air pollution resulting in fewer overall adverse health impacts and costs. The proclamation encourages citizens to find their way to building a healthier community.

### **Public Works Committee**

### **OPEN FORUM**

**Mathew Charles Cardinale** spoke regarding Spokane's growing affordable housing crisis and formally requested that his report on the subject, as well as letters from the Spokane Low Income Housing Consortium and Spokane Human Rights Commission, to the committee of purview.

**Rick Bocook** commented on the sit and lie down ordinance and stated the law makes Spokane look unfriendly. He encouraged the City Council to get rid of the law, and stated he feels it's very degrading and inhumane and targets the homeless. In addition, he questioned why the maintenance crew keeps destroying the chalk art but leave the dirt behind.

**Alfredo Llamedo** provided some quotes from the National Law Center on Homelessness and Poverty. He commented on those that are homeless are subjected to criminal punishment because our own government fails to ensure the human right to housing.

Cherrie Barnett commented on ICIS, sanctuary city, and Planned Parenthood and provided other remarks.

Sarah Rykken remarked on quotes made by Margaret Sanger and commented on Planned Parenthood and abortion.

George McGrath commented on Planned Parenthood and the dissecting and selling of baby parts.

**Gabriel Elliot** announced there is a meditation on Sundays at the Unity Center at 29<sup>th</sup> and Bernard for peace, unity, and love under will. He noted this Sunday is Maharaja's birthday. In addition, he provided other remarks.

**Annie Griffin** provided thanks for having the courage to stand up and sue Monsanto for the poisoning of our rivers with PCBs, and she commented on GMOs and their effects, as well as provided other remarks in relation to the matters.
