# October 26, 2015

# BRIEFING SESSION

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Chambers in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

# Roll Call

On roll call, Council President Stuckart, and Council Members Fagan, Mumm, and Stratton were present. Council Members Allen, Snyder, and Waldref were absent.

City Administrator Theresa Sanders, Council's Policy Advisor Brian McClatchey, and City Clerk Terri Pfister were also present on the dais.

Council Member Waldref read the proclamation and presented it to Bill Kinyon. The proclamation urges Spokane businesses and citizens to embrace the talents and skills that individuals with disabilities bring to our work places and our community.

Council Member Mumm read the proclamation and presented it to Dr. Jeff Collins and Elizabeth DeRuyter, Providence Health Care; Mary Ann Keogh Hoss, Eastern Washington University; Angela Matson, Group Health; and Erica Hallet, Empire Health Foundation. Providence Health Care, Eastern Washington University, Empire Health Foundation, and Group Health will be holding a "Creating Healthier Communities Together" conversation On October 29 to discuss improving care through the end of life.

# CITY ADMINISTRATION REPORT

# Third Quarter Report for the Business Improvement District

Mark Richard, Downtown Spokane Partnership President, presented highlights for the Third Quarter Report for the Business Improvement District and responded to Council inquiries and comments.

As part of the report, Mr. Richard indicated that DSP is struggling with working out the relationship on the precinct in the Downtown core. He noted for those who aren't aware that last week there was an announcement that the SPD Downtown Precinct is choosing to move out of the current location that the businesses provide for them at the businesses' expense. He stated this is a concern as the lease is paid for through June of 2016. If that space is vacated early that means the businesses in the Downtown core will be paying for a vacant space and that deeply concerns the DSP on behalf of its members. He indicated the DSP is striving to have a productive meeting with the Police Chief and the Administration to try to resolve this.

# **OPEN FORUM**

Henry Valder commented on the Vets Garage, homelessness, and the Guardian Project.

**Alfredo Llamedo** quoted information from a report that came out written by the Spokane Human Rights Commission that documents laws in the City that criminalize homelessness.

**Sarah Rykken** referenced an owner of a café who was exercising her first amendment rights when she posted things on her sign and was persecuted by the NAACP. She stated nobody from the City is helping the owner out and questioned when it is okay to persecute someone for something on their sign. She also commented on the observation of council members on their cell phones and stated she has been hearing that the Council is threatening to take away the open forum.

**John Ahern** commented on a small business in conjunction with the comments provided by Ms. Rykken and stated the owner was subjected to shameful abuses by the City government, local law enforcement, the union, the Mayor, NAACP, and the Spokesman Review.

**Marshall Smith** commented that he loaned his car to an individual and 13 days later received a card in the mail stating that he violated handicap parking. He stated the card says it was mailed before it was post-dated.

George McGrath commented on murder and waste and Planned Parenthood.

**Cherrie Barnett** remarked that our forefathers loved our constitution, they loved God, and they believed in being frugal and paying their bills and having a sense of honor and morality with what made the United States of America great. She noted there are a lot of homeless in the City and a lot of things unfixed and undone on properties and streets. She asked the Council to be moral and fair and to not put so much burden on the little people.

City Planner Tirrell Black provided a presentation and overview of Final Reading Ordinance C35308 relating to application #Z1400063COMP and amending the Land Use Plan Map of the City's Comprehensive Plan from "Residential 4-10" to "Office" for 0.69 acres (30,056 square feet) located at 4610, 4617, 4618 North Maple Street; and amending the Zoning Map from "Residential Single Family" (RSF) to "Office-35" (O-35). (Applicant: GRR Family LLC) (By a vote of 6 to 0, the Plan commission recommends approval.). Subsequent to Council inquiry and comment and response by Ms. Black and the opportunity for public testimony, with no individuals requesting to speak, the following actions were taken:

Motion by Council Member Allen, seconded by Council Member Fagan, to close the hearing; carried unanimously (Council Member Snyder absent).

**Motion** by Council Member Allen, seconded by Council Member Fagan, **to defer** Council consideration and vote until next week (to November 2, 2015); **carried unanimously (Council Member Snyder absent).** 

#### Hearing on Final Reading Ordinance C35309

City Planner Tirrell Black provided a presentation and overview of Final Reading Ordinance C35309 relating to application #Z1400064COMP and amending the Land Use Plan Map of the City's Comprehensive Plan from "Residential 4-10" to "CC Core" for 0.31 acres (13,800 square feet) located at 1414 East 10th Avenue and 1415 East 11th Avenue; and amending the Zoning Map from "Residential Single Family" (RSF) to "Centers & Corridors, Type 1, Neighborhood Center" (CC1-NC). (Applicant: CCRC LLC) (By a vote of 6 to 0, the Plan commission recommends approval.) Subsequent to public testimony from two individuals, Council inquiry and debate, with commentary by Dwight Hume (agent to the applicants), Ms. Black, Interim Planning Director Louis Meuler, Council's Policy Advisor Brian McClatchey, and Assistant City Attorney James Richman, the following actions were taken:

Motion by Council Member Waldref, seconded by Council Member Mumm, to take these two parcels and make them CC-4; rejected 2-4 (Council Members Mumm and Waldref voting "aye" and Council President Stuckart and Council Members Allen, Fagan, and Stratton voting "no" and Council Member Snyder absent)).

**Motion** by Council Member Mumm, seconded by Council Member Waldref, **to continue** the hearing on Ordinance C35309; **carried unanimously (Council Member Snyder absent).** 

**Motion** by Council Member Allen, seconded by Council Member Fagan, **to defer** [Ordinance C35309 to next week (November 2, 2015)]; **carried unanimously (Council Member Snyder absent).**

# CITY OF SPOKANE PUBLIC NOTICE

Public notice is hereby given pursuant to RCW 35.21.157 that the City of Spokane Solid Waste Disposal Department is implementing a 2.9% rate increase in the tipping fee (from \$102.39 per ton to \$105.36 per ton at the Waste to Energy Facility) for solid waste. The minimum fee for solid waste will be increased from \$15.67 per transaction to \$16.12 per transaction.

The rate for clean green yard waste will increase 2.9% (from \$48.35 per ton to \$49.76 per ton). The minimum fee for Clean Green Yard Waste will increase from \$5.15 per transaction to \$5.30 per transaction.

New rates are effective January 1, 2016.

# ORDINANCE NO. C35305

An ordinance vacating a portion of Grandview Avenue north of 17th Avenue and east of 'D' Street, more specifically described below in Section 1;

WHEREAS, Per RCW 35.79.010, City Staff wishes to initiate by resolution the vacation of a portion of Grandview Avenue and;

WHEREAS, the City Council has found that the public use, benefit and welfare will best be served by the vacation of said public way; -- NOW, THEREFORE,

The City of Spokane does ordain:

Section 1. That the following land described below is hereby vacated. Parcel number not assigned.

Commencing at the southwest corner of Lot 8 of Amended Plat of Block 1 City View Addition; thence along the southerly line of said Amended Plat and the recorded northerly right-of-way of Grandview Avenue, S68°25'00"E, 3.61 feet, to a point of curvature, said point being the true point of beginning for this vacation; thence continuing along said southerly line of Amended Plat and said northerly right-of-way, S68°25'00"E, 327.81 feet, to its intersection with the existing northerly right-of-way of 17th Avenue, also being the southerly angle point of Lot 2 of said Amended Plat; thence along said northerly right-of-way of 17th Avenue, S89°19'27"W, 158.40 feet, to its intersection with said recorded southerly right-of-way of Grandview Avenue; thence, along said recorded southerly right-of-way of Grandview Avenue, said recorded southerly right-of-way of Grandview Avenue; thence, along said recorded southerly right-of-way of Grandview Avenue N68°25'00"W, 88.39 feet, to its intersection with the easterly 60 foot right-of-way, being in a curve, as calculated from the existing centerline location of Grandview Avenue travelled surface; thence along said calculated easterly right-of-way, through a curve to the left, having a delta angle of 65°45'24", a curve length of 116.83 feet, and a radius of 101.80 feet, (chord bears N35°32'18"W, 110.53 feet), to a point of tangency and the point of beginning. Said point being the terminus of this vacation description.

Section 2. An easement is reserved and retained over and through the entire vacated area for the utility services of Avista Utilities, Qwest, Comcast and the City of Spokane to protect existing and future utilities.

# Passed by City Council October 26, 2015 Delivered to Mayor October 29, 2015

# ORDINANCE NO.C35311

AN ORDINANCE relating to junk vehicle abatement and related fees; amending SMC section 10.16.070, and adopting new section 10.16.045 to chapter 10.16 of the Spokane Municipal Code.

Section 1. That SMC section 10.16.070 is amended to read as follows:

Section 10.16.070 Removal and Disposal – Costs – Liens

- A. After notice has been given of the City's intent to dispose of the vehicle <u>through the notice of abatement</u> or after the appeal hearing has been held, resulting in authority to remove, the vehicle or part thereof shall be removed at the request of a law enforcement officer or limited commission officer and disposed of to a licensed motor vehicle wrecker or hulk hauler with notice to the Washington State patrol and the state department of licensing that the vehicle has been wrecked.
  - 1. Any vehicle or part thereof impounded pursuant to this chapter shall be processed in accordance with the laws of the State of Washington.
- B. Any registered disposer under contract of the City for the impounding of vehicles shall comply with any administrative regulations relative to the handling and disposing of vehicles as may be promulgated by the local authority or the director.
- C. ((Failure to remove as a result of a hearing examiner order may result in a class I civil infraction. Costs of removal may be assessed against the registered owner of the vehicle if the identity of the owner can be determined, unless the owner in the transfer of ownership of the vehicle has complied with RCW 46.12.101, or the costs may be assessed against the owner of the property on which the vehicle is stored, subject to SMC 10.16.060.))
- <u>DC.</u>The impounding of a vehicle shall not preclude charging the violator with any violation of the law on account of which such vehicle was impounded.
- ED. In addition to, or in lieu of, any other state or local provisions for the recovery of costs, the City may, after removal of a vehicle under this chapter, file for record with the County auditor to claim a lien for the cost of removal and any and all outstanding fines and collection costs, which shall be in substance in accordance with the provision covering mechanics' liens in chapter 60.04 RCW, and said lien shall be foreclosed in the same manner as such liens.

Section 2. That there is adopted a new section 10.16.045 to chapter 10.16 SMC to read as follows:

# Section 10.16.045 Failure to Remove Junk Vehicle

- A. Failure to remove the junk vehicle as outlined in the notice of abatement may result in a class I civil infraction, and/or the removal and disposal of the vehicle at the expense of the owner of the land upon which the vehicle is located. Additional fees may be assessed against the registered owner of the vehicle or the owner of the land upon which the vehicle is located, by the City or its designee, for all costs required to abate the nuisance per SMC 10.16.040 (D)(7).
- B. Failure to remove the junk vehicle as a result of a appeal to the hearing examiner may result in a class I civil infraction.
