



MINUTES OF SPOKANE CITY COUNCIL

November 9, 2015

BRIEFING SESSION

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Chambers in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

Roll Call

On roll call, Council President Stuckart and Council Members Allen, Fagan, Mumm, Stratton, and Waldref were present. Council Member Snyder was absent.

City Administrator Theresa Sanders, Council's Policy Advisor Brian McClatchey, and City Clerk Terri Pfister were also present on the dais.

Advance Agenda Review

Council received input from staff on the November 16, 2015, Advance Agenda items.

Action to Approve November 16, 2015, Advance Agenda

Following staff reports and Council inquiry and discussion regarding the November 16, 2015, Advance Agenda items, the City Council took the following action (pursuant to Council Rule 2.1.2):

The City Council adjourned at 3:57 p.m. No Executive Session was held. The City Council reconvened at 6:00 p.m. for the Regular Legislative Session.

LEGISLATIVE SESSION

Pledge of Allegiance

The Pledge of Allegiance was led by Council President Stuckart.

Roll Call

Council President Stuckart and Council Members Allen, Fagan, Mumm, Stratton, and Waldref were present. Council Member Snyder was absent.

Council's Policy Advisor Brian McClatchey and City Clerk Terri Pfister were also present on the dais.

PROCLAMATIONS

November 14, 2015 *Quit Day* Council Member Allen read the proclamation and presented it to Lindsey Ruivivar from CHAS Health. The proclamation encourages citizens to support tobacco cessation in our communities and cessation resources.

November 13, 2015 *Pancreatic Cancer Day*

Council Member Mumm read the proclamation and presented it to a representative of the Pancreatic Cancer Action Network – Inland Northwest. The proclamation notes that pancreatic cancer is the only major cancer with a five-year relative survival rate in the single digits at just six percent. The good health and well-being of the residents of Spokane are enhanced as a direct result of increased awareness about pancreatic cancer and research into early detection, causes and effective treatments.

COUNCIL SALUTATION

Recognition of Fire Department - Involvement in the Northwest Wildlife Fires

Council President Stuckart read the salutation in recognition of the Spokane Fire Department and their involvement in the Northwest wildlife fires. The salutation notes the Spokane Fire Department firefighters spent more than 4,000 hours working the wildfires on behalf of the City of Spokane and the State of Washington. The Salutation salutes the Spokane Fire Department and recognized several firefighters for their incredible support of the state wildfire incidents on behalf of the City of Spokane.

RECOGNITION OF VETERANS

Council President Stuckart noted that Veterans Day is Wednesday and he saluted all of the veterans.

APPOINTMENT

Upon Unanimous Voice Vote (Council Member Snyder absent), the City Council **approved** (and thereby confirmed) the appointment of Francis SiJohn to the United Native Americans of Spokane Public Development Authority for a term of November 9, 2015, to April 30, 2017.

COUNCIL COMMITTEE REPORTS Public Works Committee

Council Member Waldref reported on the Public Works Committee meeting held earlier today (November 9). Minutes of the Public Works Committee meeting are filed with the City Clerk's Office and are available for review following approval by the Public Works Committee.

OPEN FORUM

Rick Bocook commented on the sit and lie ordinance and commented on a friend of his who has received two tickets for sitting down and he noted both of them have been dismissed. In addition, he shared another incident regarding his friend sitting down.

Alfredo Llamedo thanked Council Member Stratton and her assistant Skyler Oberst for their actions in the past week during the crises in West Central. He also congratulated the owner of the properties in West Central because he saw the need, responded to it and is acting responsibly. He stated what we need in the City is a law just like they have in Seattle for just cause eviction. Council President Stuckart noted that having the just cause in place wouldn't have stopped or changed the action at all, and he noted that Council Member Stratton is working on the matter.

Mara Spitzer provided remarks on behalf of Deb Conklin who asked that Council Member Stratton and her legislative aide Skyler Oberst be thanked for picking up and taking action on the evictions in West Central. She stated the City needs an ordinance that requires any developer who evicts a tenant in order to remodel or tear down a building to deliver a check refunding deposits along with notice to vacate.

George Baker thanked City Council for allowing public comment. He remarked on a concern he has in regards to Sarff Investments' purchase of the City block in the West Central Neighborhood.

Marshall Smith commented on handicap parking and noted he was charged with parking a vehicle in a handicap spot, but the person who did so allegedly has a legal placard. In addition, he thanked Council President Stuckart for mentioned Veteran's Day. He also remarked on evictions and suggested Spokane landlord tenant laws be patterned after Seattle.

Olga Lucia Herrera expressed concern about what she thinks is indifference to the increased incidents of gun violence in places our society as always considered safe, such as schools and the work place. She indicated her hope is that in Spokane we start a conversation of mass shootings, gun violence including suicide, and that we come up with ideas and actions to take and work on prevention.

George McGrath commented on Planned Parenthood. Council President Stuckart reminded Mr. McGrath that Council Rule 2.2.4 states that all matters discussed shall relate to the affairs of the City.

Mike Gifford commented on the Pedestrian Master Plan.

RESOLUTION and FINAL READING ORDINANCES

Resolution 2015-0118 and Final Reading Ordinance C35318

Subsequent to an overview by Council President Stuckart, the opportunity for public testimony, with none provided, and Council commentary, the following action was taken:

Upon 5-1 Roll Call Vote (Council Member Fagan voting "no" and Council Member Snyder absent), the City Council **adopted Resolution 2015-0118** declaring and finding a substantial need for purposes of setting the limit factor for the property tax levy for 2016 **and passed Final Reading Ordinance C35318** updating the annual City of Spokane property tax levy for 2016.

Final Reading Ordinance C35317

Subsequent to an overview by Council President Stuckart and public testimony from one individual, the following action was taken:

Upon Unanimous Roll Call Vote (Council Member Snyder absent), the City Council **passed Final Reading Ordinance C35317** relating to the vacation of misdemeanor possession of marijuana convictions in the City of Spokane; adopting new chapter 5A.17 of the Spokane Municipal Code; and adopting new sections 5A.17.010 and 5A.17.020.

FIRST READING ORDINANCES

The following ordinance was read for the first time with further action deferred:

ORD C35319 Relating to the parking system fund and Parking Advisory Committee; amending SMC section 7.08.130.

Public notice is hereby given pursuant to RCW 35.21.157 that the City of Spokane plans to increase the rates for its solid waste collection and disposal services by 2.9% on January 1, 2016. The rate increase shall apply to the disposal fees at the City's Waste to Energy Facility as well as the monthly Residential Service Rates (reference SMC 13.02.0502), Commercial Service Rates – Dumpsters (SMC 13.02.0504), Commercial Service Rates – Compactors (13.02.0510), Additional Charges for Commercial Containers (13.02.0514), Rates for Equipment and Labor – Packer and Nonpacker Trucks (13.02.0528), Recycling Rates – Nonresidential – Residential Premises with Multi-unit Dwellings Premises – Additional (13.02.0552), and Clean Green Yard Waste Collection (13.02.0554).

ORDINANCE NO. C35317

An ordinance relating to the vacation of misdemeanor possession of marijuana convictions in the City of Spokane; adopting new chapter 05A.17 of the Spokane Municipal Code; and adopting new sections 05A.17.010 and 05A.17.020

WHEREAS, 1.7 million Washingtonians, 55.7% of the voting electorate, voted to legalize recreational marijuana through state Initiative 502 in 2012; and

WHEREAS, 116,190 Spokane County voters, 52.15% of the voting electorate, voted to legalize recreational marijuana through state Initiative 502 in 2012; and

WHEREAS, 52,575 City of Spokane voters, 57.0% of the voting electorate, voted to legalize recreational marijuana through state Initiative 502 in 2012; and

WHEREAS, Initiative 502 was supported by a majority of voters in each City Council District; and

NOW THEREFORE, the City of Spokane does ordain:

Section 1. That there is adopted new chapter 05A.17 to title 05A of the Spokane Municipal Code:

Chapter 05A.17 Vacation of Misdemeanor Convictions

Section 2. That there is adopted a new section 05A.17.010 to chapter 05A.17 of the Spokane Municipal Code:

05A.17.010 Misdemeanor Vacation Rates and Data

At least annually, the Spokane Municipal Court shall include conviction vacation data, including type of conviction, rates of vacation, and number of applications, to the City Council in the usual course of providing Council updates to the Public Safety Committee.

Section 3. That there is adopted a new section 05A.17.020 to chapter 05A.17 of the Spokane Municipal Code:

05A.17.020 Vacation of Misdemeanor Possession of Marijuana Convictions

- A. Every person convicted in Spokane Municipal Court of a possession of marijuana misdemeanor under SMC 10.15.100 prior to July 8, 2014 may apply to the Spokane Municipal Court for a vacation of the applicant's record of conviction for the offense. Upon such application, the court shall vacate the record of conviction by:
 - 1. Permitting the applicant to withdraw the applicant's plea of guilty and to enter a plea of not guilty; or if the applicant has been convicted after a plea of not guilty, the court setting aside the verdict of guilty; and
 - 2. the court dismissing the information, indictment, complaint, or citation against the applicant and vacating the judgment and sentence.
- B. The City of Spokane shall inform the public of the ability of any convicted person to apply for such vacation of conviction.

ORDINANCE NO. C35318

An ordinance updating the annual City of Spokane property tax levy for 2016.

WHEREAS, the Spokane City Council, the governing body of the City of Spokane, a taxing district ("District" or "City") of the State of Washington, has met and considered its budget for the calendar year 2016, holding public hearings thereon; and

WHEREAS, the District's actual regular levy amount from the previous year (2015) was \$54,943,129.62 not including administrative refunds; and

WHEREAS, the City Council, after hearing and after duly considering all relevant evidence and testimony presented, has determined that the City of Spokane requires a regular levy as provided hereafter, as well as an EMS levy as provided hereafter, both of which include an increase in property tax revenue from the previous year, and amounts resulting from the addition of new construction and improvements to property and any increase in the value of state-assessed property, and amounts authorized by law as a result of any annexations that have occurred and refunds made, and authorized refunds, in order to discharge the expected expenses and obligations of the City and in its best interest; and

WHEREAS, the District population is more than 10,000; Now, Therefore,

The City of Spokane does ordain:

Section Regular Levy.

- A. An increase in the regular annual property tax levy is hereby authorized for the levy to be collected in the 2016 tax year, said increase to be in the amount of \$549,431.30, which is a percentage increase of 1% from the previous year's actual levy, prior to the inclusion of administrative refunds in the 2015 levy.
- B. This increase is exclusive of additional revenue in 2016 resulting from new construction, improvements to property, newly constructed wind turbines, increases in the value of state assessed property, and any annexations that have occurred and refunds made or amounts as required or permitted by law. The total regular property tax levy for 2016, including amounts estimated for new construction, annexations, refunds, and any other add-ons, is estimated at \$56,500,000 and is a percentage increase of 2.83% from the previous year's actual levy prior to the inclusion of 2015 administrative refunds. Inclusive of administrative refunds in the 2015 levy, the 2016 levy represents a 2.16% increase.

Section Existing GO Bonds.

In the case of the tax levied to raise \$5,756,700 for Principal and Interest on the City of Spokane's outstanding General Obligation Bonds, the County Assessor, in spreading the tax upon the rolls shall determine the dollar rate required.

Section EMS Levy.

Ordinance C-34568 concerning a levy for emergency medical services (EMS), passed by the Spokane City Council on March 8, 2010 and approved by the voters in the election of April 27, 2010, provides for a levy for six consecutive years beginning in 2011, with the rate in the first year being 50 cents per \$1,000 of assessed valuation.

- A. As required by RCW 84.55.120, this ordinance must specifically state the dollar increase requested, as well as the percent change from the previous year. For 2016, the City is requesting an increase of \$76,814.05 which is a 1% increase over the 2015 EMS Levy.
- B. This increase is exclusive of additional revenue in 2016 resulting from new construction, improvements to property, newly constructed wind turbines, increase in the value of state assessed property, and any annexations that have occurred and refunds made or amounts as required or permitted by law. The total EMS levy for 2016, including amounts we have estimated for new construction, annexations, refunds, and other addons, is estimated at \$7,850,000 and is a percentage increase of 2.19% from the previous year levy of \$7,681,405.36.

Section 4. Certification; Filing.

The City Council certifies all information as stated herein. Appropriate City staff is directed to transmit all required information required to the Clerk of Spokane County Board of County Commissioners and County Assessor, including budget estimates of amounts to be raised by taxation on assessed value of property (RCW 84.55.020), estimated beginning and ending cash balances (RCW 84.52.025), and the amount of taxes levied on assessed value within the

City (RCW 84.52.070). Pursuant to Section 19 of the City Charter, this measure takes effect immediately on first reading and passage.
