MINUTES OF SPOKANE CITY COUNCIL

Monday, February 22, 2016

BRIEFING SESSION

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Chambers in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

Roll Call

On roll call, Council President Stuckart and Council Members Beggs, Fagan, Kinnear, Stratton, and Waldref were present. Council Member Mumm was absent.

City Administrator Theresa Sanders, City Council's Policy Advisor Brian McClatchey, and City Clerk Terri Pfister were also present on the dais.

Executive Session/Council Recess

The City Council adjourned at 3:58 p.m. The City Council immediately adjourned into an Executive Session to discuss pending litigation for approximately 30 minutes. Assistant City Attorneys Erin Jacobson, Sam Faggiano, and Special Counsel Mike McMahon were present during the Executive Session. The City Council reconvened at 6:00 p.m. for the Regular Legislative Session, with Council President Stuckart and Council Members Beggs, Fagan, Kinnear, Stratton, and Waldref present. Council Member Mumm was absent. City Council's Policy Advisor Brian McClatchey and City Clerk Terri Pfister were also present.

LEGISLATIVE SESSION

Pledge of Allegiance

The Pledge of Allegiance was led by Council President Stuckart.

Roll Call

Council President Stuckart and Council Members Beggs, Fagan, Kinnear, Stratton, and Waldref were present. Council Member Mumm was absent.

PROCLAMATION

February 23-March 6, 2016 Northwest Bach Festival

Council Member Kinnear read the proclamation and presented it to Mr. Zuill Bailey, artistic director of the Northwest Bach Festival. The Festival brings 20 musical events to Spokane between February 23 and March 6. Mr. Bailey, as a cellist, serenaded the City Council and citizens and thanked the City of Spokane for this wonderful honor.

ADMINISTRATIVE REPORT Salary Review Report

Christy Jeffers, member of the Salary Review Commission, read a public meeting notice for the record. She noted that next Thursday, February 25, from 3:00 p.m. to 4:00 p.m. in City Hall, City conference Room Lower Level – A, there will be a Salary Review Committee meeting to hear public input on Council President and City Councilmember salaries. The Salary Review Commission is an independent body of five people who serve as volunteers for a four-year term. They may not be discharged by anyone except for things like misconduct or neglect of duty. Bob Beaumier, Chair of the Salary Review Commission (https://my.spokanecity.org/bcc/commissions/salary-review-commission), noted that the Committee has a page on the City of Spokane website which includes social media and he invited citizens to make public comment on the site or to send an email to Human Resources Director Heather Lowe (hlowe@spokanecity.org) who is the staff liaison.

COUNCIL COMMITTEE REPORTS

Public Works Committee Meeting

Council Member Waldref reported on the Public Works Committee meeting held earlier today (February 22, 2016). Minutes of the Public Works Committee meeting are filed with the City Clerk's Office and are available for review following approval by the Public Works Committee.

Smart Growth Conference Report

Council Members Kinnear and Stratton remarked on the Smart Growth Conference that they both recently attended. Council Member Kinnear noted she learned a lot and expanded her knowledge. Council Member Stratton noted she spent a lot of time in sessions relating to tiny houses and low income housing and how to expand low income housing opportunities in the community. She stated she is hoping with that knowledge Council Members can move forward with some of the organizations in town that are starting to look at tiny houses and start to talk about where we want to put them.

Report by Council Member Fagan

Council Member Fagan announced the Chief Garry Park Neighborhood is working with the City of Spokane to develop a plan for their neighborhood's future. He noted the public is invited to a meeting scheduled for this coming Wednesday, February 24, at 6:00 p.m. at Stevens Elementary, 1717 East Sinto Avenue, to assist the Chief Garry Park Neighborhood plan for things like public safety, connectivity, pedestrian and bike access, transportation land use.

Trans-Pacific Partnership Resolution

Council President Stuckart noted there is a resolution on the City Council's agenda next week for the Trans-Pacific Partnership, which is in front of Congress. He acknowledged the group of people in the audience who showed up, noting they are unable to testify as the matter is on next week's agenda.

OPEN FORUM

Bill Boomer commented on Uber and Lyft and stated they are not following all of the rules and regulations of their contract and that they have a lot of illegal activity.

Tim Benn commented that Cooper Elementary School in the Minnehaha Neighborhood has no flashing lights, and he noted he lives across the street from the school. He stated his neighborhood has experienced an extreme amount of traffic due to the north south freeway and hopes the Council will support flashing lights. He also commented that District 1 on the CTAB Board is not getting represented and he put in an application in for the Board.

Henry Valder commented on the property he had a while back and stated it is finally cleaned up and it is where his dog is buried. He stated it is a problem house and it has been made to look like it was his fault; and that it was a problem landlord before he moved in and was a problem landlord after and the record shows that.

EMERGENCY BUDGET ORDINANCE

Emergency Budget Ordinance C35364

Upon Unanimous Roll Call Vote (Council Member Mumm absent), the City Council **passed Emergency Budget Ordinance No. C35364** amending Ordinance No. C35322 passed by the City Council November 23, 2015, and entitled, "An Ordinance adopting the Annual Budget of the City of Spokane for 2016, making appropriations to the various funds, departments and programs of the City of Spokane government for the fiscal year ending December 31, 2016, and providing it shall take effect immediately upon passage," and declaring an emergency and appropriating funds in:

IT Fund General Fund

FROM: Temp Seasonal, \$132,250,

TO: Various Accounts, same amount.

(This action creates a Senior Information Security Analyst position in the IT Department effective February 29, 2016.)

EMERGENCY ORDINANCE and RESOLUTIONS

Emergency Ordinance C35366 and Resolution 2016-0021

Subsequent to a presentation by Fire Chief Bobby Williams, public testimony, and Council commentary, the following action was taken:

Upon Unanimous Roll Call Vote (Council Member Mumm absent), the City Council **passed Emergency Ordinance C35366** imposing additional regular property tax levies for emergency medical services for the years 2017 through 2022; and submitting the proposition to a special municipal election to be held on April 26, 2016, and declaring an emergency **and adopted Resolution 2016-0021** requesting the Spokane County Auditor to hold a special election on April 26, 2016 to submit a proposition regarding additional regular property tax levies for Emergency Medical Services for the years 2017 through 2022 to the electors of the City of Spokane and declaring an emergency.

Resolution 2016-0022

Subsequent to an overview of Resolution 2016-0022 by Council Member Waldref and Andre Wicks from Spokane Public Schools, public testimony, and Council commentary, the following action was taken:

Upon Unanimous Roll Call Vote (Council Member Mumm absent), the City Council **adopted Resolution 2016-0022** regarding the City of Spokane's support for a Promise Zone proposal to HUD that is focused in the neighborhoods of Northeast Spokane (East Central North of the freeway, Chief Garry Park, Logan, Minnehaha, Bemiss, Whitman, Nevada-Lidgerwood, and Hillyard).

Resolution 2016-0008

Council President Stuckart referenced a memo received on February 17, 2016, from Assistant City Attorney Mike Piccolo regarding application of an initiative sponsor's request to withdraw an initiative petition. The memo concludes that the City Council has little choice under the City Code and is required to place the issue on the ballot. Council President Stuckart requested a motion to suspend the Council Rules to add this to the agenda and to place the matter on the ballot tonight.

Motion by Council Member Kinnear, seconded by Council Member Waldref, **to suspend** the Council Rules; **carried unanimously (Council Member Mumm absent).**

Motion by Council Member Kinnear, seconded by Council Member Waldref, **to add Resolution 2016-0008** to tonight's February 22, 2016, Legislative Agenda; **carried unanimously (Council Member Mumm absent).**

There was an opportunity for public testimony, with no individuals requesting to speak, and Council commentary held. Council Member Breen suggested the municipal code be updated to specifically point out that if somebody doesn't actually strictly follow all of the requirements and signatures and things (of the Code), then the City Council can keep it off the ballot. Council President Stuckart noted that there are some proposed changes that City Council has been working on for three months. Council Member Beggs indicated he has seen the changes but stated he would like to call it out more explicitly (in the Code) that the Council has the right not to put it on (the ballot). Council President Stuckart requested that Mr. Beggs provide him, along with Mr. McClatchey, the suggested changes.

Motion by Council Member Fagan, seconded by Council Member Kinnear, **to place** Initiative No. 2015-1 on the November 2017 ballot and (thereby) **adopt** Resolution 2016-0008 requesting the Spokane County Auditor to hold a special election on November 7, 2017, in conjunction with the scheduled general election to submit to the electors of the City of Spokane a proposition regarding an amendment of the Spokane Municipal Code relating to immigration status information; carried upon **Unanimous Roll Call Vote (Council Member Mumm absent).**

For Council action on Resolution 2016-0020, see section of minutes under 3:30 p.m. Administrative Session.

There were no **Final Reading Ordinances**.

The following ordinances were read for the First Time with further action deferred:

ORD C35367 Relating to the regulation of for-hire vehicles at the Spokane Airport; and amending section 12.03.0508

of the Spokane Municipal Code.

There were no **Hearings**.

Second Open Forum

Andrew Delateur stated he is a member of the Local 14 Ironworkers and stated he was privileged to work on a project for the City of Spokane at the Wastewater Treatment Plant. He stated he heard there was going to be an expansion of that plant to the tune of \$126 million and found out that a couple of companies awarded the contract through a joint venture are not really local companies, and one of the companies has an office in Saudi Arabia and they are not union friendly companies. He remarked that maybe with a project this big a local company would have been a better choice so some of the money would have been funneled back to the community. Council President Stuckart addressed Mr. Delateur's remarks and noted that the law since then has been changed on alternative bid contracts to address this exact concern. He further noted a bigger part of the conversation today at Public Works is that out of the \$126 million project, 60 percent of that work will be done by subs, and he is in contact with local shops to be sure they are included on every single bid out for those 65 projects that will comprise 60 percent of the whole work so that it goes to local subs.

ADJOURNMENT

There being no further business to come before the City Council, the Regular Legislative Session of the Spokane City Council adjourned at 7:17 p.m.

NOTICE OF PUBLIC HEARING ON PROPOSED ANNEXATION OF SPOKANE HOUSING VENTURES ANNEXATION AREA, INCLUDING ADOPTION OF COMPREHENSIVE PLAN AND APPROPRIATE LAND USE REGULATIONS

The City of Spokane Washington proposes to annex an area otherwise known as the Spokane Housing Ventures Annexation Area. The Spokane Housing Ventures Annexation Area is an approximately 42-acre area contiguous to the City of Spokane, lying South of 53rd Avenue, West of Regal Street, and North of 55th Avenue ("Spokane Housing Ventures Annexation Area"). The Spokane Housing Ventures Annexation Area is situated in the County of Spokane, State of Washington, and is legally described as follows:

Those portions of the North ½ of Section 3, Township 24 North, Range 43 East W.M. and further described as follows:

All of lots 5-7 and portions of lots 3,4 and 8-12 of, Block 1, of The Amended Plat of South Spokane and Lot 1, Block 2, of the Plat of Hilby Station; which include the following Parcel Numbers: 34031.5201, 34031.0459, 34032.0433, 34032.0405, 34032.0432, 34032.0490, 34032.0489, 34032.0492, 34032.0481, 34032.0480, 34032.0446, 34032.0412, and 34032.0447.

The boundaries are described below:

Beginning (Point of Beginning) at the southwest corner of Lot 12, Block 1, of The Amended Plat of South Spokane, which is also the intersection of the north right-of-way line of 55th Avenue and the east right-of-way line of Regal Street; THENCE west across Regal Street to the intersection of the west right-of-way line of Regal Street and the north right-of-way line of 55th Avenue; THENCE north along said west right-of-way line of Regal Street to the intersection of the south right-of-way line of 53rd Avenue (coincident with the south limit of the City of Spokane) and the west right-of-way line of Regal Street; THENCE east along the south limit of the City of Spokane to the intersection of the east limit of the City of Spokane; THENCE east, along the same bearing as the north lot lines of Lots 5 and 6, Block 1, of The Amended Plat of South Spokane (coincident with the south limit of the City of Spokane), to the intersection of the southwest right-of-way line of the Palouse Highway; THENCE southeasterly along said southwest right-of-way line of the Palouse Highway to a point that is 9.96 feet primarily north of the northwest corner of Lot 1, Block 2, of the Plat of Hilby Station; THENCE south 00°36'08" west 9.96 feet to the northwest corner of Lot 1, Block 2, Hilby Station, said plat was filed on May 5, 1999 under Auditor's File Number 4363950; THENCE along the following (4) courses according to the above mentioned plat; THENCE

- b) southwesterly along a tangential curve to the right having a radius of 20.00 feet, 45.25 feet; THENCE
- c) southwesterly along a curve having a radius of 185 feet, and a delta angle of 08°59'49" with a chord bearing of north 85°53'42" east and a chord distance of 29.02 feet for an arc distance of 29.05 feet; THENCE

HOME FUNDS APPLICATIONS AVAILABLE

The City of Spokane seeks applicants for funding that can be used to rehabilitate, or construct rental housing on three properties currently owned by the City. The housing will be affordable to low-income households.

About \$600,000 in Federal HOME funds will be available as low-interest loans through the City of Spokane's Multifamily Housing Program. In exchange for low-cost loans with the potential for payment deferral and/or debt forgiveness, property owners must agree to rent restrictions and to rent to low-income tenants for at least 5 years for projects involving rehabilitation or 20 years for new construction projects.

Projects must meet at least one of the program priorities: housing units affordable to households earning 30% or less of the area median income ("AMI") (\$19,350 for a family of four); housing units with 3 or more bedrooms that are affordable to large households earning 50% or less of the AMI (\$32,350 for a family of four); housing units that are affordable to households with incomes at or below 50% of the AMI and are located within a City Council Targeted Investment Area and/or in areas designated as Centers and Corridors in the City's Comprehensive Land Use Plan; and/or housing units that provide Permanent Supportive Housing for chronically homeless. Rent restrictions, tenant income limits, and other requirements apply.

Applications for funding consideration may be submitted by non-profit housing organizations, the Spokane Housing Authority, and Community Housing Development Organizations, as well as for-profit developers and building owners.

An ordinance amending Ordinance No. C-35322, passed the City Council November 23, 2015, and entitled, "An ordinance adopting the Annual Budget of the City of Spokane for 2016, making appropriations to the various funds, departments, and programs of the City of Spokane government for the fiscal year ending December 31, 2016, and providing it shall take effect immediately upon passage", and declaring an emergency.

WHEREAS, subsequent to the adoption of the 2016 budget Ordinance No. C-35322, as above entitled, and which passed the City Council November 23, 2015, it is necessary to make changes in the appropriations of the IT Fund, which changes could not have been anticipated or known at the time of making such budget ordinance; and
