MINUTES OF SPOKANE CITY COUNCIL

Monday, March 13, 2017

BRIEFING SESSION

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:33 p.m. in the Council Chambers in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

Roll Call

On roll call, Council President Pro Tem Waldref and Council Members Beggs, Fagan, and Stratton were present. Council Member Kinnear arrived at 3:35 p.m. Council President Stuckart was absent.

City Administrator Theresa Sanders, City Council's Policy Advisor Brian McClatchey, and City Clerk Terri Pfister were also present on the dais.

Advance Agenda Review

The City Council received an overview from staff on the March 20, 2017, Advance Agenda items.

First Reading Ordinance C35485

Upon review of the March 20, Advance Agenda, the City Council took the following action:

Motion by Council Member Mumm, seconded by Council Member Beggs, to suspend the City Council Rules; rejected 4-1 (Council Member Fagan voting "no" and Council President Stuckart and Council Member Kinnear absent).

(Note: A motion to suspend the City Council Rules requires five affirmative votes for passage.)

(Council Member Kinnear arrived at the meeting at 3:35 p.m.)

Upon Council Member Kinnear's arrival to the meeting, the City Council took the following action:

Motion by Council Member Mumm, seconded by Council Member Beggs, **to suspend** the City Council Rules; **carried 5-1 (Council Member Fagan "no" and Council President Stuckart absent).**

Motion by Council Member Stratton, seconded by Council Member Mumm, **to add** Ordinance C35485 to First Reading on the March 20 Advance Agenda; **carried 5-1 (Council Member Fagan "no").**

Council President Waldref Pro Tem noted for the record that the actions above were taken due to an error in the date of the agenda submission item when it was sent to the Clerk's Office.

Interim City Attorney Mike Piccolo was present during the Executive Session. The City Council reconvened again at 6:00 p.m. for the Regular Legislative Session.

LEGISLATIVE SESSION

Pledge of Allegiance

The Pledge of Allegiance was led by Council President Pro Tem Waldref.

Invocation

Melissa Opel, Minister Assistant at Spokane Buddhist Temple, provided an invocation.

Roll Call

Council President Pro Tem Waldref and Council Members Beggs, Fagan, Kinnear, and Stratton were present. Council President Stuckart was absent.

City Council's Policy Advisor Brian McClatchey and City Clerk Terri Pfister were also present.

MAYORAL PROCLAMATION

March 2017 Developmental Disabilities Awareness Month

Council Member Mumm read the proclamation and presented it to Darci Ladwig, from Arc of Spokane, and her daughter Zoey. An intellectual or developmental disability affects more than 7,000 people in Spokane County and their families. People with developmental disabilities are a vibrant part of our community, improving the quality of life for all of us and public awareness about the needs of people with developmental disabilities can help Spokane become a more welcoming city. The Arc of Spokane advocates and seeks to encourage greater social inclusion of people with developmental disabilities in our community through a variety of public awareness and education initiatives. The proclamation urges the City of Spokane to give full support to efforts toward enabling people with developmental disabilities to live full and productive lives of inclusion in our community.

COUNCIL SALUTATION

Council Member Stratton noted that last week she had the pleasure of attending a celebration at Mukogawa Fort Wright. She read a salutation in recognition of Mukogawa Fort Wright Institute. The Mukogawa Fort Wright Institute was established with a mission in part to increase the American communities' reciprocal understanding of each other's culture. The Mukogawa Fort Wright Institute provides students with the support to maximize their development through its academic and residential life program. Mukogawa Fort Wright Institute strives to provide the Spokane community with cultural exchange programs by opening its doors to the public through displays and classes at the Japanese Cultural Center to over 4,000 visitors per year to advance community outreach. The City of Spokane has enjoyed a decade's long friendship with Mukogawa Fort Wright Institute most notably through the collaboration and friendship of Ed Tsutakawa and Mayor Neil Fosseen. Spokane shares a deep connection to Japan through its cherished Japanese Sister City Nishinomiya. Spokane is home to one of the last remaining original ambassador friendship dolls created in an exchange program in the '20s between the United States and Japan to spread friendship and goodwill. The Hinamatsuri celebration has been celebrated by countless generations of families and holds a special place in Spokane's celebration. The salutation salutes the Mukogawa Fort Wright Institute, and expresses friendship and support for the Inland Northwest Japanese children and families and extends sincere well wishes to all of Spokane's Japanese residents as our community marks the celebration of the Hinamatsuri holiday. A representative from Mukogawa Fort Wright Institute accepted the proclamation. Students from Mukogawa Fort Wright then performed a traditional Japanese active dance.

COUNCIL COMMITTEE REPORTS

Public Works Committee

Council Member Waldref reported on the Public Works Committee meeting held earlier today (March 13, 2017). Minutes of the Public Works Committee are filed with the City Clerk's Office and are available for review following approval by the Public Works Committee.

There were no **Boards and Commissions Appointments**.

OPEN FORUM

Andrew Caudell with Orange Cab expressed concerns regarding regulations at the Airport for cab drivers. He noted all cab drivers in Spokane are required to complete an expensive and time consuming FBI background check to pick up or

drop off at the Airport. He also noted he spoke with SeaTac today and was assured that they do not have anything similar over there and have no requirements at all for pick up or drop off beyond the City for hire permit requirements. He stated as far as he knows there are no major airports anywhere in the country that require drivers to complete this sort of background check to pick up or drop off.

Julie Diltz, with Orange Cab and United Cab, stated she along with the majority of taxi drivers she has spoken with in Spokane are very frustrated with the lack of regulation regarding Uber and Lyft. She stated Uber and Lyft both perform services as for-hire as defined by RCW 46.72.010.

Bill Boomer noted he is with the taxi industry and brought to attention what happened this weekend with Uber and Lyft drivers downtown. He stated they were parked on both sides of the street on Division which is a highway and they had their emergency flashers on and had it down to one lane for traffic to go on. He stated the Police Department would tell them to move on and they would go around the block and they did it all night long. He also remarked on surge pricing by Uber and Lyft.

Gabriel Elliot stated he is an altruist priest craft and he mentioned Mr. Ralph Nader and his long proposed efforts for a department of peace in the United States government. He invited citizens to think of attending a meditation class on Sundays at Unity on 29th in Spokane.

Michael Lawless noted he drives for Orange and United Cab and stated he does not understand how they (Uber and Lyft) are being able to come in and take over. If you want taxi cabs to be obsolete in this town, you'll just keep continuing to do what you're doing because they are taking over.

Council President Pro Tem Waldref noted that City Council is in the middle of looking at the new contract, if the Council decides to move in that direction, with Uber, and noted there is actually state legislation that is going on around statewide oversight of these vehicles.

Ladd Smith stated he is one of the four commissioners on the OPOC. He noted Council Member Beggs has been working on the OPO ordinance revision. He stated the OPOC passed a resolution on November 4, 2016, to have a more open and transparent process with all community stakeholders and this has not happened. He stated the resolution that was passed by the OPOC was not honored in his opinion. He also remarked on discussion of confidential case matters and noted there is no ability for the OPOC and the OPO to discuss cases, and revisions to the ordinance give the OPOC more power and responsibilities but noted the inability to discuss cases will hinder the ability to empower the ombudsman. He also expressed other concerns pertaining to the OPOC and OPOC.

Bob Horrocks referenced an article in the paper last week. He stated a lot has been said about the amount of money being made from the school zone speed cameras and one of them is on Nevada Street which runs alongside Longfellow Elementary. He noted a lot of children are walking to school alongside a heavily used arterial and that camera makes sense. The camera on Northwest Boulevard is another matter and he stated Finch Elementary is not alongside that street but five blocks from there. He questioned why the camera was not put on Driscoll Boulevard which runs next to the school and where the majority of children would walk and stated the answer is making money and not protecting the children. He also provided further remarks regarding the cameras.

George McGrath commented on the better weather and stated we're not getting as much attention on pot holes that we've been getting all winter long. He further commented on the use of money to make Division an entry way into the City, and he believes that money could fix some potholes instead of making Spokane a welcoming city. He also remarked on the street bond issue to fix the streets and provided further remarks regarding potholes.

Council President Pro Tem Waldref reminded citizens to call 3-1-1 if they notice a pothole. She noted the asphalt plant opened up so the City now has actual hot asphalt to put in those holes and works better. Council Member Kinnear remarked the Mayor has said the City has well over 1,300 potholes that have been fixed already. She stated she wanted to test how quickly that happened so she went down to 3-1-1 on the first floor and reported a pothole and went by that location and it was filled the next day.

Jonathan Mallahan, Neighborhood Services Division Director, provided an overview of Special Budget Ordinance C35483 and responded to Council inquiries. Subsequent to public testimony and Council commentary, the following action was taken:

Upon 5-1 Roll Call Vote (Council Member Fagan voting "no" and Council President Stuckart absent), the City Council **passed Special Budget Ordinance C35483** amending Ordinance No. C35457 passed by the City Council November 28, 2016, and entitled, "An Ordinance adopting the Annual Budget of the City of Spokane for 2017, making appropriations to the various funds, departments and programs of the City of Spokane government for the fiscal year ending December 31, 2017, and providing it shall take effect immediately upon passage, and declaring an emergency and appropriating funds in:

Rental Rehabilitation Fund

FROM: Unappropriated Reserves, \$950,000;

TO: Contractual Services, \$950,000.

(This action is necessary to accommodate an anticipated \$1.75 million loan for the rehabilitation of the Ridpath, as funds were not included in the budgeted expenditures for 2017.)

Special Budget Ordinance C35484

Subsequent to commentary by Council President Pro Tem Waldref and the opportunity for public testimony, with no individuals requesting to speak, the following action was taken:

Upon Unanimous Roll Call Vote (Council President Stuckart absent), the City Council **passed Special Budget Ordinance C35484** amending Ordinance No. C35457 passed by the City Council November 28, 2016, and entitled, "An Ordinance adopting the Annual Budget of the City of Spokane for 2017, making appropriations to the various funds, departments and programs of the City of Spokane government for the fiscal year ending December 31, 2017, and providing it shall take effect immediately upon passage, and declaring an emergency and appropriating funds in:

Accounting Services Fund

FROM: Interfund Finance, \$67,900;

TO: Various Accounts, same amount.

[This action creates an additional Accounting Clerk position (from 13 to 14) to support Fire Department operations.]

There were no **Emergency Ordinances**.

RESOLUTIONS

Resolution 2017-0018

Council President Pro Tem Waldref provided an overview of Resolution 2017-0018 and public testimony was taken. Council President Pro Tem Waldref then reviewed a few changes to the ordinance and requested a motion to accept the new version of the resolution. Subsequently, the following action was taken:

Motion by Council Member Mumm, seconded by Council Member Stratton, **to accept** the new version (of Resolution 2017-0018); **carried unanimously (Council President Stuckart absent).**

Upon Unanimous Roll Call Vote (Council President Stuckart absent), the City Council **adopted Resolution 2017-0018, as revised,** establishing a joint partnership for identifying resources and utilizing best practices to remove snow and ensure mobility during winter weather events.

Subsequent to an overview of Final Reading Ordinance C35481 by Council Member Kinnear, public testimony, and Council commentary, the following action was taken:

Upon Unanimous Roll Call Vote (Council President Stuckart absent), the City Council **passed Final Reading Ordinance C35481** relating to the crime of vehicle trespass; enacting a new section 10.12.065 of the Spokane Municipal Code.

Final Reading Ordinance C35482

Subsequent to an overview of Final Reading Ordinance C35482 by Council Member Kinnear and Policy Advisor Brian McClatchey, public testimony, and Council commentary, the following action was taken:

Upon Unanimous Roll Call Vote (Council President Stuckart absent), the City Council **passed Final Reading Ordinance C35482** relating to the enforcement of extreme risk protection orders; amending section 10.07.020 of the Spokane Municipal Code; enacting new sections 10.07.022 and 10.07.024 of the Spokane Municipal Code; and re-numbering section 10.07.021 of the Spokane Municipal Code.

There were no **First Reading Ordinances**.

There were no **Special Considerations**.

There were no **Hearings**.

SECOND OPEN FORUM

Alexandra Stoddard spoke regarding capital fund fees that citizens pay on their City utility bill. She stated that she is on a limited fixed income and that is dental insurance for her and there are others living in Spokane who are in the exact same economic place that she is. She inquired if the City Council could do another financial analysis and look and see if that number could be reduced to reduce the burden on the citizens of Spokane. She also remarked the favorite place she ever lived was a studio apartment when she very first left home and it was affordable, and she stated we need more of them in Spokane.

Council President Pro Tem Waldref stated that over the next three to four months the Public Works Committee will start its utility rate conversation and we're hitting our three-year utility rate decision. She noted we are catching up our capital needs, but the Committee will look at the capital costs, the operational costs, and whether we do a one-year or a three-year set of rates.

There being no further business to come before the City Council, the Regular Legislative Session of the Spokane City Council adjourned at 7:43 p.m.

ORDINANCE NO. C35480

An ordinance relating to commercial vehicles; adopting a new section 16A.44.100 of the Spokane Municipal Code; and renaming chapter 16A.44 of the Spokane Municipal Code.

NOW, THEREFORE, The City of Spokane does ordain:

Section 1. That there is adopted a new section 16A.44.100 of the Spokane Municipal Code to read as follows:

Section 16A.44.100 Regulations on Motor Carriers Used in Intrastate or Interstate Commerce

- A. Concerning motor carriers used in intrastate or interstate commerce and operating within the City of Spokane, the following are adopted by reference as if fully set forth herein:
 - 1. RCW 46.16a.455, "Trucks, buses, and for hire vehicles based on gross weight"; and
 - 2. WAC 446-65-010(u), "Transportation Requirements".
- B. Violation of this section is a class 2 civil infraction.

Section 2. That chapter 16A.44 of the Spokane Municipal Code is renamed as follows:

Chapter 16A.44 ((Special Permits for Oversize or Overweight Movements)) Commercial Vehicles

Passed by City Council March 13, 2017 Delivered to Mayor March 20, 2017

ORDINANCE NO. C35481

An ordinance relating to the crime of vehicle trespass; enacting a new section 10.12.065 of the Spokane Municipal Code.

NOW THEREFORE, the City of Spokane does ordain:

Section 1. That there is enacted a new section 10.12.065 of the Spokane Municipal Code to read as follows:

Section 10.12.065 Vehicle Trespass Prohibited; Penalty

C. Vehicle trespass is a misdemeanor.

An ordinance relating to the enforcement of extreme risk protection orders; amending section 10.07.020 of the Spokane Municipal Code; enacting new sections 10.07.022 and 10.07.024 of the Spokane Municipal Code; and re-numbering section 10.07.021 of the Spokane Municipal Code.

NOW, **THEREFORE**, the City of Spokane does ordain:

Section 1. That section 10.07.020 of the Spokane Municipal Code is amended to read as follows:

Section 10.07.020 Making a False or Misleading Statement to a Public Servant

- A. A person who knowingly makes a false or misleading material statement to a public servant is guilty of a gross misdemeanor. "Material statement" means a written or oral statement reasonably likely to be relied upon by a public servant in the discharge of his official powers or duties. (RCW 9A.76.175)
 - ((1. A person is guilty of false reporting if, with knowledge that the information reported, conveyed or circulated is false, he initiates or circulates a false report or warning of an alleged occurrence or impending occurrence of a fire, explosion, crime, catastrophe or emergency knowing that such false report is likely to cause evacuation of a building, place of assembly or transportation facility, or to cause public inconvenience or alarm.
 - 2. False reporting is a gross misdemeanor. (RCW 9A.84.040)))

Section 2. That there is adopted a new section 10.07.022 of the Spokane Municipal Code to read as follows:

Section 10.07.022 False Reporting

A person is guilty of false reporting if, with knowledge that the information reported, conveyed or circulated is false, he initiates or circulates a false report or warning of an alleged occurrence or impending occurrence of a fire, explosion, crime, catastrophe or emergency knowing that such false report is likely to cause evacuation of a building, place of assembly or transportation facility, or to cause public inconvenience or alarm.

False reporting is a gross misdemeanor. (RCW 9A.84.040)

Section 3. That there is adopted a new section 10.07.024 of the Spokane Municipal Code to read as follows:

Section 10.07.024 Violations Related to Extreme Risk Protection Orders

A. False Filing of Extreme Risk Protection Order

Any person who files a petition for an Extreme Risk Protection Order pursuant to Chapter 7.94 RCW knowing the information in such petition to be materially false, or with intent to harass the respondent, is guilty of a gross misdemeanor.

B. Unlawful Possession of Firearm After Issuance of Extreme Risk Protection Order

Any person who has in his or her custody or control, purchases, possesses, or receives a firearm with knowledge that he or she is prohibited from doing so by an order issued pursuant to Chapter 7.94 RCW is guilty of a gross misdemeanor, and further is prohibited from having in his or her custody or control, purchasing, possessing, or receiving, or attempting to purchase or receive, a firearm for a period of five years from the date the existing order expires. However, such person is guilty of a class C felony if the person has two or more previous convictions for violating an order issued pursuant to Chapter 7.94 RCW.

Section 4. That section 10.07.021 of the Spokane Municipal Code is renumbered as follows:

Section ((10.07.021)) 10.07.026 Criminal Impersonation

- A. No person may with intent to defraud another or for any other unlawful purpose:
 - 1. assume a false identity and do an act in his assumed character, or
 - pretend to be a representative of some person or organization or public servant and do an act in his pretended capacity.
- B. The penalty for violation of this section is a fine not to exceed five thousand dollars, or imprisonment for not more than three hundred sixty-four days, or both such fine and imprisonment.
