MINUTES OF SPOKANE CITY COUNCIL

Monday, July 17, 2017

BRIEFING SESSION

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Briefing Center in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

Roll Call

On roll call, Council President Stuckart and Council Members Beggs, Fagan, Kinnear, and Stratton were present. Council Members Mumm and Waldref entered the meeting at 3:31 p.m.

Finance and Administration Division Director Tim Dunivant, City Council's Policy Advisor Brian McClatchey, and City Clerk Terri Pfister were also present on the dais.

Advance Agenda Review

The City Council received an overview from staff on the July 24, 2017, Advance Agenda items.

Action to Approve July 24, 2017, Advance Agenda

Following staff reports and Council inquiry and discussion regarding the July 24, 2017, Advance Agenda items, the City Council took the following action (pursuant to Council Rule 2.1.2):

Motion by Council Member Fagan, seconded by Council Member Mumm, **to approve** the Advance Agenda for Monday, July 24, 2017; **carried unanimously.**

ADMINISTRATIVE SESSION

Current Agenda Review

The City Council reviewed the July 17, 2017, Current Agenda for any changes.

Memorandums of Understanding for the Operation of Transportation Network Company Services in the City of Spokane (OPR 2017-0461 / OPR 2017-0462)

Motion by Council Member Fagan, seconded by Council Member Kinnear, **to move (and thereby defer)** to the July 24, 2017, Legislative Session the Memorandums of Understanding for the operation of transportation network company services in the City of Spokane with (a) Lyft (OPR 2017-0461) and (b) Raiser (OPR 2017-0462); **carried unanimously.**

Ordinance C35519 Relating to Climate Change, Global Warming, and the City of Spokane's Sustainability Action Plan

Council President Stuckart advised there are two changes to Ordinance C35519. He noted last week he sent to City Council a summary of what his changes were. He further noted a second set of updated changes was sent out by Council Member Beggs. He requested a motion to accept Council Member Beggs' suggested changes which would be to change "protection" to "stewardship" and under Section 15.05.020(C) to add "within the boundaries of the City of Spokane." Further, for Item C, Council President suggested making all the suggested changes but cancel out "on an annual" basis because the above-referenced greenhouse gas inventory [under Section 15.05.020(A)] already sets the timeline. Council President Stuckart called for a motion to accept Council Member Beggs' changes that he just summarized. The following action was taken:

Motion by Council Member Kinnear, seconded by Council Member Waldref, to so move (to accept Council Member Beggs' changes as summarized above by Council President Stuckart); carried 6-1 (Council Member Fagan voting "no").

Council President Stuckart indicated the second set of changes were labeled "Avista changes" and they were changes in the "Whereas" (clauses) so that it doesn't trap the City into some legal court case (Foster case) on the other side of the state and changing one word to "goal." He requested a motion to accept the changes that were emailed out last week (as just described). The following action was taken:

Motion by Council Member Kinnear, seconded by Council Member Stratton, to so move (to accept the changes that were emailed out last week as described by Council President Stuckart); carried 6-1 (Council Member Fagan voting "no").

<u>Final Reading Ordinance C35506 Relating to the Impoundment of Abandoned or Unauthorized Vehicles</u> Council Member Waldref advised that City Council was asked by staff to remove Final Reading Ordinance C35506, and Council President Stuckart requested a motion to table the ordinance indefinitely. The following action was taken:

Motion by Council Member Waldref, seconded by Council Member Mumm, **to defer indefinitely** Ordinance C35506; **carried unanimously**.

CONSENT AGENDA

Upon motion by Council Member Fagan, seconded by Council Member Waldref, the City Council approved Staff Recommendations for the following:

Multiple Family Housing Property Tax Exemption Agreement with Caroline Yu for one multi-family building with 27 units located at 1310 West College Avenue. (OPR 2017-0480)

Interlocal Agreement with Spokane County supporting prosecution and the public defense of defendants accepted into the joint City/County Mental Health Court for 2017—\$261,750 Revenue. An important outcome resulting from this Court is improved public safety. (OPR 2017-0481)

Report of the Mayor of pending claims and payments of previously approved obligations, including those of Parks and Library, through July 7, 2017, total \$6,489,278.11 (Check Nos. 538880-538976; ACH Payment Nos. 39468-39644), with Parks and Library claims approved by their respective boards. Warrants excluding Parks and Library total \$6,468,467.28. (CPR 2017-0002)

City Council Meeting Minutes: June 29, 2017. (CPR 2017-0013)

Setting Hearing before City Council on Validated Initiative No. 2016-6 petitions regarding prohibition of oil and coal shipment by rail, filed by Todd Eklof, sponsor, for July 24, 2017. (LGL 2016-0036) (<u>Clerical Note</u>: Included in the City Council's Agenda packet was an Agenda Submission Sheet from the City Clerk with the following information: In order to be placed on the November 7, 2017, ballot 2,586 validated signatures are required. The validation breakdown reflects that the Spokane County Elections Office examined 5,057 signatures, of which 3,296 were approved. This constitutes 6.374 percent of the votes cast at the last general municipal election held November 3, 2015.)

PROCLAMATION

July 17-21, 2017 Disability Voter Registration Week

Council Member Mumm read the proclamation. Rae Lynn Barden, Administrative Services Coordinator for the Spokane Library, who was accompanied by Bev Austin with the League of Women Voters, and John Lemus, Human Rights Commission Chair, accepted the proclamation and provided remarks on *Disability Voter Registration Week* events.

CITY ADMINISTRATION REPORT

Civil Service Annual Report for 2016

Chief Examiner Gita George-Hatcher displayed for the City Council and the audience the City's recruitment video. She then provided an overview of the Civil Service Annual Report for 2016 and reviewed goals for 2017.

Growing Neighbors

John Edmundson presented an overview of a new initiative called "Growing Neighbors." Growing Neighbors grows healthy neighborhoods primarily through urban farming and community development. The main goal is not to get everyone to do what we're doing, but really to help neighbors connect with each other. In many cases, neighbors don't really know each other and you don't see a lot of interaction. Growing Neighbors creates some opportunities for interaction to take place. "Neighborhood families" is the end goal of Growing Neighbors. We want neighbors to start functioning more like extended family and less like strangers competing for scarce resources; to see each other as being on the same team. BOARDS AND COMMISSIONS APPOINTMENTS

Plan Commission (CPR 1981-0295)

Upon Unanimous Voice Vote (in the affirmative), the City Council **approved** (and thereby confirmed) the appointment of Carole Shook to fill a vacated term, with term expiring December 31, 2018, and appointment of Sylvia St. Clair to fill a vacated term, with term expiring December 31, 2017.

There were no Council Committee Reports.

OPEN FORUM

Nicole Bishop stated she is the Public Relations Director for the Fulcrum Dispute Resolution Clinic, and she noted there is an event coming up this Thursday, July 20, at 7 p.m. at the Garland Theater. The program started approximately 20 years ago as a mediation firm working to provide mediation services for low income families. Since then, the program has expanded to include basic food, employment, and training which provides an opportunity for a lot of people.

Donna Lands expressed concerns regarding Riverfront Park. She stated Spokane doesn't have a theme, and it would be nice to make Riverfront Park the central theme of earning income all year-round and be a place of entertainment.

Michael Poolin stated the largest source of toxic pollution in the County and quite probably the State is the superfund site known as Fairchild Air Force Base, which he stated has polluted the environment for 75 years, and remarked that what it has done to Airway Heights' water is the tip of the iceberg. He further stated Veterans for Peace is calling for a demonstration on Saturday, July 29, at 10 a.m., at the gates of Fairchild to expose and protest all of this.

Gabriel Elliot remarked on establishment of order in our community and provided other remarks.

Subsequent to the opportunity for public testimony, with no individuals requesting to speak, and Council commentary, the following action was taken:

Upon Unanimous Voice Vote in the affirmative, the City Council **passed Ordinance C35517** amending Ordinance No. C35457 passed by the City Council November 28, 2016, and entitled, "An Ordinance adopting the Annual Budget of the City of Spokane for 2017, making appropriations to the various funds, departments and programs of the City of Spokane government for the fiscal year ending December 31, 2017, and providing it shall take effect immediately upon passage," and declaring an emergency and appropriating funds in:

Library Fund FROM: Unappropriated Reserves, \$169,600; TO: Various Accounts, same amount.

(This action appropriates additional funding for various ongoing Library needs.)

Upon 6-1 Voice Vote (with Council Member Fagan voting "no"), the City Council **passed Final Reading Ordinance C35519, as amended,** relating to climate change, global warming, and the City of Spokane's Sustainability Action Plan; re-naming Title 15; and enacting a new chapter 15.05 to the Spokane Municipal Code.

Final Reading Ordinance C35520

Subsequent to an opportunity for public testimony, with no individuals requesting to speak, the following action was taken:

Upon Unanimous Voice Vote in the affirmative, the City Council **passed Final Reading Ordinance C35520** relating to the building code; amending SMC sections 17F.050.010, 17F.050.090 and 17F.050.200.

Final Reading Ordinance C35522

Subsequent to an opportunity for public testimony, with no individuals requesting to speak, and Council commentary, the following action was taken:

Upon Unanimous Voice Vote in the affirmative, the City Council **passed Final Reading Ordinance C35522** creating the West Plains/Airport Area Public Development Authority and approving its charter and bylaws.

ORDINANCE NO C35517

An ordinance amending Ordinance No. C-35457, passed the City Council November 28, 2016, and entitled, "An ordinance adopting the Annual Budget of the City of Spokane for 2017, making appropriations to the various funds, departments, and programs of the City of Spokane government for the fiscal year ending December 31, 2017, and providing it shall take effect immediately upon passage", and declaring an emergency.

WHEREAS, subsequent to the adoption of the 2017 budget Ordinance No. C-35457, as above entitled, and which passed the City Council November 28, 2016, it is necessary to make changes in the appropriations of the Library Fund, which changes could not have been anticipated or known at the time of making such budget ordinance; and

WHEREAS, this ordinance has been on file in the City Clerk's Office for five days; - Now, Therefore,

The City of Spokane does ordain:

Section 1. That in the budget of the Library Fund, and the budget annexed thereto with reference to the Library Fund, the following changes be made:

Section 2. It is, therefore, by the City Council declared that an urgency and emergency exists for making the changes set forth herein, such urgency and emergency arising from the need to appropriate additional funding for ongoing Library needs, and because of such need, an urgency and emergency exists for the passage of this ordinance, and also, because the same makes an appropriation, it shall take effect and be in force immediately upon its passage.

ORDINANCE NO. C35519

An ordinance relating to climate change and the City of Spokane's Sustainability Action Plan; re-naming Title 15; and enacting a new chapter 15.05 to the Spokane Municipal Code.

WHEREAS, since 2001, when the City of Spokane joined the Cities for Climate Protection Campaign, sponsored by the International Council for Local Environmental Initiatives and the U.S. Environmental Protection Administration (Resolution 2001-0038, May 7, 2011), the City has taken a leading role in recognizing the threats of climate change and setting the standard in its response efforts; and

WHEREAS, in furtherance of these objectives, the City became a signatory to the U.S. Mayors Climate Protection Agreement (signed Feb. 1, 2007), adopted City Council Resolution 2010-0038 (June 28, 2010), which set greenhouse gas ("GHG") emissions reduction goals, and became a member of the U.S. Green Building Council; and

WHEREAS, the Mayor's Task Force on Sustainability produced the City's Sustainability Action Plan in 2009, intended to implement the City's "Near-Nature Quality of Life Initiative," adopted by Council Resolution 2007-0009 (Feb. 19, 2007); and

WHEREAS, our environmental efforts have not been limited to GHG emissions as the City of Spokane issued \$200 million in "green" bonds to: fund dramatic improvements in the health of the Spokane River; protect the Spokane Valley-Rathdrum Prairie aquifer which is the sole-source aquifer for residents of this area; promote efficient energy use by updating and maintaining distribution and treatment systems; and increase resiliency in the face of climate change and the growth of our region's population; and

WHEREAS, the City of Spokane has made sustainable infrastructure a priority, and has committed to adding more renewable power generation and exploring options for additional investment in "smart" technology; and

WHEREAS, by achieving net zero energy consumption through several measures, such as: converting the City's garbage fleet from diesel to compressed natural gas; requiring new City vehicles be more fuel efficient than the vehicles they replace; building the new energy-efficient Spokane Central Service Center to replace aging and inefficient buildings at the former Normandie complex; installing software that powers down computers when they are not in use; replacing the bulbs in traffic signals citywide with LED bulbs; installing more energy-efficient motors at water pump stations; changing out lighting in City facilities with more energy-efficient bulbs; and upgrading HVAC systems, the City is realizing the economic benefits of a sustainability-driven approach to local government; and

WHEREAS, the Intergovernmental Panel on Climate Change ("IPCC") is a body jointly established in 1988 by the World Meteorological Organization ("WMO") and the United Nations Environment Programme ("UNEP"), and has produced the world's most authoritative and objective scientific and technical assessments in the field of climate change since 1990; and

WHEREAS, according to the IPCC's 2014 Climate Change Report, "human influence on the climate system is clear and growing, with impacts observed across all continents and oceans. Many of the observed changes since the 1950s are unprecedented over decades to millennia. The IPCC is now 95 percent certain that humans are the main cause of current global warming. . . . the more human activities disrupt the climate, the greater the risks of severe, pervasive and irreversible impacts for people and ecosystems, and long-lasting changes in all components of the climate system"; and

WHEREAS, the City of Spokane is committed to implementing planning and regulations to ensure the health of its residents and its environment, including reasonable efforts at the municipal level to mitigate the effects of climate change in Spokane.

NOW, THEREFORE, the City of Spokane does ordain:

Section 1. That Title 15 of the Spokane Municipal Code is renamed "Environmental Stewardship."

Section 2. That there is adopted a new chapter 15.05 of the Spokane Municipal Code to read as follows:

Chapter 15.05 Climate Change

Section 15.05.010 Acknowledgement of Climate Change

- A. It is the official policy of the City of Spokane to acknowledge and recognize the occurrence of human-caused climate change. The City also recognizes the vast scientific consensus regarding this matter, and acknowledges that the potential impacts of climate change pose a real threat to the health and well-being of Spokane's citizens.
- B. It is the goal of the City of Spokane to incorporate strategies, both with respect to the City's own actions and the actions of those within the City limits, to reduce Spokane's carbon footprint and support local, state, and national efforts to limit the release of greenhouse gases ("GHG") into the atmosphere, incentivize the growth and development of a local clean energy economy, and secure the economic benefits of becoming an environmentally-responsible, sustainable, and resilient city.

Section 15.05.020 Greenhouse Gas Emissions Reduction Goals

- A. Pursuant to the City of Spokane's 2009 Greenhouse Gas Inventory, it is the goal of the City of Spokane to reduce GHG emissions created by activities within the boundaries of the City of Spokane by at least thirty percent (30%) below the 2005 baseline level by the year 2030.
- B. It is the intent of the City Council to keep the City of Spokane's Greenhouse Gas Emissions Reduction Goals aligned with the Washington State reduction goals.
- C. The City shall calculate and publish the GHG emissions created by activities from within the City of Spokane boundaries.

Section 15.05.030 Sustainability Action Plan

- A. The City recognizes and intends that sustainability, resiliency planning, and a proactive response to the effects of climate change are essential for the ultimate success of the City's strategic planning, and that environmental considerations must always be a crucial part of our long-term planning.
- B. The City shall utilize the City of Spokane Sustainability Action Plan for the purposes of this chapter and as a framework for developing and implementing the City's efforts related to climate change mitigation and adaptation and energy security.

Passed by City Council July 17, 2017 Delivered to Mayor July 20, 2017

ORDINANCE NO. C35520

An ordinance relating to the building code; amending SMC sections 17F.050.010, 17F.050.090 and 17F.050.200

The City of Spokane does ordain:

Section 1. That section 17F.050.010 of the Spokane Municipal Code is amended to read as follows:

Section 17F.050.010 Adoption of the National Electrical Code

- A. The National Electrical Code, ((2014))2017 Edition, as published by the National Fire Protection Association, is the electrical code for the City.
- B. The rules and regulations of the State department of labor and industries, contained in chapter 296-46B WAC (except WAC 296-46B-906, WAC 296- 46B-907, WAC 296-46B-908, WAC 296-46B-((911-))909, and WAC 296-46B- 911) are adopted as amendments and interpretations of the National Electrical Code.
- C. Persons doing electrical work are also required to comply with the state electrical installations laws.
- D. The National Electrical Code is further modified by the local amendments as provided in this chapter.

Section 2. That section 17F.050.090 of the Spokane Municipal Code is amended to read as follows:

Section 17F.050.090 Installation of Residential Service Entrance

- A. The service entrance conductors for a new single-family dwelling having five hundred square feet or more of habitable space must be installed in a raceway of not less than two-inch trade size which terminates in a two-hundred amp cabinet or panel containing a two-hundred amp main breaker or set of fuses. The conductors must be approved for carrying two hundred amperes. ((Allowable ampacities of insulated conductors are as set forth in Table 310-15(b)(6) and Tables 310-16 through 310-21 of the National Electrical Code.))
- B. The service entrance cable for a new dwelling having less than five hundred square feet of habitable space or for rewiring an existing dwelling of any size may be installed either by the method provided in subsection (A) of this section or as exposed wiring on the exterior of the building, in accordance with the National Electrical Code.

Section 3. That section 17F.050.140 of the Spokane Municipal Code is amended to read as follows:

Section 17F.050.140 Unapproved Work

- A. Whenever the inspector finds materials used or work performed which does not conform to this code, the inspector rejects the work and orders the permittee, in person or by phone, and later in writing if requested, to make all corrections in materials and workmanship necessary to satisfy this code within fifteen days, or within such longer time as the inspector may grant for good cause, unless the permittee timely appeals to the hearing officer.
- B. Whenever the inspector finds any electric wiring, apparatus or fixture:
 - 1. being used or maintained in a dangerous or unsafe condition; or
 - 2. being installed, altered, or extended without a proper permit or by an unauthorized person;

the ((inspector notifies the building official. The building official)) inspector gives written notice to the owners of the premises to take corrective action in a specified time.

Section 4. That section 17F.050.190 of the Spokane Municipal Code is amended to read as follows:

Section 17F.050.190 Functions of Electrical Inspector

The electrical inspector has responsibility to:

- ((A. process applications for electrical permits;
- B. review and approve plans and diagrams;
- C.))A. conduct inspections of installation and equipment;

((D. Make and promulgate rules, regulations and interpretations of the electrical code;

E.)) B. initiate proceedings, including prosecutions, to enforce the electrical code;

((F. maintain records of permits issued and of all other administrative activities under the electrical code.))

Section 5. That section 17F.050.200 of the Spokane Municipal Code is amended to read as follows:

17F.050.200 Hearing Officer

The hearing officer has jurisdiction over appeals pertaining to the electrical code as provided in ((SMC 4.06.070)) SMC 17G.050.070.

ORDINANCE NO. C35522

AN ORDINANCE CREATING THE WEST PLAINS/AIRPORT AREA PUBLIC DEVELOPMENT AUTHORITYAND APPROVING ITS CHARTER AND BYLAWS

WHEREAS, the City of Spokane, Washington (City), is a State of Washington first class charter city organized and existing under the Constitution and laws of the State of Washington;

That the Interlocal Agreement pursuant to Chapter 39.34 RCW (Interlocal Cooperation Act) sets forth the terms and conditions between the City and the County for the operation of the West Plains/Airport Area Public Development Authority; and

That the attached Charter and Bylaws for the West Plains/Airport Area Public Development Authority are hereby approved.
