TOWN HALL FORUM

Jennifer Bates remarked on the high quantity of dead tinder dried weeds and litter along every thoroughfare, not just on City properties but in yards and parking lots of many businesses, and she expressed concerns regarding fire danger. She also commented on dead lawns in front of houses and neglected and abandoned properties that could easily go up in flames endangering those who live there and their neighbors. Pledge of Allegiance

The Pledge of Allegiance was led by Council President Stuckart.

City Council's Policy Advisor Brian McClatchey and City Clerk Terri Pfister were also present.

MOMENT OF SILENCE

Council President Stuckart noted today is September 11. He also stated there have been two massive hurricanes, and the Spokane area was pretty smoky last week. He requested a moment of silence to remember September 11 and all the victims of fires and hurricanes.

PROCLAMATIONS

Month of September 2017 Hunger Action Month

The proclamation was read by Council Member Waldref and accepted by Julie Humphries of Second Harvest Foods. Throughout the month of September the community is encouraged to take steps to solve hunger which is participating in the United Way Make a Meal for Many Day of Action on September 15 when volunteers will pack 140,000 meals for distribution to hungry people in our City and region.

September 18-24, 2017 Constitution Week

The proclamation was read by Council Member Beggs and accepted by three members of the Daughters of the American Revolution. September 17, 2017, marks the 230th anniversary of the drafting of the Constitution of the United States of America by the Constitutional Convention. The proclamation asks citizens to reaffirm the ideals of the framers of the Constitution from 1787 by vigilantly protecting the freedoms guaranteed to us through this guardian of our liberties and remembering that lost rights may never be regained.

September 15, 2017 POW MIA Recognition Day

The proclamation was read by Council Member Fagan and accepted by a member of Post 51, Veterans of Foreign Wars, on behalf of Ensign John R. Monahan. On POW MIA Recognition Day, Americans take the time to remember those who were prisoners of war and those who are missing in action as well as their families. Ensign John R. Monahan, Post 51, Veterans of Foreign Wars, has recognized that 83,000 American service personnel are still missing in action. These service men and women are assumed dead but are still unaccounted for. September 15 is the date to pause to remember the sacrifice and service of those who were prisoners of war as well as those who are missing in action.

SALUTATION

Recognition of Jeff Lew

Council Member Mumm presented the Salutation and it was accepted by Doug Wardell, Director of Nutritional Services from Spokane Public Schools. Council Member Mumm advised there is a gentleman in the State of Washington who found out that many students had lunch debt, where they would go to lunch and didn't have money; and it would accrue on their account as a debt, and he didn't think this was right. The gentleman's name is Jeff Lew. Seventy-six percent of America's school districts have children with lunch debt according to the School Nutrition Association. Spokane Public School District is recognized as the second largest district in the State of Washington and works hard to minimize lunch debt that has a current balance of \$1,667 owed by students across the City. Jeff Lew is a native of the Pacific Northwest and helped the Seattle School District wipe out its students' school lunch debt and realized the Spokane School District was the next largest school district and wanted to help. Jeff Lew loved school lunch as a kid and wishes for all children to have school lunch daily. Jeff Lew as a parent wanted to make sure that no student would feel singled out or bullied because of a meal debt and that no child would go hungry. Jeff Lew believes in equal lunches for all children and wants to eliminate the lunch shaming of school children. Jeff Lew on June 2 created a Go Fund Me account to raise money to pay for the lunch debt of the students of our City. As of August 10, he has helped to raise more than \$4,000 to make sure that Spokane school children are not held publically accountable for unpaid school lunch bills by throwing away their food, providing a less desirable alternative, or physically marking students with hand stamps if they did not have the money. A statewide event was held on August 25 to publically recognize Jeff Lew for his commitment and contributions

to helping eliminate school lunch debt across the state with a presentation of a check that went to Spokane and similar ones went to Tacoma and Seattle. The City Council salutes Jeff Lew for his love of school lunches and making sure that all children get to eat a nutritious and desirable meal each day this year at school without any shame.

RESOLUTION NO. 2017-0071

A Resolution amending the City Council rules of procedure's standing committee provisions effective October 1, 2017.

WHEREAS, the City Council's Rules of Procedure establishes standing committees, which are reconfigured from time to time; and

WHEREAS, the City Council and Administration have established a strategic plan; and

WHEREAS, the City Council desires to amend its Rules of Procedure so that the Council's standing committees' areas of focus are in alignment with the focus areas established in the strategic plan.

NOW, THEREFORE, BE IT RESOLVED that the City Council amends Rule 9 of its Rules of Procedure as follows to amend the standing committees for the conduct of efficient and effective Council business:

RULE 9 - COMMITTEES

Rule 9.1 STANDING COMMITTEES

- 9.1.1 There shall be four (4) standing committees, as follows:
 - A. Public Safety and Community Health;
 - B. Finance and Administration;
 - C. Urban Development;
 - D. Public Infrastructure, Environment and Sustainability.
- 9.1.2 Committee membership shall be comprised of a minimum of one (1) council member from each council district, and additional members as desired. Standing committees composed of more than three (3) Council members shall be noticed as meetings of the Council where no legislative action shall occur.
- 9.1.3 The Council President may chair a maximum of two (2) standing committees, as determined in his or her sole discretion. All other committees shall select by majority vote the chair and vice-chair for each committee. No council member shall chair more than two (2) standing committees at one time.
- 9.1.4 The Council shall confirm the members of standing committees at the second meeting in January of each year or as soon thereafter as possible.

Rule 9.2 AD HOC COMMITTEES

Ad hoc committees with specified functions may be established for a designated term by motion of the Council. Unless already determined by the Council, such matters as appointment process, the qualification for membership, the number of members, and time for report of a committee shall be determined by the committee.

Rule 9.3 ORIGIN AND REFERRAL

9.3.1 Each ordinance or formal resolution must be presented in the committee designated by the sponsor of the item under Rule 7.1.3 (Committee of Origin) before it may be filed for first reading.

9.3.2 By declaration of the Chair (subject to appeal) or by motion of the Council, any matter before the Council may be referred to a committee, except that no committee shall investigate the facts of, nor shall any member or members of the Council take independent action on, any pending or contemplated adjudicated matters.

Rule 9.4 REPORT

- 9.4.1 A committee shall advise the Council that it is ready to report by making such announcement at a briefing session, at which time the Council may decide on what agenda the matter shall be placed, or by filing the report with the Clerk for placement on an agenda in coordination with the Council President and Mayor as any other agenda item.
- 9.4.2 A report of a committee recommending that the Council take specific action shall be in writing and, except in emergencies, in the manner of a formal resolution. Such pre-filing may substitute for full reading. Any committee member disagreeing with any part of the committee's report shall be given the opportunity to express his or her disagreement, orally or in writing, prior to Council action on the matter. If it be moved and seconded that the minority report be adopted, that motion shall be voted on before a motion to adopt the committee report.

Rule 9.5 INTER-GOVERNMENTAL COMMITTEES AND BOARDS

Unless governed by other regulations, statutes, or ordinances, appointment of full slate of Council members to inter-governmental committees or boards shall be made by the Council President to be confirmed by a majority of the City Council. All appointments shall be made consistent with the governmental documents creating the inter-governmental committee.

Rule 9.6 STANDING COMMITTEE MEETINGS

One of the functions of standing committee meetings is to provide the city administration and city staff an opportunity to update members of the committee regarding department programs, plans, and other administrative activities and future City Council administrative and legislative agenda items. Another function of the standing committees is to dedicate time to discussing strategic initiatives with the city administration and measuring progress of these initiatives.

All standing committees shall be open to the public except when the committee adjourns into executive session. No public testimony will be taken during standing committee meetings. Participation in a standing committee meeting shall be limited to standing committee members, appropriate staff and other individuals recognized by the committee. Participation by Council Members, including deliberation and voting, shall be open to all Council members when the standing committee is meeting as a committee of the whole and as a special Council meeting. Participation by Council members in a standing committee that is not a committee of the whole shall be limited to just the appointed Council members.

Upon motion of the City Council, a standing committee meeting may be conducted as a meeting of the full City Council, in which case, a special meeting notice shall be issued and the meeting shall be conducted in a study session format.

2.0 DEPARTMENTS/DIVISIONS AFFECTED

This policy shall apply to the City Council and all City departments and divisions.

5.0 POLICY

5.1 It is the policy of the City Council to utilize standing committee meetings to facilitate Council business and to become fully informed on City administration activities and strategic initiatives of interest to the Council.

6.0 PROCEDURE

- 6.1 The City Council has established four (4) standing committees. Those committees and their meeting times and locations are as follows:
 - a. Public Safety and Community Health meets first Monday of the month at 1:15 p.m. in the City Council Briefing Center.
 - b. Urban Development meets second Monday of the month at 1:15 p.m. in the City Council Briefing Center.
 - c. Finance and Administration Committee meets third Monday of the month at 1:15pm in the City Council Briefing Center.
 - d. Public Infrastructure, Environment and Sustainability Committee meets fourth Monday of the month at 1:15 p.m. in the City Council Briefing Center.
- 6.2 If a City Council Monday legislative meeting is cancelled, standing committee meetings scheduled for that day can be rescheduled for another Monday in the same month at 10:15am.
- 6.3 Standing committee meetings are intended to provide members of the City Council and City staff an opportunity to review and discuss in detail issues or topics that are of interest to the City administration and the City Council and to facilitate the efficient conduct of Council business.
- 6.4 No public testimony will be taken during standing committee meetings. Participation in a standing committee meeting shall be limited to standing committee members, appropriate staff, and other individuals recognized by the committee.
- 6.4 Staffing.
 - 6.4.1 The Senior Executive Assistant to the City Council President will be in charge of coordination and execution of meeting notices with approval from the standing committee chairs and their staff.
 - 6.4.2 The divisions or departments routinely reporting to a respective standing committee shall provide staff to assist the chairperson of the standing committee by taking minutes and distributing material.

- 6.4.3 Agendas for standing committee meetings shall be set by the chairperson of the standing committee with input from Council staff and the appropriate department(s) or division head(s). Agendas for standing committee meetings shall be approved by the chairperson of the standing committee prior to publication or distribution.
- 6.4.4 City staff is not required to attend portions of the meeting in which they are not expected to participate.

6.5 Minutes / Briefing Papers

- 6.5.1 Minutes shall be taken using the attached template (Attachment No. 1). Original approved and signed standing committee meeting minutes shall be filed with the City Clerk's Office and online. Minutes of standing committee meetings shall be retained pursuant to the applicable retentions schedule.
- 6.5.2 Staff for the Council Member or department or division which is bringing forward the topic or item under consideration by the standing committee shall prepare a briefing paper on each topic being submitted to the standing committee, which shall be formatted using the attached template (Attachment No. 2).

7.0 RESPONSIBILITIES

The Council President, with the assistance of City administration, shall administer this policy.

Ordinances

These ordinances are published in this issue of the Official Gazette pursuant to passage by the Spokane City Council. It should be noted that these ordinances may be subject to veto by the Mayor. If an ordinance is vetoed by the Mayor, the Mayoral veto will be published in a subsequent issue of the Official Gazette.

ORDINANCE NO. C35546

An ordinance creating a utility fee credit for nonprofit providers of long-term housing for developmentally disabled persons; enacting a new chapter 13.12 of the Spokane Municipal Code; and specifying an effective date.

NOW THEREFORE, the City of Spokane does ordain:

Section 1. That there is enacted a new chapter 13.12 of the Spokane Municipal Code to read as follows:

Chapter 13.12 Credit for nonprofit housing providers for persons with developmental disabilities.

Section 13.12.010 Findings, purpose, and applicability

- A. The City of Spokane finds that it is important for the City to support independent living for persons with developmental disabilities in our community. Given the high cost of housing and the economics of providing housing for people with developmental disabilities, the City finds it is in the best interests of our community to extend a utility fee credit for providers of such housing.
- B. This chapter is intended to provide a specific utility fee credit for providers of independent living housing for developmentally disabled persons and who receive a property tax exemption under RCW 84.36.042 for such housing, and is intended to focus that credit specifically for such providers.
- C. This chapter does not apply to housing providers operating under a project rental assistance contract pursuant to which the provider receives funds from the Washington Department of Commerce through the U.S. Department of Housing and Urban Development's 811 Capital Advance Program, which is a designated funding source for the development of affordable housing units primarily for people with developmental disabilities.

Section 13.12.020 Qualifications

- A. In order to qualify for the utility fee credit established by this chapter, an applicant must qualify as a nonprofit provider of long-term housing for persons with developmental disabilities with an active property tax exemption (approved under the provisions of RCW 84.36.042) on file at the Spokane County Assessor's office for that property.
- B. Qualifying property owners may request that each qualifying property receive the credit established by this chapter by submitting a written request to the City of Spokane, using the form prescribed and supplied by the City. A property owner make this request through a duly authorized agent.
- C. If approved, the effective date for the credit shall be the month following the City's acceptance of an accurate, complete, and signed request, regardless of the date of the property having received the property tax exemption under RCW 84.36.042. Any charges, along with any associated late penalties and interest that may have accrued for the property prior to the effective date of the credit will still be due, as previously billed, and subject to collection under to this chapter.
- D. If a qualifying nonprofit becomes the owner of additional property(ies), the owner must submit a new request for a credit for each property pursuant to subsection B of this section.
- E. A qualifying nonprofit property owner must maintain an active property tax exemption on file at the Spokane County Assessor's office for each property in order to continue to qualify for the credit for each property.
- F. The property owner is responsible for reporting any change (e.g., change of ownership, change from "active" tax exemption status, dissolution of qualifying nonprofit, cessation of exemption, etc.) that may affect qualification for the credit or that may affect qualification for the underlying tax exemption as provided in RCW 84.36.042). If the property owner fails to report any such change, the City shall have the right to pursue the billing and collection of any additional fees (i.e., the credit provided, multiplied by the applicable number of months) that may be due to the City.

Section 13.12.030 Credit

- A. The credit provided by this chapter shall be ten dollars (\$10.00) per month and apportioned as follows to the account:
 - 1. One-third toward any monthly water charges,
 - 2. One-third toward any monthly wastewater charges, and
 - 3. One-third toward any monthly solid waste collection charges.
- B. An account which does not receive all three utility services shall only receive partial credit as listed in SMC 13.12.040.

Section 13.12.040 Partial service

The City provides water, wastewater, stormwater, and solid waste services to its citizens and customers. Not all utility service accounts within the City's service areas receive all services. For example, there are some accounts, which are served water only. Therefore, the application of the credit provided by this chapter is on a proportionate basis with 1/3 of the credit being applied for water services; 1/3 of the credit being applied for wastewater services and 1/3 of the credit being applied for solid waste collection services. For those accounts, which only have one service, the credit would be

1/3 of the total designated amount.

Section 13.12.050 Periodic review

The program created by this chapter shall expire on December 31, 2020. No later than June 30, 2020, administration staff shall provide a report on the program created by this chapter to the City Council and make a recommendation as to whether to extend this program beyond the expiration date provided for in this section.

Section 2. That this ordinance shall, pursuant to section 19(B) of the City Charter, be in force and effective on January 1, 2018.

Section 1. That SMC section 07.03.155 is amended to read as follows:

07.03.155 Police Department – Patrol Anti-Crime Team (PACT)

There is established in the police department a patrol anti-crime team (PACT) imprest fund in an amount not to exceed ((one thousand five hundred dollars)) ten thousand dollars.
