### MINUTES OF SPOKANE CITY COUNCIL

Monday, February 11, 2019

### **BRIEFING SESSION**

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Briefing Center in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

### Roll Call

On roll call, Council President Stuckart and Council Members Beggs, Burke, Fagan, Kinnear, Mumm, and Stratton were present.

City Attorney Mike Ormsby, City Council Policy Advisor Brian McClatchey, and City Clerk Terri Pfister were also present on the dais.

### Advance Agenda Review

There was no Advance Agenda Review as the regularly scheduled City Council meeting for Monday, February 18, 2019, has been canceled in recognition of President's Day.

### ADMINISTRATIVE SESSION

### **Current Agenda Review**

The City Council reviewed changes to the February 11, 2019, Current Agenda.

<u>Purchases of Miscellaneous Waterworks Products (from Various Companies) (OPR 2019-0077 through OPR 2019-0081)</u>
Council President Stuckart requested suspension of the Council Rules in order to add Item No. 7—Purchases of Miscellaneous Waterworks Products—to today's Current Consent Agenda. The following actions were taken:

An administrative reserve of \$244,181.41 (plus tax), which is 10% of the contract price, will be set aside.

Council President Pro Tem Beggs and Council Members Fagan, Kinnear, Mumm, and Stratton were present. Council President Stuckart and Council Member Burke were absent.

### **PROCLAMATION**

February 28, 2019 Rare Disease Day in Spokane

Council Member Stratton read the proclamation and presented it to a representative of the event. Almost 30 million Americans are affected by the nearly 7,000 diseases and conditions considered rare in the United States, including thousands of Spokane residents. Many rare diseases are serious and debilitating conditions that have a significant impact on the lives of those affected, including individuals and families whom often experience problems such as

diagnosis delay, difficulty finding medical expertise, and lack of access to treatments or ancillary services. The proclamation is in participation with the National Organization for Rare Disorders' nationwide observance.

### **ADMINISTRATION REPORT**

### State of the City Address - 2019

Mayor David Condon presented a shortened version of his 2019 State of the City address to the City Council, reviewing key components in each of the City's Strategic Plan categories: Safe and Healthy, Urban Experience, Innovative Infrastructure, and Sustainable Resources.

### **APPOINTMENTS**

Citizens Transportation Advisory Board (CTAB) (2018-0032) and Historic Landmarks Commission (CPR 1981-0122) Upon Unanimous Roll Call Vote (Council President Stuckart and Council Member Burke absent), the City Council approved (and thereby confirmed) the following appointments:

- CTAB: Appointment of Christopher Johnson for a term to expire on November 11, 2022.
- <u>Historic Landmarks Commission</u>: Appointments of Sylvia Tarman (archaeologist) and Amanda Paulson (at-large) for respective terms from January 1, 2019, to December 31, 2021.

There were no Council Committee Reports.

### **OPEN FORUM**

**Drea Rose** noted she is the cofounder of MAC Movement, an organization of music, art, and community. She thanked the Spokane community and local organizations and all the people in the community that take the time to help these organizations. She also remarked on the community putting up homeless individuals in hotels so they wouldn't be out in the cold. In addition, she put a call out for not just more people in the community to help but for the City to step in and help these organizations more and remarked on homelessness and those who may be in an abusive relationship who need warm places.

**Dave Bilsland** remarked on warming centers and all the people that are trying to help feed. He stated one of the problems is they can't feed inside; they have to feed outside.

**Bill Sexton** stated that on January 20 the Police force went out and forcibly removed the homeless from areas where they were staying and gave them about five minutes to pick up their things and leave. He thought the idea of possibly using one of the buildings at the Fairgrounds as a warming center is a good idea and provided other remarks pertaining to homelessness and warming centers in the community.

**Jon Lossing** stated he is here today to announce that he will be running for mayor in 2019. Mr. Lossing was cautioned by Council President Pro Tem Beggs that the City Council has rules about campaigning and his remarks are out of bounds.

**John Alder** reminded everybody that he has used the paramedics several times and if there is a fire we want to make sure we have firefighters there to put it out. He reminded citizens to get their ballot in and please vote yes on this (fire levy).

**Kelly Masjoan** noted she is a fire dispatcher and executive board member of IAFF Local 29. She presented concerns on fire dispatch staff shortages and stated the fire dispatchers are essentially being managed by SRECC without SRECC being live yet and presented other concerns regarding staffing and SRECC.

**Tim Usher** stated Proposition 1 seems like it wouldn't be necessary if the Council would be more careful of taxpayer money in many areas. The key term on the ballot is public safety, but this preys on the emotions of the voters as does the phrase "it's for the children" and stated neither totally reflects reality.

Stephanie Fox remarked on recovery success and the drug epidemic.

**Charlie Bowchamp** presented his recommendations for the betterment of Spokane and the surrounding communities.

Matt Deryan remarked on affordable housing.

### Resolution 2019-0006 and Resolution 2019-0007

Teri Stripes of the City's Planning Department provided a brief overview of Resolution 2019-0006 and Resolution 2019-0007. There was an opportunity for public testimony, with no individuals requesting to speak, and an opportunity for Council commentary, after which the following actions were taken:

**Upon Unanimous Roll Call Vote (Council President Stuckart and Council Member Burke absent),** the City Council **adopted Resolution 2019-0006** approving a development agreement between the City and 1<sup>st</sup> Avenue Chelan, L.L.C. relating to certain public infrastructure costs, and authorizing the Mayor to execute the development agreement on behalf of the City.

**Upon Unanimous Roll Call Vote (Council President Stuckart and Council Member Burke absent),** the City Council **adopted Resolution 2019-0007** approving a development agreement between the City and 600 Main, L.L.C. relating to certain material costs, and authorizing the Mayor to execute the development agreement on behalf of the City.

### **ORDINANCE NO. C35741**

An ordinance carrying over from the 2018 fiscal year and re-appropriating various funds for the use of certain departments and divisions of the City government and the budgeting of various outstanding grants, both revenues and expenses, of the City of Spokane, and thereby amending Ordinance No. C-35703, passed by the City Council December 10, 2018, and entitled "An ordinance adopting the Annual Budget of the City of Spokane for 2019, making appropriations to the various funds of the City of Spokane government for the fiscal year ending December 31, 2019, and providing it shall take effect immediately upon passage", and declaring an emergency.

WHEREAS, at the end of the 2018 fiscal year there were various unexpended appropriations for uncompleted programs, improvements in progress, unfilled orders for material, equipment and supplies and unfulfilled contracts for personal services, all properly budgeted and contracted for, and various outstanding grants, bond projects, and capital projects; and

WHEREAS, in order to complete such programs and pay such claims it is necessary that the various funds be re-appropriated in the 2019 budget; and

WHEREAS, this ordinance has been on file three days;
