MINUTES OF SPOKANE CITY COUNCIL

Monday, July 15, 2019

BRIEFING SESSION

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Briefing Center in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

Roll Call

On roll call, Council President Stuckart and Council Members Beggs, Burke, Fagan, Kinnear, Mumm, and Stratton were present.

City Attorney Michael Ormsby and City Council Policy Advisor Brian McClatchey, and City Clerk Terri Pfister were present on the dais.

Resolution 2019-0053

Motion by Council Member Kinnear, seconded by Council Member Mumm, **to defer** Resolution 2019-0053—seeking to reorient toward community policing in downtown Spokane—for two weeks (from July 22, 2019, Agenda to July 29, 2019 Agenda); **carried unanimously**.

Hearings before City Council for July 22, 2019, on Initiative Nos. 1 and 2 (LGL 2019-0014 and LGL 2019-0015)

City Clerk Terri Pfister reported on validated petition signatures for Initiative No. 2019-1 (regarding open government) and Initiative No. 2019-2 (prohibiting a City of Spokane income tax). For Initiative No. 2019-1, the County examined 3,105 of the 3,343 signatures submitted and 2,285 were approved. This constitutes 5.134 percent of the votes cast at the last general municipal election held November 7, 2017. For Initiative No. 2019-2, the County examined 3,112 of the 3,342 signatures submitted and 2,319 were approved. This constitutes 5.21 percent of the votes cast at the last general municipal election held November 7, 2017. For generative submitted and 2,319 were approved. This constitutes 5.21 percent of the votes cast at the last general municipal election held November 7, 2017. Five percent or 2,226 signatures were required to place the respective matters on this coming November's ballot. MAYORAL PROCLAMATION

July 15-21, 2019 *L.W. Hutton Week*

Council President Pro Tem Beggs read the proclamation and presented it to Mr. Chud Wendle. Hutton Settlement founded in 1919 by Mr. L.W. Hutton in Spokane, Washington, was established to create for children a home where they could learn to work as well as play, where they're lives could be as normal and individual as the lives of more fortunate children. L.W. Hutton, also an orphan dedicated his life and fortune to serving others in need and is recognized as one of Spokane's biggest visionaries and philanthropists. L.W. Hutton showed great foresight in his establishment of his children's home, including a sustainable funding model, a unique governance structure and a legacy of love, all allowing the organization to deliver a century of providing hope, opportunity, and life to thousands of our region's children in need of a safe home and family.

Council Member Mumm stated an analysis has been done on our boards and commissions and she noted she will be drafting a letter to the Mayor expressing the update on the status of our boards and commissions, which is showing not a great balance on gender or people of color. She stated she would like to have a further conversation with the Mayor about this.

Motion by Council Member Mumm, seconded by Council Member Burke, to table indefinitely the two appointments to the Plan Commission; carried 5-1 (Council Member Stratton "no" and Council President Stuckart absent).

OPEN FORUM

Jennifer Bates inquired if it's the intent of the City's Parks Department to have no benches at all in Riverfront Park. She spoke regarding the lack of seating in downtown Spokane and attributes it to irrational fear and loathing of the homeless by the stores and businesses downtown.

George McGrath congratulated President Trump on the courage to tell it like it is and provided other commentary. He also remarked on Lime scooters blocking sidewalks all over town.

Wayne Gazzola stated that we have treated land and community spaces as commodities until it has come to this – there is simply no place to go. He stated we take far more than we could ever give and that we owe it to others to give them their own space and to be with others in the same boat, to rest, to clean up, and to simply be during the day; not just a place to sleep at night.

He referenced where he grew up and one of his favorite places to go as a child was the Museum of Natural History. He stated there is a blue whale that hangs from the ceiling and he used to picture himself and dream about flying through the museum under that whale, over the whale, and would think about how big it was.

Council President Pro Tem Beggs announced Mr. Llamedo's three minutes were up, and he adjourned the meeting. Mr. Llamedo was allowed to complete his commentary following the adjournment of the meeting.

Hearing on Final Reading Ordinance C35795 Relating to the Adoption of the City of Spokane's Community Empowerment Zone Strategic Plan and the Community Empowerment Zone Boundary

Discussion Items

- 2. Utility Credits Ordinance

Council Member Burke discussed the proposed ordinance to provide utility charge credits for temporary shelter providers. The ordinance is included in the packet and would provide a utility credit to providers of permanent supportive housing and emergency homeless shelters. Discussion was had on the cost of the program and Council Member Burke will develop a fiscal impact statement for it.

3. Loaned Employee and Property to other Government Agencies Ordinance

Council Member Mumm discussed the proposed ordinance on loaned employee and property to other government agencies. Discussion was had on the ordinance and may be deferred for further review and recommendations.

- B. Staff Requests
 - 1. Impact Fees Discussion

Inga Note discussed with the committee the Transportation Impact Fee update process. She provided an overview and PowerPoint that included the history of the impact fees being enacted in 2011 and the projects that were partially funded with the fees collected. Inga spoke about the scope of the update that is done every two years in conjunction with the annual update of the Capital Facilities plan in the City's Comprehensive Plan. The committee has been meeting since 2017 and the next milestones will be to review with the Plan Commission and finally council adoption the last quarter of 2019.

2. Public Works Apprentice Program

Jason Sandobal gave an update on the apprentice program for January through May 2019. Currently there is 19% participation. The summary reports are filed with the clerk's office and are publicly searchable. Jason spoke about the apprentice incentive grant to assist minorities, women, and residents of Community Empowerment Zones (CEZ's). The applications are due in August and is supported by penalties collected form the ordinance with over \$10,000 collected to date.

3. WheelShare Program – Status Update

Brandon Blankenagel introduced Colin Quinn-Hurst, Bicycle and Pedestrian Planner. Colin reviewed the WheelShare program with a PowerPoint. The scooter speed has been discussed and will be limiting speeds within downtown and within Riverfront Park. When riders rent the scooters, they are reminded of behavior and to not ride on sidewalks. The First Ride Academy and Lime Patrol is in operation, a first in the United States for Lime. The academy focuses on safety, education, and Lime Patrol for enforcement. Discussion was had on the contract with Lime and the budget for 2019, which includes advertising, sidewalk signage, and parking infrastructure for the anticipated \$59,000 revenue. The next quarterly report will be in August focusing on any operational adjustments, programming and infrastructure investments. Signage and representatives will be attending Hoopfest to remind riders that the scooters and bicycles will not be allowed at the event but there will be parking stations for pick up and drop off for people who are using them when they park further away from the event.

Strategic Plan Session

A. Priority Strategy 1. Rapidly Accelerating Street Pavement Maintenance Projects

Construction Highlights Kyle Twohig gave an update on the construction projects so far this year. He highlighted the progress for the CSO 24 plaza at 1st and Adams had the art installed, Riverside – Martin Luther King Jr. Way Phase 2B, Sunset Blvd. bike lane markings, Sprague Avenue grind and overlay as well as next will be Maple/Ash.

- B. <u>Priority Strategy 2. Repurposing Public Property to Stimulate Private Investment</u>
 - Update on Wastewater Maintenance Property 909 East Sprague Scott Simmons introduced Charlie Wolff. Charlie gave an update on the next steps to purchase the property that BNSF owns that the Wastewater Maintenance building is located. The purchase and sale agreement will be submitted to Council agenda and the next steps will be to perform an Environmental Phase II as a part of the due diligence. Scott Simmons spoke about the University District development and the trail connection off of Sprague Avenue.

C. Priority Strategy 3. Sustainable City

 Smart Use of Water Resources for Economic Growth: Develop Comprehensive Water Conservation Plan -Define and identify Park/Water Conservation Projects

Dan Kegley introduced Doug Greenlund, Environmental Programs and Nick Hamad, Parks Department. Doug and Nick gave an overview of the projects identified to collaborate for identifying water conservation and education efforts. The projects include irrigation and Indian Canyon Golf Course, Manito Park Landscape alterations and irrigation upgrades of the lower meadow and Grand Boulevard, Manito Japanese Garden Pond modifications for drip irrigation and water reuse in the pond. In addition, Franklin Park and Friendship Park splash pad sensor upgrades and TJ Meenach SpokaneScape planting. Doug discussed the standard irrigation details and specifications project.

 Putting our Renewable Energy Resources to Work in the Community Scott Simmons gave a brief update that the project employee, energy advisor is on board and one of the first tasks will be to strategize the power purchase agreement that expires the end of this year for Upriver Dam. The contract currently is about \$2.9 million in revenue. He will also assist with the Waste to Energy contract that will expire in 2022 and biofuel exploration.

A RESOLUTION EXPRESSING THE INTENTION OF THE CITY COUNCIL TO DESIGNATE A RESIDENTIAL TARGETED AREA, AMEND SMC 8.15.030 AND TO SET A PUBLIC HEARING

WHEREAS, Chapter 84.14 RCW authorizes cities to enact multifamily housing property tax incentive programs by designating residential targeted areas within urban centers;

WHEREAS, the City of Spokane exercised its authority under Chapter 84.14 RCW by enacting Ordinance No. C32575, codified as Chapter 8.15 SMC, which provides a property tax incentive for multifamily housing in urban centers by establishing a methodology for granting such incentives and designating the urban centers and residential targeted areas;

WHEREAS, the City Council has subsequently revised the designated residential targeted areas; and

WHEREAS, the City Council, along with the City Administration has performed a review of the designation of the residential targeted areas; and

WHEREAS, the City Council desires to modify the boundary of the existing designated residential targeted areas and to revise the name of the residential targeted areas listed in SMC 8.15.030 as set forth in Ordinance No. C35797 amending SMC 8.15.030; and

WHEREAS, RCW 84.14.040 requires public notice and a hearing before the City designates residential targeted areas.

NOW, THEREFORE, it is resolved by the City Council that it is the intent of the City of Spokane to designate a revised residential targeted area as set forth in Ordinance No. C35797 and as generally identified in Attachment A to the ordinance.

IT IS FURTHER RESOLVED that the City of Spokane shall conduct a public hearing on August 12, 2019 beginning at 6:00 pm at the City Council Chambers at City Hall, West 808 Spokane Falls Blvd., Spokane, Washington, to take public testimony and consider the designation of the targeted area as set forth above.

IT IS FURTHER RESOLVED that the City Council shall also consider adoption of Ordinance No C35797 to amend SMC 8.15.030 to designate the revised residential targeted area as set forth in *Attachment A subsequent to the hearing called for in this resolution.

Ordinance No. C35785

CHARTER AMENDMENT REGARDING OPEN GOVERNMENT AND TRANSPARENCY IN CITY GOVERNMENT

WHEREAS, democracy demands transparency; and

WHEREAS, a transparent government is a top priority for the citizens of the City of Spokane; and

WHEREAS, the Open Public Meetings Act was passed by citizen initiative in the State of Washington in 1972, and

WHEREAS, the legislative declaration of the Open Public Meetings Act (RCW 42.30.010) states in part: The people of this state do not yield their sovereignty to the agencies which serve them. The people, in delegating authority, do not give their public servants the right to decide what is good for the people to know and what is not good for them to know. The people insist on remaining informed so that they may retain control over the instruments they have created.; and WHEREAS, the people of Washington State declared at the ballot box through Initiative 276 (chapter 42.17 Revised Code of Washington) that, "the people have the right to expect from their elected representatives at all levels of government the utmost of integrity, honesty, and fairness in their dealings," and that our form of government "is founded on a belief that those entrusted with the offices of government have nothing to fear from full public disclosure;" and

WHEREAS, Substitute House Bill 1268, the Personnel System Reform Act approved by the Legislature in 2002, ended the longstanding precedent of publicly negotiated collective bargaining agreements; and

WHEREAS, collective bargaining agreements are among the City of Spokane's largest expenditures; and

WHEREAS, both taxpayers and employees deserve the right to know how they are being represented during collective bargaining negotiations; and

WHEREAS, collective bargaining units and their agents have contributed hundreds of thousands of dollars to the election of local officials through direct and indirect campaign contributions, creating an impression of secret deal-making, which will be eliminated by making collective bargaining negotiations open to the public; and

WHEREAS, public observance of collective bargaining contract negotiations will not preclude bargaining representatives of both sides from meeting separately and privately to discuss negotiating tactics, goals, and methods; and

WHEREAS, opening collective bargaining negotiations to the public does not mean that the public will participate in the negotiations; and

WHEREAS, collective bargaining is defined in statute (RCW 41.56.030); and

WHEREAS, making collective bargaining contract negotiations transparent does not conflict with and is not preempted by state law; and

WHEREAS, the Open Public Meetings Act (RCW 42.30.140) permits collective bargaining contract negotiations to be exempted from the open public meetings *requirements*, but this exemption does not compel such negotiations to be secret; and

WHEREAS, the Open Public Meetings Act (RCW 42.30.140) does not prohibit governments from making these negotiations open to the public.

NOW, THEREFORE, THE PEOPLE OF THE CITY OF SPOKANE HEREBY ORDAIN:

Section 1. Article IV of the City Charter of the City of Spokane shall be amended by adding a new section to read as follows:

Section 40. Open Collective Bargaining Negotiations

- A. As of December 1, 2019, the City of Spokane will conduct all collective bargaining contract negotiations in a manner that is transparent and open to public observation both in person and through video streaming or playback. This section does not require the city to permit public comment opportunities during negotiations.
- B. The City of Spokane shall provide public notice of all collective bargaining negotiations in accordance with the Open Public Meetings Act (RCW 42.30.060-42.30.080.)
- C. The City of Spokane shall publish and maintain all notes, documentation, and collective bargaining proposals on the city's official website within two business days of their transmission between the negotiating parties.
- D. The City of Spokane shall publish all final collective bargaining agreements on the city's official website for the life of the agreement.
- E. Any elected official or an elected official's agent who is determined by the City Ethics Commission to have participated in any collective bargaining negotiation in violation of this charter amendment shall be referred to the City or County Prosecutors office for appropriate action.
- F. Open to public observation does not include meetings related to any activity conducted pursuant to the enforcement of a collective bargaining agreement (CBA) after the CBA is negotiated and executed, including but not limited to grievance proceedings.

Section 2. <u>Severability</u>. If any provision of this charter amendment or its application to any person or circumstance is held invalid, the remainder of the amendment or the application of the provision to other persons or circumstances is not affected.

Section 3. <u>Submission to Voters</u>. This City Charter amendment shall be submitted to the voters of the City of Spokane for their approval or rejection at the next applicable election under Section 82 of the Spokane City Charter.

Section 4. <u>Effective Date</u>. This Charter amendment, if approved by the voters, shall take effect and be in full force upon the issuance of the certificate of election by the Spokane County Auditor's Office.

Further action deferred to voters at the next General Municipal Election to be held November 5, 2019.

Ordinance No. C35786

CHARTER AMENDMENT PROHIBITING A CITY OF SPOKANE INCOME TAX

WHEREAS, the citizens of the City of Spokane recognize the need for a strong, competitive economy with reliable revenues for vital city government services; and

WHEREAS, cities across the state of Washington, including Seattle and Olympia, have attempted to adopt a cityimposed income tax; and

WHEREAS, in court proceedings, municipal attorneys have argued that cities in Washington state have the authority to implement a city income tax; and

WHEREAS, city councilors who serve on the Association of Washington Cities have argued that every city in the state has the authority to adopt a city income tax; and

WHEREAS, the state of Washington prohibits cities, counties, and city-counties from adopting a tax on net-income (RCW 36.65.030); and

WHEREAS, Washington state voters have rejected the opportunity to adopt an income tax 10 times; and

WHEREAS, voters in the City of Spokane rejected the opportunity to impose a state income tax in 2010; and

WHEREAS, credit agencies consider income taxes unwise and volatile.

NOW, THEREFORE, THE PEOPLE OF THE CITY OF SPOKANE HEREBY ORDAIN:

Section 1. That Article III of the City Charter of the City of Spokane shall be amended by adding a new section to read as follows:

Section 21.6 Prohibition of City Income Tax

The City of Spokane may not impose an income tax on wages, salaries, investments, the sale of goods or services, or any other source of income.

Section 2. <u>Severability</u>. If any provision of this charter amendment or its application to any person or circumstance is held invalid, the remainder of the amendment or the application of the provision to other persons or circumstances is not affected.

Section 3. <u>Submission to the Voters</u>. This City Charter amendment shall be submitted to the voters of the City of Spokane for their approval or rejection at the next applicable election under Section 82 of the Spokane City Charter.

Section 4. <u>Effective Date</u>. This Charter amendment, if approved by the voters, shall take effect and be in full force upon the issuance of the certificate of election by the Spokane County Auditor's Office.

Further action deferred to voters at the next General Municipal Election to be held November 5, 2019.

ORDINANCE NO. C35795

An ordinance relating to the adoption of the City of Spokane's Community Empowerment Zone Strategic Plan and the Community Empowerment Zone Boundary and the appointment of the Community Empowerment Zone Manager; adopting a new chapter 8.20 to title 8 of the Spokane Municipal Code.

WHEREAS, Chapter 43.31C RCW authorizes cities to designate geographic areas within communities that are characterized by 1) a lack of employment opportunities, 2) an average income level that is below the median income level for the surrounding community, 3) a lack of affordable housing, 4) deteriorating infrastructure, and a lack of facilities for community services, job training, and education; and

WHEREAS, the City of Spokane exercised its authority under Chapter 43.31C RCW by amending a 2001 Community Empowerment Zone (CEZ) and Plan to reflect current needs for reinvestment in these areas by establishing an amended plan and boundary for granting such State incentives in designated boundary; and

WHEREAS, the City will subsequently revise the designated CEZ boundary area once the Plan and Boundary are approved by the State agencies; and

WHEREAS, the City Council, along with the City Administration, has performed a review of the amended Plan and Boundary; and

WHEREAS, the City Council desires to modify the boundary of the existing designated CEZ Boundary and to revise the name of the boundary to Spokane's Community Empowerment Zone Boundary; and

WHEREAS, on April 22, 2019, the City Council approved Resolution No. 2019-0030 expressing the intent of the City Council to adopt the City's Community Empowerment Zone Strategic Plan and to designate a community empowerment zone boundary, and to hold a public hearing on April 29, 2019 to take public testimony and to consider the amended plan and designation of the amended boundary; and

WHEREAS, the City Council now intends to hold the second required public hearing on July 22, 2019, to take public testimony to amend the plan and designation of the amended boundary and appoint the Zone Administrator; Now, Therefore,

The City of Spokane does ordain:

Section 1. That there is adopted a new chapter 8.20 to title 8 of the Spokane Municipal Code to read as follows:

CHAPTER 8.20 COMMUNITY EMPOWERMENT ZONE

8.20.010 Community Empowerment Zone

- A. The City of Spokane Community Empowerment Zone Strategic Plan, attached as Appendix A, is adopted by the City Council.
- B The Spokane Community Empowerment Zone Boundary Map is adopted by the City Council. See Community Empowerment Zone Boundary Map 8.20.010- M1.
- C. Pursuant to RCW 43.31.070, the City of Spokane Director of Planning is designated as the City's Community Empowerment Zone Administrator for the areas of the City designated as a community empowerment zone.

Passed by City Council July 22, 2019 Delivered to Mayor July 24, 2019

ORDINANCE NO. C35799

An ordinance amending Ordinance No. C35703, passed by the City Council December 10, 2018, and entitled, "An ordinance adopting the Annual Budget of the City of Spokane for 2019, making appropriations to the various funds, departments, and programs of the City of Spokane government for the fiscal year ending December 31, 2019, and providing it shall take effect immediately upon passage", and declaring an emergency.

WHEREAS, subsequent to the adoption of the 2019 budget Ordinance No. C35703, as above entitled, and which passed the City Council December 10, 2018, it is necessary to make changes in the appropriations of the Human Services Grants Fund, which changes could not have been anticipated or known at the time of making such budget ordinance; and

WHEREAS, this ordinance has been on file in the City Clerk's Office for five days; - Now, Therefore,

The City of Spokane does ordain:

Section 1. That in the budget of the Human Services Grants Fund, and the budget annexed thereto with reference to the Human Services Grants Fund, the following changes be made:
