#### MINUTES OF SPOKANE CITY COUNCIL

#### Monday, August 12, 2019

#### **BRIEFING SESSION**

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Briefing Center in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

#### **Roll Call**

On roll call, Council President Stuckart, Council Members Burke, Fagan, Kinnear, Mumm, and Stratton were present. Council Member Beggs was absent.

City Attorney Mike Ormsby, City Council Policy Advisor Brian McClatchey, and City Clerk Terri Pfister were present on the dais.

#### MAYORAL PROCLAMATION

August 15-20, 2019 Nick Mamer Days – The 90<sup>th</sup> Anniversary of the Spokane Sun-God

Council Member Fagan read the proclamation and presented it to Colonel Dawn Hilderbrand and J.B. Rivard. Nicholas "Nick" Mamer, a citizen of the City of Spokane, having faithfully served the people of the United States in World War I by serving in the U.S. Army Air Service and emerging as second lieutenant reserve military aviator and pursuit pilot, planned the flight of the Spokane Sun-God with the wholehearted support of Spokane citizens and a forward thinking committee of business leaders headed by Victor Dessert. Nick Mamer took off from Felts Field with his selected co-pilot Art Walker August 15, 1929, guided the Spokane Sun-God over dangerous mountains through horrendous electrical storms, and, although low on gas, refueled at night and even by five-gallon creamery cans to fly nonstop from Spokane to San Francisco, from San Francisco to New York, and from New York back to Spokane proving that aerial refueling permits flying anywhere on earth without landing. Following this flight, the dauntless Nick Mamer continued to bring flying records and selfless service to the region. He flew as lead pilot with Northwest Airlines until his untimely death at age 39 caused by a malfunction of his airliner on January 10, 1938, which convinced grateful citizens to erect a clock tower memorial at Felts Field to honor his memory and serve as a model of unity and purpose and belief that became an inspiration for generations that followed.

#### COUNCIL SALUTATION

#### Veterans for Peace

Council Member Burke read the Council Salutation and presented it to representatives of the event. Veterans for Peace with veterans and associate members in every U.S. State, Mexico, Europe, and Asia is holding its 2019 National Convention in Spokane August 15-18 with the theme "Sacred Land, Sacred Lives - Peace Knows No Borders." Veterans for Peace hold permanent NGO status at the United Nations and is the first military veteran organization invited to be a member of the international Peace Bureau and works to prevent the spread of violence and militarism and transform foreign and U.S. policy to a diplomatic focus and assist national leaders in formation of a long-term vision of peace and justice. Spokane Veterans for Peace, Chapter 35, has been a resource in this community since 1989, carrying forward Veterans for Peace principles and programs, supporting all efforts to educate the public concerning the true cost of war and alternatives to armed conflict that provide justice and safety for all. The Council Salutation salutes Veterans for Peace and encourages citizens of Spokane to recognize the value of peacemakers that Spokane Veterans for Peace contributes to our community and welcomes the delegates and business visitors to the 2019 Veterans for Peace National Convention.

Jennifer Bates commented on her union's yearly picnic at Mission Park and lack of picnic tables, benches, and open restrooms.

Sam Lewis remarked on homelessness.

**Jude Cormier** stated she is concerned about an issue that impacts many people with and without disabilities. She also remarked on lack of curb cuts to make crossing the street possible in a wheelchair or scooter. She remarked on the work on Thor and Freya and waiting until 2022 to have curb cuts put in and pleaded with Council to get this work done quickly.

**Patrick Divine** remarked on yesterday's vigil for victims of gun violence. He stated it's time we move on smart gun reform.

# Ordinances

#### ORDINANCE NO. C35797

An ordinance relating to multiple family housing property tax exemption; amending SMC section 8.15.030; and declaring an emergency.

WHEREAS, in Spokane, 47.7% of Spokane renters are cost-burdened, meaning that they pay more than thirty percent of their income on housing; and

WHEREAS, also, 22.1% of Spokane's renters are severely cost-burdened, meaning that they spend fifty percent or more of their income on housing; and

WHEREAS, according to the Washington State Department of Commerce ("Commerce"), a main driver of the recent increase in homelessness is rental increases caused by the fact that the supply of rental housing is simply not keeping pace with demand; and

WHEREAS, in the recent 2019 Annual Point-in-Time Count of homeless people in Spokane County, a lack of affordable housing is the one of the top five cited reasons for homelessness; and

WHEREAS, the City of Spokane Comprehensive Plan policy H 1.9 is to "encourage mixed income developments throughout the city" because "mixed income housing provides socio-economic diversity that enhances community stability and ensure that low-income households are not isolated in concentrations of poverty"; and

**WHEREAS**, the City of Spokane Comprehensive Plan policy H 1.12 is to "support the development of affordable housing development funding sources"; and

WHEREAS, the City of Spokane recognizes the urgent need to increase investments in the production, preservation, and ongoing operation and maintenance of affordable housing and permanent supportive housing; and

**WHEREAS**, the current lack of affordable housing is jeopardizing the public peace, health, and safety and presents an urgent and emergency condition which justifies the passage of this ordinance as an emergency ordinance pursuant to Section 19 of the Spokane City Charter.

The City of Spokane does ordain:

Section 1. That SMC section 8.15.030 is amended to read as follows:

#### 8.15.030 Residential Targeted Areas – Criteria – Designation

- A. Following notice and public hearing as prescribed in RCW 84.14.040, the council may designate one or more residential targeted areas, upon a finding by the council in its sole discretion that the residential targeted area meets the following criteria:
  - 1. The residential targeted area is within an urban center.
  - 2. The residential targeted area lacks sufficient available, desirable, and convenient residential housing, including affordable housing, to meet the needs of the public who would be likely to live in the urban center if affordable, desirable, attractive, and livable residences were available; and
  - 3. Providing additional housing opportunity, including affordable housing, in the residential targeted area will assist in achieving one or more of the following purposes:
    - a. Encourage increased residential opportunities within the City, including mixed-income and affordable housing opportunities; or
    - b. Stimulate the construction of new multifamily housing; or
    - c. Encourage the rehabilitation of existing vacant and underutilized buildings for multifamily housing.
- B. In designating a residential targeted area, the council may also consider other factors, including whether:
  - 1. additional housing, including affordable housing units, in the residential targeted area will attract and maintain an increase in the number of permanent residents;
  - 2. an increased permanent residential population in the residential targeted area will help to achieve the planning goals mandated by the Growth Management Act under chapter 36.70A RCW, as implemented through the City's current and future comprehensive plans;
  - 3. encouraging additional housing in the residential targeted area is consistent with public transportation plans; or
  - 4. additional housing may contribute to revitalization of a distressed neighborhood or area within the City.
- C. At any time the council may, by ordinance, in its sole discretion, amend or rescind the designation of a residential targeted area pursuant to the same procedural requirements as set forth in this chapter for original designation.
- D. The following <u>area((-areas)</u>), as shown in Attachment A, <u>is</u> ((<del>are\_</del>))designated as <u>a</u>residential targeted <u>area</u> ((<del>areas</del>))under this chapter:
  - 1. <u>Spokane's MFTE</u>
  - ((<del>1. Downtown</del>
  - 2. University District
  - 3. South University District
  - 4. Kendall Yards
  - 5. Monroe Corridor
  - 6. Market Corridor
  - 7. Division Corridor
  - 8. Hamilton/Nevada Corridor
  - 9. East Sprague Targeted Investment Pilot
  - 10. Lower South Hill))
- E. If a part of any legal lot is within a designated residential targeted area with zoning allowing for construction of multifamily housing, <u>Centers and Corridors Zones: CC1, CC2, CC3 overlay, and CC4, Residential Zones: RMF, RHD and Commercial Zones: DTG, DTU, DTS, DTC, CA1, CA2, CA3, CA4, O, OR, NR, NMU, CB, GC and where multi-family housing is allowed in LI as shown in Attachment A, then the entire lot shall be deemed to lie within such residential targeted area. The <u>area</u> ((areas-))designated as <u>a</u> residential targeted <u>area</u> ((areas-))is ((are-))bound by the streets described in Attachment A. Property located outside of, but adjacent to, the described <u>area</u> ((areas-))is not designated as <u>a</u> residential targeted <u>area</u>().</u>

Section 2. Pursuant to section 19 of the City Charter, this ordinance shall be effective immediately upon passage.
