### Monday, December 9, 2019

### **BRIEFING SESSION**

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Briefing Center in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

### Roll Call

On roll call, Council President Pro Tem Beggs (Chair) and Council President Stuckart and Council Members Burke, Fagan, Kinnear, Mumm, and Stratton were present.

City Attorney Mike Ormsby, City Council Policy Advisor Brian McClatchey, and Acting City Clerk Laurie Farnsworth were also present on the dais.

Council President Pro Tem Beggs (Chair) and Council President Stuckart and Council Members Burke, Fagan, Kinnear, Mumm, and Stratton were present.

City Council Policy Advisor Brian McClatchey and Acting City Clerk Laurie Farnsworth was also present on the dais.

### Poetry at the Podium

Kelly Warner, who resides in the Emmerson-Garfield Neighborhood, presented a poem called "Release."

There were no Mayoral Proclamations.

There was no Administrative Report.

There were no Council Committee Reports.

# **REVIEW OF OPEN FORUM RULES**

Council President Pro Tem Beggs reviewed the rules for Open Forum.

### **OPEN FORUM**

**Terri Anderson** remarked on the process of how things get put on and taken off agendas and what happens with the process and how fair that is especially for those that are invisible in Spokane and basically don't have the same access as others do.

**Deb Abrahamson** remarked on the process also and stated the decision to defer the ordinance (establishing a local residential tenancy code) to March was heartless because we have so many homelessness people.

**Steve Schneider** state he is an attorney that represents mostly small landlords that have one or two units. He spoke regarding the costs of evictions and effect on small landlords.

**Candy Turner** stated she represents Summit Christian Academy and recognized the students accompany her in the audience. She stated many of her students have parents that have come from the former Soviet Union. She remarked on the goal of taking the students to Washington, D.C. and questioned whether there is something Summit Christian Academy could do and the City could pay for so that the Academy could earn the funds to go.

**Eric Besset** thanked the Council for listening to citizens and appreciates the opportunity to extend the conversation regarding the residential tenancy code.

Laura Renz remarked on the abuses of service dog laws.

Lainie Woolway also spoke about the abuses of service dog laws.

John Alder spoke regarding the need for affordable senior housing.

**Joshua Scowden** thanked Council for the deferral to March (of the tenancy code ordinance) and spoke about his experiences and doesn't want his ability to help people to be taken away.

Jeremy Logan spoke about the lack of tenant protections and objected to the deferral to March.

**Will Neville** stated he is with the Spokane Democrats Socialists of America and that he is here today to show solidarity for the all the tenants that live in Spokane, Spokane Valley, and all throughout the United States that have been affected on this ongoing housing crises.

**Dave Schmitt** remarked on City Administration and City elected officials considering human beings as a zero sum. He stated the City needs someone who will be able to interdict on behalf of the citizens, like the Ombudsman person does for the Police Department. He also remarked on economic issues.

# Special Budget Ordinance C35859 and Resolution 2019-0114

Council President Pro Tem Beggs provided and overview of Special Budget Ordinance C35859. Council Member Fagan requested Resolution 2019-0114 be taken with Special Budget Ordinance C35859. Subsequent to public testimony from one individual, and Council commentary, the following action was taken:

Upon Unanimous Roll Call Vote, the City Council passed/adopted the following:

 Passed Special Budget Ordinance C35850 amending Ordinance No. C35703 passed by the City Council December 10, 2018, and entitled, "An Ordinance adopting the Annual Budget of the City of Spokane for 2019, making appropriations to the various funds, departments and programs of the City of Spokane government for the fiscal year ending December 31, 2019, and providing it shall take effect immediately upon passage," and declaring an emergency and appropriating funds in:

Property Acquisition FundFROM:Loan Proceeds, \$900,000;TO:Capital Expenditures, \$900,000.

(This action allows budgeting for the Property Acquisition Fund to interfund loan the Parks Department to upgrade for construction of the Shane's Inspiration Inclusive Playground Project.)

• Adopted Resolution 2019-0114 of the City of Spokane, Washington, providing for the issuance and sale of a taxable Limited Tax General Obligation Bond in the aggregate principal amount of not to exceed \$900,000 to secure an interfund loan from the Spokane Investment Pool to the Asset Management Fund to finance a portion of the costs of the acquisition, construction and installation of the Shane's Inspiration Inclusive Playground Project; fixing the date, form, maturity, interest rate, terms and covenants of the bond; establishing the provisions for repayment of the interfund loan established thereby; authorizing the sale and delivery of the bond to the City, and providing for other matters properly relating thereto.

**Upon Unanimous Roll Call Vote,** the City Council **passed Final Reading Ordinance C35855** approving and confirming the 2020 assessments and assessment roll for the East Sprague Parking and Business Improvement Area, prepared under Ordinance C35377 as codified and amended in Chapter 4.31C SMC.

### Hearing on Final Reading Ordinance C35856

The City Council held a hearing on the 2020 Assessments and Assessment Roll for the Downtown Spokane Parking and Business Improvement Area. ### Hearings on Comprehensive Plan Amendment Ordinances C35838 through C35842

### Final Reading Ordinance C35838

**Upon 6-0 Roll Call Vote (Council Member Mumm absent),** the City Council **passed Final Reading Ordinance C35838** relating to application Planning File Z18-882COMP amending map LU 1, Land Use Plan Map, of the City's Comprehensive Plan from "Residential 15-30" to "General Commercial" for approximately 0.12 acres described as lot 15, block 57 of the Lidgerwood Addition and amending the zoning map from "Residential Multifamily" (RMF) To "General Commercial" (GC-70). (Applicant: H A Tombari LLC) (Plan Commission approved 7 to 0)

### Final Reading Ordinance C35839

**Upon Unanimous Roll Call Vote,** the City Council **passed Final Reading Ordinance C35839** relating to application Planning File Z18-883COMP and amending map LU 1, Land Use Plan Map, of the City's Comprehensive Plan from "Residential 15-30" to "Office" for approximately 0.29 acres described as lots 1 and 2 of the subdivision of lot 5 of GH Morgan's Addition and amending the zoning map from "Residential Multifamily (RMF)" to "Office (O-35)". (Applicant: David Jeter, MPT, COMT, Acceleration Physical Therapy/Carl Upton and Patricia Upton aka Patricia Reilly) (Plan Commission approved 6 to 1)

### Final Reading Ordinance C35840

**Upon Unanimous Roll Call Vote,** the City Council **passed Final Reading Ordinance C35840** relating to application Planning File Z18-884COMP and amending map LU 1, Land Use Plan Map, of the City's Comprehensive Plan from "Residential 4-10" to "Office" for approximately 0.85 acres described as lots 10 through 15 of Block 36, Monroe Park Addition and amending the zoning map from "Residential Single Family (RSF)" to "Office (O-35)". (Applicant: Washington State Department of Ecology) (Plan Commission approved 7 to 0)

### Final Reading Ordinance C35841

**Upon Unanimous Roll Call Vote,** the City Council **passed Final Reading Ordinance C35841** relating to application Z18-958COMP, amending Chapter 3 of the City's Comprehensive Plan to include a new policy encouraging transit supported development in the vicinity of high-performance transit stops in the City of Spokane. (Applicant: Council President Ben Stuckart, on behalf of the Spokane City Council) (Plan Commission approved 7 to 0)

### Final Reading Ordinance C35842

**Upon Unanimous Roll Call Vote,** the City Council **passed Final Reading Ordinance C35842** relating to application Z19-002COMP, amending policy LU 1.8, general commercial uses, in Chapter 3 of the Comprehensive Plan as it relates to directing new commercial growth to centers and corridors. (Applicant: Council Member Candace Mumm, on behalf of the Spokane City Council) (Plan Commission approved 7 to 0)

# SECOND OPEN FORUM

**Cherie Barnett** commented on the law of unintended consequences, broken faith with Judeo-Christian foundations, Planned Parenthood, and provided other remarks.

Eugen Knowles commented on housing crisis and homelessness.

Steven Wareham shared his experience renting out a home and remarked on low income housing.

**Mariah McKay** stated she is here in her capacity as a landlord and community manager for Our Natural Homes Rental Company. She stated she is disappointed in the deferral of Ordinances C35860 and C35861 and that it's past time to take decisive and needed action to protect the most vulnerable in the community. She shared background on Our Natural Homes' unique rental model and concerns about the housing crises.

### ADJOURNMENT

There being no further business to come before the City Council, the Regular Legislative Session of the Spokane City Council adjourned at 8:14 p.m.

# **General Notices**

# RESOLUTION 2019-05

BE IT RESOLVED BY THE CIVIL SERVICE COMMISSION that the following Civil Service Rule Change was adopted on December 17, 2019.

# RULE CHANGE:

### Rule V Section 10 Probation:

- (a) All open entry appointments shall have a probationary period not to exceed one year from the date of appointment to the classified position.
- (b) When injury or other adverse circumstance causes an extended absence which prevents the full and fair evaluation of an employee during a probationary period, the employing department head may request extension of the probationary period. Extensions shall not to exceed the length of the extended absence. Extensions must be requested within 10 working days of the conclusion of the absence or the scheduled end of the probationary period, whichever comes first. The Chief Examiner may approve or deny the request If approved, all applicable personnel records shall be annotated and adjusted accordingly. Failure to make a request within these provisions shall automatically make the appointment permanent.
- (c) The appointing officer shall remove a probationer found to be unsatisfactory at any time during the probationary period, and shall notify the Commission of such action on the form provided. If probation is by appointment from an open eligible list, the probationer shall be dropped from the service except as provide for transfers in Rule VII,

Section 2 (a); OR, where a classified position is vacated to accept the open entry appointment, the probationer shall be placed on the laid off list for the previously held classification.

# **Rule VI Section 14 Probation:**

- (a) All promotional appointments shall have a probationary period not to exceed six months from the date of appointment to the classified position.
- (b) When injury or other adverse circumstance causes an extended absence which prevents the full and fair evaluation of an employee during a probationary period, the employing department head may request extension of the probationary period. Extensions shall not to exceed the length of the extended absence. Extensions must be requested within 10 working days of the conclusion of the absence or the scheduled end of the probationary period, whichever comes first. The Chief Examiner may approve or deny the request. If approved, all applicable personnel records shall be annotated and adjusted accordingly. Failure to make a request within these provisions shall automatically make the appointment permanent.
- (c) The appointing officer shall remove a probationer found to be unsatisfactory at any time during the probationary period. The probationer shall be returned to the former classification; provided, the employee shall not disp lace any other employee with greater classification seniority. Should no position exist, the employee shall then be given the option of appointment to a position in the next lower classification or placement on the laid off list.

# **ORDINANCE NO. C35836**

An ordinance granting a non-exclusive franchise to use the public right of way to provide noncable telecommunication service to the public to Noel Communications, Inc., subject to certain conditions and duties as further provided (in the ordinance).

**WHEREAS,** the City of Spokane ("<u>Grantor</u>") granted to Noel Communications, Inc., a Washington corporation ("<u>Grantee</u>"), a franchise as set forth in Ordinance No. C35118, effective September 24, 2014, to use the public right of way for the purpose of providing telecommunications services to the public in the City of Spokane (the "<u>Franchise</u>");

WHEREAS, Grantee plans to enter into an agreement (the "<u>Purchase Agreement</u>") to sell certain of its assets and related business operations, including the Franchise (collectively, the "<u>Business</u>"), to Wholesail Networks LLC, a Washington limited liability company ("<u>Assignee</u>");

WHEREAS, Grantee submitted a letter to Grantor on or about August 13, 2019, requesting Grantor's consent to the Assignment of the Franchise from Grantee to Assignee (the "Consent Request");

WHEREAS, in connection with the consummation of the sale of the Business to Assignee, which is anticipated to take place on or around August 31, 2019 (the "<u>Closing</u>"), Grantee desires to assign its rights and delegate its obligations under the Franchise to Assignee (the "<u>Assignment</u>");

**WHEREAS**, Grantor has conducted a review of the legal, technical and financial qualifications of Assignee to hold the Franchise and own and operate the telecommunications network authorized by the Franchise;

WHEREAS, all written comments and staff reports have been received, and made a part of the record; and

**WHEREAS**, based on the foregoing, Grantor has concluded Assignee has established it meets the legal, technical and financial criteria to hold the Franchise and to operate the telecommunications network.

### NOW, THEREFORE, THE CITY OF SPOKANE DOES ORDAIN:

**Section 1.** Grantor hereby approves the Consent Request and consents to the transactions contemplated by the Purchase Agreement and the Assignment.

**Section 2.** Grantor confirms that: (a) the Franchise was duly issued to Grantee, is valid and enforceable in accordance with its terms, and is in full force and effect; (b) other than as set forth in this Ordinance, there have been no amendments or modifications to the Franchise; (c) to Grantor's knowledge, there are no defaults under the Franchise, and no event has occurred and is continuing which, with the giving of notice or passage of time, or both, could constitute a default thereunder; and (d) upon the Closing, the duly authorized franchisee under the Franchise will be Assignee.

**Section 3.** Assignee may hereafter, without the need to obtain the prior consent of Grantor, from time to time: (a) assign or transfer its assets, including the Franchise, provided however, that such assignment or transfer is to a parent or subsidiary of Assignee or another entity under direct or indirect control of the parent of Assignee; (b) restructure its debt or change the ownership interests among its equity participants, and/or its affiliates; (c) pledge or grant a security interest in its assets, including but not limited to the Franchise, or of the ownership interests in Assignee, to any secured lender(s) for purposes of securing indebtedness.

**Section 4.** The Franchise and this Ordinance were and are made, passed and adopted in accordance with all applicable notice and procedure requirements under all laws applicable to Grantor, and with all applicable notice and procedure requirements, and do not conflict with the laws, ordinances, resolutions and other regulations of Grantor, as presently in effect or as the same were in effect at the time the particular action was taken.

**Section 5.** Grantor's approval of the Consent Request and its consent to the Assignment of the Franchise to Assignee shall be effective from and after its adoption and approval by the Grantor. Assignee shall notify the Grantor in writing upon the date of the Closing.

**Section 6.** Grantor releases Grantee, effective upon the Closing, from all obligations and liabilities (including any guarantee or surety) under the Franchise related to the period on and after the date of the Closing; and Assignee shall be responsible for any obligations and liabilities under the Franchise related to the period on and after the date of the Closing.

### **ORDINANCE NO. C35857**

An ordinance adopting the Annual Budget of the City of Spokane for 2020, making appropriations to the various funds of the City of Spokane government for the fiscal year ending December 31, 2020, declaring a public emergency, and providing it shall take effect immediately upon passage under Section 16(D) of the City Charter as necessary for the immediate support of the public health, safety, and welfare of the citizens of Spokane.

**WHEREAS**, the City of Spokane is a first-class city with a population of less than 300,000 persons and is required, pursuant to RCW 35.33.075 to adopt a final budget prior to the close of the current fiscal year at midnight, December 31, 2019; and

WHEREAS, all appropriations in the final budget must be limited to the total estimated revenues therein including the amount to be raised by all municipal revenue sources and the unencumbered fund balances estimated to be available at the close of the current fiscal year; and

**WHEREAS**, pursuant to RCW 35.33.121 the expenditures as classified and itemized by fund in the final budget adopted by the City Council shall constitute the City of Spokane's appropriations for the fiscal year commencing after midnight, December 31, 2019, subject to later adjustments as provided therein;

### NOW, THEREFORE,

The City of Spokane does ordain:

### Section 1.

- A. That the revenues to be generated by the revenue sources set forth in the final budget are required for the continuation of the existing essential municipal programs and services of the City of Spokane.
- B. That without said essential municipal programs and services, the public health, safety and welfare of the citizens of the City of Spokane would be seriously impaired.
- C. That the following Annual Budget of the City of Spokane for 2020 reflects a continuation of said essential municipal services and programs provided by the City of Spokane for the public health, safety and welfare of the citizens of the City of Spokane as required by the constitution and laws of the State of Washington, the City Charter, ordinances, other legislative enactments and lawful obligations of the City of Spokane.

**Section 2.** That the Annual Budget of the City of Spokane for the fiscal year ending December 31, 2020, as set forth in the document attached hereto and entitled, "2020 Adopted Budget, City of Spokane, Washington," hereinafter referred to as the 2020 Annual Budget, be and the same is, hereby fixed, determined and adopted; and that the amounts set forth in said budget are hereby appropriated for the use of the several funds as specified.

**Section 3.** That the foregoing appropriations are to be paid from the respective funds as specifically indicated in the 2020 Annual Budget and the salaries and wages therein set forth in detail as prescribed by RCW 35.33.051 shall be paid on a biweekly basis, payable every other Friday of such fiscal year.

**Section 4.** That because this ordinance adopts the Annual Budget, as provided by Section 19(A)(3) of the City Charter, and because the Annual Budget is a public emergency ordinance which is necessary for the immediate support of the public health, safety, and welfare of the citizens of the City of Spokane, as provided by Section 16(D) of the City Charter, it shall take effect immediately upon its passage and shall not be subject to Mayoral veto.

### **ORDINANCE C35862**

An ordinance relating to the Salary Review Commission; amending SMC sections 2.05.020, 2.05.030, 2.05.040 and 2.05.050.

The City of Spokane does ordain:

Section 1. The SMC Section 2.05.020 is amended to read as follows:

### 2.05.020 Membership – Term – Removal

A. Membership.

The commission shall consist of five members who are residents and registered voters of the City. Appointment shall be as follows:

- <u>Three Commission members shall have experience in the field of personnel management, or a demonstrated knowledge in the administration of compensation and benefits. Two Commission members shall have experience in finance, business management, or other related fields that demonstrate experience beneficial to the review of total compensation and establishment of salary.</u> ((Two members shall be at-large appointments appointed by the mayor with the city council's approval.))
- All members shall be at-large appointments nominated by the mayor and appointed by the city council. ((Three members shall be appointed by the mayor with city council approval with one member from each of the three city council districts respectively. The individuals submitted for appointment from the council districts shall be recommended by the city council to the mayor for appointment.))
- 3. Applications for positions to the salary review commission shall be reviewed by the City's ethics committee pursuant to SMC 1.04.170 as an advisory opinion for potential conflicts of interest or other conflicts with the ethics code.
- 4. The ethics committee's advisory opinion shall be filed with the mayor's office and with the city council.

### B. Term.

Each member of the commission shall serve a four-year term, and no member shall be appointed to more than two terms regardless of whether the terms are held consecutively.

- 1. More than two years of a four-year term shall count as a whole term.
- 2. Initial appointments shall be as follows:
  - a. Three members shall be appointed for a period of four years; and
  - b. Two members shall be appointed for two years.
- 3. All subsequent appointments or reappointments shall be for a four-year term.
- 4. Appointments may be made to complete an unexpired term in the event of a vacancy.

C. Removal.

Commission members may only be removed during their terms of office by the city council with a recommendation from the mayor for cause of:

- 1. incapacity,
- 2. incompetence,
- 3. neglect of duty,
- 4. malfeasance in office, or
- 5. for a disqualifying change in:
  - a. residence, or
  - b. voter status.
- D. Compensation.

Commission members shall serve without compensation.

- E. Qualifications.
  - ((1. Commission members shall have experience in finance, business management, or personnel management, or other related fields that demonstrate experience beneficial to the review and establishment of salaries for elected officials.))
  - ((2))<u>1</u>. Officers, officials, and employees of the City and their immediate family members shall not be eligible to serve on the commission.
    - a. For the purposes of this section, "immediate family member" shall mean a:
      - i. parent,
      - ii. stepparent,
      - iii. in-law,
      - iv. spouse,
      - v. sibling,
      - vi. stepsibling,
      - vii. child,
      - viii. stepchild, or
      - ix. dependent relative

of the officer, official or employee, whether or not living in the household of the officer, official or employee.

Section 2. That SMC section 2.05.030 is amended to read as follows:

### 2.05.030 Definitions

- A. "Elected officials" means the positions of mayor, council president and all council members.
- B. "Salary" or "salaries", as used in this chapter, means ((any fixed compensation paid periodically for work or services.)) the annual wage paid for work or services to the positions of mayor, council president and all council members as contained in City Pay Plan A09.
  - 1. ((This definition expressly excludes the total cost of any medical or other benefits provided to any elected official, as well as any expenses paid or reimbursed on behalf of an elected official in compliance with the City policies and procedures for expense reimbursements.))

<u>Annual Wage – as applied to the positions of mayor, council president and all council members, "annual wage"</u> or "annual wages" shall mean the specific dollar amount identified in City pay plans A09 and shall exclude the cost of all other benefits provided to the employee.

<u>C.</u> <u>"Total Compensation" shall mean any salary plus any medical, dental, retirement, deferred compensation and all other benefits provided to the elected officials.</u>

Section 3. That SMC section 2.05.040 is amended to read as follows:

### 2.05.040 Duties

A. It is the goal of the commission to base salaries of the mayor, council president and council members on realistic standards so that the elected officials may be paid according to the duties of their offices and so that citizens of the highest quality may be attracted to public service. The commission shall have the duty to review and establish the salary of the mayor, council president and council members. The commission shall study the relationship of ((salaries)) total cost of compensation to the duties of the mayor, council members.

- B. A decision by the commission to change the salary of the mayor, council president or city council members, shall be filed by the commission with the city clerk by May 31<sup>st</sup>, shall be final and shall become effective and incorporated into the city budget without further action of the city council or salary commission.
  - 1. Any change of salary, by the commission shall supersede any ordinance or resolution in effect at the time the salaries are changed but only to the extent of such conflict.
- C. Salary increases established by the commission <u>for the mayor, council president and council members</u> shall be effective on the first pay period of the year following the decision of the commission and shall apply to the mayor, council president and all city council members regardless of their terms of office.
- D. Salary decreases established by the commission shall become effective as to an incumbent mayor, council president or council member at the commencement of their next subsequent terms of office.

Section 4. That SMC section 2.050.050 is amended to read as follows:

### 2.05.050 Operations of Commission

- A. The commission may establish its own rules of procedures consistent with the Spokane Municipal Code and state law, which shall include a meeting schedule.
- B. The commission shall annually elect a chair and vice chair from its members.
- C. All meetings of the commission shall be open to the public.
  - 1. At least one of the meetings shall include a public hearing held prior to the commission issuing a decision regarding the establishment of salaries in order to provide an opportunity for the public and the affected elected officials to address the commission.
- D. The commission shall meet to review the salary schedules of the mayor, council president and council members, during even numbered years and may meet more frequently on their own initiative or by a motion of the city council.
  - 1. Decisions of the commission regarding an increase or decrease in the salary schedule shall be filed by the commission with the city clerk by May 31st.
- E. In determining the salaries for the mayor, council president and council members, the commission shall solicit information regarding the elected officials' duties and responsibilities. <u>The commission shall utilize best-practice</u> <u>methodology for determining the elected official's salary giving consideration to data and other information gathered</u> by the City's Human Resources Department and presented to the commission. The commission shall also consider each year information regarding cost of living adjustments (COLA), including the COLA provided by the City to the Managerial and Professional Association in its collective bargaining agreement. Prior to the commission issuing a salary schedule, the commission may request additional financial information and other relevant data from the appropriate city department.
- F. Three members of the commission shall constitute a quorum and the affirmative vote of three members shall be required to approve a salary schedule for the mayor, council president and council members as well as all other matters of the commission.
- G. The commission shall keep a written record of its proceedings, which shall be a public record in accordance with state law.
  - 1. The commission shall provide written documentation forming the basis for the salary schedule.
- H. The commission shall be assisted in performing its duties by staff <u>members; one budget staff member from the city</u> <u>council office and one staff member from the human resources department</u> assigned by the city administration and the City Council. <u>The staff members will research</u>, review, and provide current data to commission about any proposed salary adjustment and may also make recommendations to the commission based on their research.

### **ORDINANCE NO. C35863**

An ordinance relating to arterial streets; changing Section 12.08.040 of the Spokane Municipal Code.

WHEREAS, the Spokane City Council has adopted an Official Arterial Street Map (Ordinance No. C34255, 2008); and

**WHEREAS**, with the 2011 annexation of the West Plains the City acquired arterial streets from Spokane County (Ordinance No. 34749, 2011) and these streets are not shown on the Official Arterial Street Map; and

WHEREAS, the City Council updated the Planned Arterial Network Map in the Comprehensive Plan (Ordinance No. 35509, 2017); and

**WHEREAS**, there are substantial differences between the Planned Arterial Network Map and the Official Arterial Street Map that should be reconciled; and

WHEREAS, the Street Department would make necessary changes to signing and striping within four months of adoption; and

**WHEREAS,** following the process outline in the City's regulations, the City's Plan Commission has recommended approval of the amendments to the City's Official Arterial Street Map;

NOW THEREFORE, the City of Spokane does ordain:

Section 1. That there is adopted these updates to Title 12 of the Spokane Municipal Code to read as follows:

### Chapter 12.08 Regulation of Traffic

# Section 12.08.040 Official Arterial Street Map

- A. The arterials within the City of Spokane are hereby designated and classified on the Official Arterial Street Map that is maintained by the city engineer. Changes to the Official Arterial Street Map require city council approval.
- B. This section does not preclude arterial streets from being further designated ((and classified)) for ((traffic engineering and)) transportation planning purposes in the Comprehensive Plan.

- A. The following limits are established as local limits, expressed as Maximum Allowable Discharge Limits, No ((user or other person)) <u>Significant Industrial User</u> may discharge wastewater into the POTW in excess of the following concentrations:
  - 1. Arsenic: ((<del>0.41</del>)) <u>0.12</u> mg/L.
  - 2. <u>Benzene: <0.5 mg/L</u> ((toluene, ethylbenzene, and xylene (BTEX): A sum of these four constituents' analytical results not to exceed 1.4 mg/L)).
  - 3. Cadmium: ((<del>0.11</del>)) <u>0.093</u> mg/L.
  - 4. Total Chromium: <u><</u>5.0 mg/L.
  - 5. Copper: ((<del>1.9</del>)) <u>0.74</u> mg/L.

- 6. Cyanide: ((<del>1.9</del>)) <u>1.01</u> mg/L.
- 7. Fats, oils, and, grease: See SMC 13.03A.0201(B)(19).
- 8. Lead: 0.32 mg/L.
- 9. Mercury: ((0.05)) 0.012 mg/L.
- 10. Nickel: ((3.98)) 1.74 mg/L.
- ((11. Non-polar material (or total petroleum hydrocarbons): Not to exceed 100 mg/L.))
- ((<del>12</del>))<u>11</u>. Silver: ((<del>1.7</del>))<u>0.46</u> mg/L.
- ((<del>13</del>))12. Zinc: ((5.6)) <u>2.59</u> mg/L.
- ((14))13. The pH limit set in SMC 13.03A.0201(B)(2) may also be enforced as a local limit.
- ((<del>15</del>))14. Molybdenum: ((<del>1.5</del>)) <u>0.66</u> mg/L.
- ((<del>16</del>))15. Selenium: ((<del>1.0</del>)) <u>0.40</u> mg/L.
- B. Users that discharge wastewater into any sewer that conveys wastewater to Spokane County Regional Water Reclamation Facility must comply with the limits set forth in Spokane County Code Chapter 8.03A 0204.
- C. All concentrations for metallic substances are for "total" metal unless indicated otherwise. The superintendent may impose mass limitations in addition to or in place of the concentration-based limitations shown in subsection (A) of this section. Where a user is subject to a categorical pretreatment standard and a local limit for a given pollutant, the more stringent limit applies as the applicable pretreatment standard.
- D. Limits may be established for all users, groups, or specific users. They may be designed to ameliorate temporary or permanent discharge characteristics, or to accommodate any new or special temporary or permanent condition of the POTW, its effluent receiving water, or other environmental problem. The superintendent may set limits as instantaneous maximums or for other durations (e.g., daily maximum or monthly average limits) where deemed proper.
- E. Whenever determined appropriate, the superintendent may develop best management practices (BMPs) for general application, in individual discharge permits or general discharge permits, to implement local limits and the requirements of article II of this chapter and require documentation of compliance. Failure to follow such requirements is a violation of this chapter.
