MINUTES OF SPOKANE CITY COUNCIL

Monday, August 3, 2020

BRIEFING SESSION

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:32 p.m. in the Council Chambers in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

The regularly scheduled Spokane City Council 3:30 p.m. Briefing/Administrative Sessions and the 6:00 p.m. Legislative Session were held virtually and streamed live online and aired on City Cable 5. Pursuant to Governor Jay Inslee's Eighth Updated Proclamation 20-28.8, dated July 31, 2020, all public meetings subject to the Open Public Meetings Act, Chapter 42.30 RCW, are to be held remotely and the in-person attendance requirement in RCW 42.30.030 has been suspended until at least through September 1, 2020. More information on the process: The Study was presented at Plan Commission workshops in February and June 24, 2020, Plan Commission hearing July 8, 2020, where it was recommended to go forward to City Council. The Study and resolution were presented to the Urban Development Committee on March 9 and July 13, 2020. Launched in early fall 2019, Grand Boulevard Transportation and Land Use Study is funded primarily through Traffic Calming dollars identified by Comstock Neighborhood Council in 2016, with land use analysis funding sponsored by City Council in 2017. Comstock, Manito-Cannon Hill, and Rockwood Neighborhood Council boundaries intersect at 29th Avenue and Grand Blvd. and the neighborhood councils are actively engaged in the project.

A series of focus interviews with area stakeholders and two community open houses were held, along with an online survey that received 475 responses. The Grand Boulevard email distribution list has approximately 145 members. Comments from participants have been incorporated into the final draft coming to the City Council Plan Commission. Citizen comment regarding safety and traffic calming for pedestrians, bicyclists, and users of all ages and abilities was the prime driver of alternatives that were recommended.

WHEREAS, the goal for many years has been for the entirety of SMC Title 11 to be transferred to SMC Title 17; and

WHEREAS, Planning & Development Services has identified the remaining sections of SMC chapter 11.19 as obsolete or, substantive standards placed in other chapters of SMC, or are duplicative of standards that are now in place in Title 17; and

WHEREAS, the continued existence of these sections of chapter 11.19 hinders the public in preparing applications for development by relying on code citations appearing to be in force; and

WHEREAS, the processing of applications is anticipated to be more efficient by eliminating the time spent on resubmittal after explanation of the current SMC Title 17 affecting the applicant, improving customer service; and

WHEREAS, the repeal of SMC chapter 11.19 sections does not necessitate Plan Commission review or recommendation as there is no amendment to SMC Title 17 affecting land use action; and

WHEREAS, this repeal action is categorically exempt from the State Environmental Policy Act (SEPA) as stated in Washington Administrative Code (WAC) Procedural Actions 197-11-800(19)(a)(b); and

WHEREAS, a Notice of Intent to Repeal SMC chapter 11.19 sections was published in the City Gazette July 2020 and the Spokesman-Review July 2020; and

WHEREAS, the City Council adopts the recitals set forth herein as its findings and conclusions in support of its repeal of these sections of chapter 11.19; --
